The project would include three meeting rooms, staff offices, a kitchen, rest rooms, and utility and circulation space. Most of the second level would be devoted to an outdoor terrace that would include seating areas, landscaping, and a single-hoop basketball court. A new elevator would connect the building's two levels. The project would provide a total of about 4,400 square feet of interior space, while the second-story outdoor terrace would be nearly 2,050 square feet in size.
