Request for CDLAC Certification of Compliance for Tax-Exempt Bond Projects (plus, Serious Incident Protocol, information about housing counseling services for annual income recertifications and marketing reminder)

Annual Monitoring Report EZ ("AMR-EZ"): The Mayor's Office of Housing and Community Development (MOHCD) is pleased to announce the availability of the Annual Monitoring Report EZ ("AMR-EZ") form for Reporting Year 2024 (RY2024). The AMR-EZ is the abridged form of the Annual Monitoring Report that must be completed for certain projects that have been financed by or through the Mayor's Office of Housing and Community Development (MOHCD) or the former San Francisco Redevelopment Agency or its successor, the Office of Community Investment and Infrastructure. The form is now available to be downloaded from the Compliance Monitoring page of the MOHCD web site.

<u>CDLAC Certification of Compliance</u>: This notice also serves as a request for the Certification of Compliance, the certification form that must be completed and provided annually to MOHCD in accordance with the requirements of the California Debt Limit Allocation Committee (CDLAC). See below for more information.

<u>Applicability</u>: To determine the projects for which you must provide an AMR-EZ and/or a Certification of Compliance, please see this list.

<u>Deadline</u>: The AMR-EZ and the Certification of Compliance are due by the close of business on February 3, 2025. Please refer to MOHCD's policy on "<u>Deadlines for Annual Monitoring Reports</u>" and requests for extensions, which is posted adjacent to the AMR-EZ reporting form on our web site.

# AMR-EZ Completion and Submission Instructions

The Annual Monitoring Report (AMR-EZ) consists of the following two parts:

I. <u>AMR-EZ RY2024 - project name.xlsx</u> — This is a Microsoft Excel spreadsheet that is comprised of the following worksheets:

Completeness Tracker

Provide all relevant information that is requested in worksheets A-G, as applicable. Based on certain data inputs on worksheet A, the reporting form will indicate whether or not worksheets B and E must be completed and whether or not insurance documentation must be submitted. Use the Instructions to help you complete each worksheet, and use the Completeness Tracker to help you to determine 1) which worksheets to complete, based on certain data inputs on worksheet A, 2) when each required worksheet is complete and 3) whether or not you must submit documentation of insurance with the report.

Use Worksheet G (Narrative), Question #1, to explain any data provided on other worksheets that may be unclear or better understood with additional information. Also, use Question #2 to describe any affirmative marketing that you conducted for the project during the reporting period.

Submit this report as an Excel file only; do not convert it to pdf or another file type. Do not overwrite any validations for any of the cells, alter any formulas or add or delete any rows or columns. Changing the format of the AMR-EZ without MOHCD's prior approval will render the report invalid and unacceptable. If you need to revise the form in order to successfully complete the report, submit a request to moh.amr@sfgov.org.

II. <u>Waiting List</u> – Submit a copy of the project's waiting list that is current as of the date of submittal. The waiting list must include the following information for each person or household who has applied to live at the project and is still waiting to be considered for an available unit:

- name of head-of-household
- contact information
- date of application,
- number of people in the household,
- stated household income and
- desired unit size.

This requirement is not applicable to transitional housing projects, residential treatment programs, shelters, group homes or permanent supportive housing for homeless people that is leased through a closed referral system.

Completed AMR-EZs must be submitted electronically, via <u>one email</u> <u>message per project</u>, to <u>moh.amr@sfgov.org</u> by February 3, 2025.

# **AMR-EZ Training - On-Demand Videos**

To facilitate completion of the AMR-EZ by project sponsors, MOHCD has created training videos that provide step-by-step instructions on how to complete the Excel reporting form and how to submit the report overall. There are ten video modules that vary in length from two to 30 minutes and may be viewed on-demand from the Compliance Monitoring page of the MOHCD web site. We strongly encourage all persons who are involved in preparing the AMR to watch the videos. # **CDLAC Certification of Compliance**

Every year, the City and County of San Francisco, as issuer of tax-exempt bonds for the construction or rehabilitation of numerous affordable housing projects in San Francisco, is charged with gathering Certifications of Compliance in accordance with the requirements of the California Debt Limit Allocation Committee (CDLAC). The owners of projects that have been financed with tax-exempt bonds issued by the City or the former San Francisco Redevelopment Agency are responsible for completing these certifications for their respective projects and submitting them to MOHCD.

This notice requests that you complete the Certification of Compliance form for each of the tax-exempt bond projects owned or controlled by your organization. For

this purpose, please use the respective certification forms that are attached to the CDLAC resolutions that approved the City's applications to issue the bonds for your projects. Copies of the resolutions should be available in your organization's records.

To determine the projects for which you must provide a Certification of Compliance, please see this list.

By the close of business on February 3, 2025, please do the following for each of your tax-exempt bond projects:

- Print the certification form on the letterhead of the ownership entity of the project or the parent corporation,
- Have an authorized representative of the project owner sign it,
- Scan the document and email a copy of it, along with the AMR-EZ, to <u>moh.amr@sfgov.org</u>

#### Serious Incident Protocol

To ensure that the City is kept informed of serious incidents that occur at projects financed by this office, owners and managers of MOHCD-supported affordable housing must follow the <u>Serious Incident Protocol</u> for reporting serious, negative events such as accidents, criminal activity or equipment failure. Reports of such incidents should be filed as soon as possible after emergency procedures have been followed and the situation has been stabilized. The reports must be in writing and should be filed with the MOHCD asset manager who is assigned to the project.

# Marketing Procedure for Available Units and Waiting List Openings

Before advertising the availability of units for lease in a project or the opening of the waiting list, owners and property managers must notify MOHCD of this action by completing a Marketing Plan Template and submitting it to the assigned staff person on MOHCD's asset management and compliance monitoring team. The template is available on the <a href="Compliance Monitoring">Compliance Monitoring</a> page of our web site, under "Marketing Requirements for MOHCD-Financed Multifamily Rental Projects." Owners and managers of projects funded under the Small Sites Program or the Housing Preservation Program should follow the procedures in the <a href="Marketing and Leasing Manual">Marketing and Leasing Manual</a> for those programs and use the related forms.

Once the marketing plan is approved, MOHCD will post information about the available units or opening of the waiting list on <u>DAHLIA</u> – the City's internet portal where members of the public may get information and apply for affordable housing.
