



ALLOWABLE ANNUAL RENT INCREASES

A landlord may increase the tenant's base rent once every 12 months by the amount of the allowable annual rent increase without filing a petition at the Rent Board. Effective March 1, 2025 through February 28, 2026, the allowable annual increase amount is 1.4%. This amount is based on 60% of the increase in the Consumer Price Index for All Urban Consumers in the Bay Area, which was 2.4% as posted in November 2024 by the Bureau of Labor Statistics. To calculate the dollar amount of the 1.4% annual rent increase, multiply the tenant's base rent by .014. For example, if the tenant's base rent is \$2,000.00, the annual increase would be calculated as follows: \$2,000.00 x .014 = \$28.00. The tenant's new base rent would be \$2,028.00 (\$2,000.00 + \$28.00).
