

**ALLOWABLE ANNUAL RENT INCREASES**

A landlord may increase the tenant's base rent once every 12 months by the amount of the allowable annual rent increase without filing a petition at the Rent Board. **Effective March 1, 2026 through February 28, 2027, the allowable annual increase amount is 1.6%.**

To calculate the dollar amount of the 1.6% annual rent increase, multiply the tenant's base rent by .016. For example, if the tenant's base rent is \$2,000.00, the annual increase would be calculated as follows: $\$2,000.00 \times .016 = \32.00 . The tenant's new base rent would be \$2,032.00 ($\$2,000.00 + \32.00).
