# **Other Significant Issues:**

Natural Languages will provide interpretation in the seven core languages (Arabic, Chinese, Korean, Russian, Spanish, Tagalog and Vietnamese) for as needed onsite interpreting to back-fill for civil service staff on extended leave, and other unanticipated absences at Zuckerberg San Francisco General Hospital and at other department facilities. Natural Languages will also be used to support COVID emergency responses.

Natural Languages, LLC was selected under RFP 30-2020 to provide as-needed onsite interpreter services. RFP 30-2030 established two contracts to the two highest ranking responsive responsible Proposers. The highest ranked Proposer was deemed "Primary," and the second highest ranked Proposer was deemed "Backup". Natural Languages, LLC ranked the highest and was deemed the Primary. Interlingva, Inc, was deemed the "Backup" proposer. The Department is also in negotiations with the backup proposer and will present the contract to the Commission if negotiations are successful.
