## 3. Approval of Minutes from February 26, 2021 (Action Item)

The minutes of February 26, 2021 were approved unanimously and without changes.

### 4. Chair Update

Taraneh Moayed gave a summary of the changes regarding the new ordinance amendment which was introduced by Supervisor Peskin.

# 5. Review and Approval of Surveillance Technology Policy: Security Camera (Action Item)

Discussion began with departments using the citywide policy standard.

### Department of Public Health

Marc Upchurch presented the Department of Public Health's Security Camera Policy. The department adopted the standard security camera template and provided department-specific answers.

### Location of the cameras

- o Cameras are located at the hospital centers and in areas where the cameras are intended on protecting the medical professionals and to secure the location, but generally are located in private areas of the hospitals where there is a checkpoint or security.
- o 381 cameras are subject to this policy.

### Public noticing

 Signs are posted, but there are no other active communications about surveillance cameras.

#### Crime statistics

- An internal incident log is maintained.
- o They share any data related to a criminal act with law enforcement.
- They have the ability to "diffuse" images so images are relevant to specific event.
- Process for sharing information with law enforcement
  - o They verify who the requester is, the person is required to be a pre-approved person in sheriff's department.
  - Once material is requested, someone in department reviews footage with law enforcement
  - o There have been times where other civil agencies have been involved.

### Recreation and Parks

Christine Nath presented the Department Security Camera Policy previously using the standard security camera template.

The committee approved the Security Camera policies for the Department of Public Health and Recreation and Parks for review at COIT, with the exception of Todd Rydstrom, who abstained.

Discussion then continued to evaluate Surveillance Technology Policies that did not use the citywide template.

### Public Utilities Commission

Brad Taylor presented additional information about the Public Utilities Commission's Security Camera Policy, specifically about the costs of any technology used and its management.

The committee voted to approve the policy of the Public Utilities Commission unanimously.
