### 3. Approval of Minutes from March 12, 2021 (Action Item)

### 4. Discussion: Third Party Camera Agreements

SF Safe Executive Director Kyra Worthy presented on the SF Safe program, which allows police access to third-party cameras with the camera owner's and community consent. She discussed the cameras as a method of public safety, including issues of public disclosure, data governance, controls used by SF Safe, and advice for third party camera partnerships.

### 5. Review and Approval of Surveillance Technology Policy: AI and Algorithms

Department of Police Accountability (DPA) Attorney Sara Maunder and Veritone Representative Joe Fitzgerald presented the surveillance technology policy for the Veritone Video Redaction Tool by DPA.

PSAB members decided to continue discussion on the policy once DPA completed contract negotiations with the vendor.
