Inaugural Meeting

1. Call to Order and Roll Call

The Redistricting Task Force met in inaugural session through videoconferencing, and provided public comment through teleconferencing, on Friday, September 17, 2021. Clerk John Carroll called the meeting to order at 2:10 p.m.

On the call of the roll, Member Jeremy Lee, Member Gil, Member Pierce, Member Castillon, Member Townsend, Member Ho, Member Cooper, Member Chasel Lee, and Member Reiner were noted present. A quorum was present.

Angela Calvillo, Clerk of the Board (Board of Supervisors) conducted the ceremonial swearing-in of the 2020 Census Redistricting Task Force members.

2. Brief Remarks on the Purpose of the Task Force

John Arntz, Director (Department of Elections), and Adrienne Pon, Director (Office of Civic Engagement and Immigrant Affairs), provided brief remarks on the purpose and obligations of the Task Force and its Members.

Speakers: Mark Powell; David Pilpel; spoke on various concerns relating to the hearing matter.

3. Introductions of the Redistricting Task Force Members

Each of the new members of the Redistricting Task Force shared introductory remarks and welcomed one-another to the body.

4. Introduction of the Clerk of the Board, Angela Calvillo, and staff, including meeting platforms, regular meeting schedule, parliamentary authority, and outreach

Angela Calvillo, Clerk of the Board (Board of Supervisors), presented brief remarks introducing the services of the Office of the Clerk of the Board, including services related to remote and in-person meetings of the Task Force and cablecast services provided through SFGovTV; and answered questions raised throughout the discussion.

5. Discussion and Action to designate a Member of the Task Force as Chair and designate the Vice-Chair

Clerk Carroll presented guideline procedures for nominating and voting on the offices of Chair and Vice Chair, and opened nominations for the office of Chair. Member Castillon nominated Member Townsend; Member Jeremy Lee nominated himself. Nominations were closed with Members Townsend and Jeremy Lee nominated.
