Code Chapter 67) as applicable;’ and to add a new Article VIII COMMUNICATIONS to read as follows: ‘Section 1. Outside Communications ¶ Members receiving outside communications regarding redistricting that the member construes as material should forward those messages to the Clerk.’ The motion carried by the following vote:**
