
#### **Summary of Complaints Received in October 2021**

The Department of Police Accountability received **63** cases in **October 2021**, compared with **56** cases in the same period last year. The **October 2021** case total is **15%** higher than the five-year average and **13% higher** than the previous year.

From January through October, the DPA received a total of **658** new cases, compared with the **683** cases filed during the same period in 2020. The October year to date case total represents a **4%** decrease in new complaints over last year.




### **Year to Date Monthly Comparison of Cases Received**
