Dear Redistricting Task Force Chairman Townsend and Task Force Members:

As a mayoral appointee to the SF Elections Task Force of 1995 which drafted and recommended to the Board of Supervisors the district election plan approved by the voters in 1996, and was used to elect 11 members to the Board of Supervisors in 2000, it is with keen interest that I have been monitoring the progress of the 2021-2022 Redistricting Task Force and listened intently to your first of 17 district hearings which took place last Friday for District 6.

I share with the members your consternation of not having adjusted 2020 census data which zeroes in on ethnic, linguistic, and nationality to inform you on your block by block line drawing or to inform the line drawing by members of the public wishing to submit maps and plans to the Task Force. Such information plus residency status (homeowner and renter) and same sex couples were found at the block or tract levels in the 100% Summary Files 1 & 2 for the 2000 Census and 2010 Census, and used by previous Task Forces in line drawing.

Rather than bemoan the fact that the Census Bureau hasn't yet released such information for the 2020 Census and currently most ethnic groups and nationalities are subsumed under the four major racial groupings of Hispanic, and Non-Hispanic Whites, Asians, and Blacks which is a rather blunt statistical instrument, I would refer you to data updated at least weekly from the San Francisco Department of Elections. In the Department's Master Voter File are data which will serve to be more definitive than the broad racial categories or the CVAP data which can be highly unreliable at the census block level because of sampling errors by the American Community Survey which most recently was conducted by the Census Bureau from 2015-2019.

Upon my request, Director Arntz's staff provided me with the precinct-by-precinct stats of 41,419 San Francisco registered voters -- 8.2% of all registered voters of the City who requested that they be sent election materials in a language other than English.

Currently, City-wide, 7,535 voters have requested election materials in Spanish, 29,672 in Chinese, 1,547 in Vietnamese, 1,174 in Tagalog, 728 in Korean, 237 in Japanese, 213 in Thai, 55 in Hindi, 52 in Burmese, 6 in Khmer, 18 in Russian, and 182 in other languages.

These citywide stats don't necessarily reflect the relative size of each nationality, but rather the degree to which non-profits such as CAVEC and MALDEF have convinced Chinese and Hispanic voters to request voting materials in Chinese or Spanish, respectively. My guess is that nearly 40% of all Chinese voters have asked for Chinese language materials, while the percentage might be only 5%-10% for other groups, and in the case of most East Indian voters, probably less than 0.5% as most are already fluent in English.

What the data show is where language minorities are concentrated by precinct and by neighborhood.

More extensively and representative of the roughly 110,000 total voters in San Francisco who are immigrants is that the Department's Master Voters File (MVF) lists the place of birth of over 90% of the 504,100 registered voters of the City. Those

voters who listed their place of birth, listed the state, district, or territory of the United States, or the current or former foreign country, territory, or colony. The data will show that the majority of voters in six Chinatown/North Beach precincts were born in China, Hong Kong, Taiwan, or Macao.

The Department has organized that data for me by precinct order for Districts 6 and 5, and not only will we be able to find out where the concentration of Filipino immigrant voters is in the Tenderloin as differentiated from Vietnamese, East Indian, and Chinese, but also Arab immigrant voters from North Africa, the Near East, the Arabian Peninsula, and Persian Gulf states.

To process those tens of thousands of records will take a week or two, but once I've done so, I'll share my findings and heat maps with the Task Force to help inform your line drawing.

In the interim I will share with you the highlights of my findings using the Department's election materials language data for District 6.

247 Filipinos voters in District 6 requested election materials in Tagalog. Those precincts where Filipinos requesting non-English materials

constituted more than 1% of the registered voters included: 7608, 7609, and 7617 (2.85%) in the Tenderloin; 7622, 7623, and 7624 (3.22%) in Mid-Market and SOMA; and 7625 (2.91%) and 7634 (2.40%) (mostly Filipino who are now seniors who were displaced from housing along 3rd Street in the 1970's to provide for the construction of Moscone Convention Center and Yerba Buena Gardens.

294 Vietnamese voters in District 6 requested election materials in Vietnamese. Those precincts where Vietnamese requesting non-English materials constituted more than 1% of the registered voters included: 7603 (2.04%), 7604, 7606 (2.79%), 7607 (3.22%), 7608 (5.96%). 7609, 7613 (4.18%), 7615 and (5.17%) in the Tenderloin; and 7623 and 7629 in Mid-Market and SOMA.

504 Hispanic voters in District 6 requested election materials in Spanish. Those precincts where Hispanics requesting non-English materials constituted more than 1% of the registered voters included:

7602 (2.56%), 7603 (2.17%), 7604, 7605, 7606 (2.29%), 7607, 7609, 7613 (2.75%), 7614 (4.32%), and 7615 (2.30%) in the Tenderloin; 7621, 7622 (2.17%), 7623, 7624, 7628 (2.09%), 7629, 7632, and 7633 in Mid-Market and SOMA; 7625 and 7634 in Moscone Convention Center and Yerba Buena Gardens; 7644 (2.34%) in Mission Bay; and 7647 at Treasure Island.

Because proportionately more Chinese voters (2,561 in total in District 6) have requested Chinese language election materials than Filipinos and Vietnamese have in their native languages, I've increased the threshold to 10% of the registered voters in a precinct, to include: 7605 (15.40%), 7608 (21.50%), 7609 (28.54%), 7611 (12.17%), 7612 (17.80%), and 7617 (11.76%) in the Tenderloin; 7633 (18.88%) in Mid-Market and SOMA; 7625 (42.57%) and 7634 (11.87%) in Moscone Convention Center/Yerba Buena Gardens; and 7643 (13.45%) Mission Bay.

It will be interesting to find out the ethnicities and national origin of voters on Rincon Hill once I have analyzed the place of birth data from the MVF.

I hope this will prove helpful and I want to again thank Director Arntz and his able staff for their timely assistance.

In particular, we live about 100 feet away from the upcoming development at 3700 California St and only a few blocks away from the upcoming development at the former UCSF campus at 3333 California St. These two projects will be the biggest development projects to ever take place in these neighborhoods. As such, both projects will significantly impact my family and our neighborhoods during its construction (noise when driving piles, weekend work, traffic congestion, etc.) and forever transform our neighborhood. Make no mistake, I am a proponent of both projects but with such a massive change that will saddle both sides of California Street it seems inappropriate to change our neighborhoods into different districts at this time. Again, my house is 100 feet from 3700 California and it would seem logical that I coordinate any issues with the same district supervisor as someone on Sacramento Street. Similarly, the 3333 California development should be coordinated within the same district – it should not matter if you live on one side of California or the other. This stretch of land being developed is the shopping hub to Presidio Heights, Laurel Heights, and Jordan Park. To break up these neighborhoods into two distinct districts at this time just seems like a logistical nightmare.



Greetings SF Redistricting Task Force members,

As you shape and advance our City through a redistricting process I urge you to center genuine and participatory community engagement. To this end I urge accessibility, transparency and clarity in process and timeline.

Clear deadlines for draft maps with ample time allocated for community dialogue and feedback is critical. Several surrounding cities and counties, like Oakland and San Jose, released their first draft maps 3-4 months before their final submission deadline. Publishing a citywide draft map by February and presenting multiple options of district maps at the upcoming district-specific meetings will help facilitate conversation and elicit more feedback from community members who may not know where to start. Showing map options will help people get specific, which will be more helpful to you!

For a redistricting process to be truly democratic, we need language access so all members of our community can participate in this process that will affect all of us for the next decade. None of the meetings so far have had adequate language access. This is unacceptable. We need simultaneous translation in commonly spoken languages in SF like Spanish, Chinese, and Tagalog for all community members to be able to fully participate. In my D11 community, we have a lot of monolingual Spanish and Cantonese speakers. So far, they have not been able to participate in this process because there has not been consistent translation provided at meetings.

Mapping tools are a powerful resource to help visualize and negotiate proposals and I hope to see them incorporated in diverse community engagement settings where residents with limited tech skills can benefit. So far in my attempts to utilize the existing [redrawmysf tool](#) I have found it difficult to access the user's guide due to certain privacy issues identified by my browser constituting an entry level technical barrier, particularly for those with limited ability to navigate and troubleshoot tech issues.

Better political representation in my D11 community would ensure immigrant and working class communities of color have agency as our neighborhoods weather the storm of this public health pandemic and the legacy of a housing affordability crisis and economic disenfranchisement.

Hi Redistricting Task Force members,

The League of Women Voters of San Francisco is sending this public comment in writing because we learned there was an audio issue when Lauren Girardin spoke during the General Public Comment portion of the January 14, 2022 meeting, which may have made it difficult to understand what was being recommended.

Thank you for all your efforts today. As you each did, the League of Women Voters listened carefully to everything people shared today in their public comments. We are grateful to all the people who took time to call in today. As we listened, one thing became clear: People need more guidance from you about how they can describe their community of interest in a way that can be the most useful in this process.

With more guidance from you during these meetings, people can better understand that a community of interest can be defined through a wide variety of common interests, including shared culture, history, languages, experiences, identity, housing, recreation options, transportation access, environmental concerns, or other bond that brings a community together.

Hearing more specifics about communities of interest will also greatly benefit your redistricting process. We've seen this clearly in other jurisdictions that are further along. With more guidance from you during these meetings, people calling in will know they can and should be more specific about the physical boundaries of their community of interest. For example, they will know to mention specific streets and landmarks. They will know to make it clear which definition of city neighborhoods they mean, since there are wildly different views about what areas the Tenderloin encompasses, or which blocks are part of SOMA.

We strongly encourage you to use every one of these meetings as a chance to not just listen, but also to educate the public about redistricting. We recommend you always start these district meetings with an overview of what redistricting is, what a community of interest is, and specific things that are helpful for people to include when they define their community of interest — such as their community of interest boundaries, and specific street names, landmarks, public spaces, parks, businesses, and other places that are significant to that community. This can also include a reminder about the fact sheet that is being prepared, with the understanding that not everyone who calls into the task force meetings has access to online information.






