Dear Task Force Members,
Happy Friday! We hope this message finds you well. Below is our weekly update with the progress of our outreach and the next steps for the following week. We have continued to update our city-wide email blast contact list as we send out regular "save the date"/meeting reminder email blasts. In addition, this week, we have started the targeted outreach for **D7 organizations** and continued targeted outreach for **D4 and D9 organizations** with information and an invitation to participate in their respective District Task Force Meetings.

Highlights of The Week: We connected with District 8 priority community organizations list.

The district 8 list comprises 20 organizations that received a personalized email regarding the date, time, and how to participate in the upcoming meeting. In addition, we included the fact sheet to provide further intel on the redistricting process, communities of interest, and the overall process.

- After connecting with Betsy Eddy of the Diamond Heights Community Association, Betsy sent an announcement about the D8 meeting to an additional 790 contacts on the DHCA email list.
- Additionally, Matt McCabe of the Noe Neighborhood Council curated an exclusive newsletter about today's meeting to another 300 active members in his database, including our materials.
- Overall, for the District 8 meeting, we were able to reach over **1100 additional District 8 residents**, in addition to our email blast of 900 San Francisco-wide contacts!

While direct links in the email body will lead you to the respective materials listed, we have attached the **priority list document** shared earlier this week. In addition, we also included the **updated outreach calendar** and the finalized **translated fact sheet** as attachments for your reference.

Please see below for deliverable updates and reminders from the past week in more detail:

Calendar:

General/Citywide Email Blasts:

- We continue to add emails provided to us to our distribution list.
- The [D10 meeting reminder](#) sent on Feb 3 was delivered to 910 recipients and had a **36% open rate** and **8% click rate**
- The [D11 meeting reminder](#) sent on Feb 7 was delivered to 907 recipients with a **35% open rate** and **8% click rate**
- The [D8 meeting reminder](#) sent on Feb 9 was delivered to 907 recipients with a **33% open rate** and **4% click rate**

- As requested, we have also included buttons in Spanish, Chinese, and Filipino to direct residents to the agenda of their choice

District-Specific/Targeted Outreach:

- CEC continues to complete targeted outreach to the organizations indicated on the [priority organizations](#) to the Task Force members and CEC's targeted outreach within each district. We are also resharing the list as an attached word document, so the members have a wide range of accessibility to provide input

Task Force Members did not have any additions for District 11, District 8, or District 1 organizations

- As a reminder, we'd greatly appreciate it if the Task Force would prioritize reviewing the list and provide additions **no later than a week before their given meeting**.
- Any general questions about mapping, the meeting schedule, and general redistricting information are redirected to the rdtf@sfgov.org email

Phone call Outreach:

- Member Chasel Lee provided us with the phone call script on Tuesday, Feb 8
 - CEE **completed phone calls to all District 8 and District 1 organizations upon receiving the script**
- Phone calls to all **District 4** and **District 9** organizations have also been completed
- We are scoped to contact priority list **no larger than 25 organizations**
- CEC will make one call to each organization and leave a message if no one picks up
- Moving forward, phone calls to organizations in our priority organization list will be made **1 week before** their meeting

What is Redistricting?

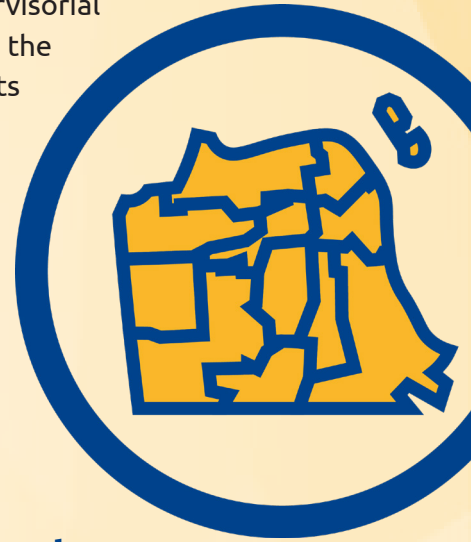
Redistricting is a once-a-decade exercise that draws lines of fair engagement and representation of our neighborhoods. It is an important part of our democracy that preserves our residents' rights of fair representation while promoting participation of our diverse citizens of various ethnic backgrounds, cultural demographics, and communities of interest.

Every ten years, the US Government conducts a nationwide census to count all people living in the United States. Based on the results of this census, new boundary lines are drawn for congressional, state, and local districts, including the San Francisco Supervisorial Districts, to ensure that voting districts are reflective of recorded population changes.

Why Does Redistricting Matter?

As the population of San Francisco grows and shifts, the City is legally required to redraw Supervisorial District boundaries every ten years to ensure equal and equitable representation for all residents. Redistricting directly impacts communities' access and ability to voice their goals, ideals, and objectives to their government officials through elections and community policies. This process helps ensure that communities of interest are kept intact with meaningful representation.

The San Francisco Redistricting Task Force (RDTF) is required to ensure that the boundaries of existing Supervisorial Districts comply with the legal requirements established by federal, state and local law. As part of that process, the RDTF holds multiple outreach hearings to receive input from the community.

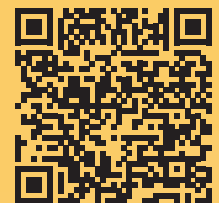


Who Will Redraw the New District Boundaries?

The RDTF is a diverse group of nine people appointed by the Mayor, the Board of Supervisors and the Elections Commission. It is responsible for drawing the new San Francisco Supervisorial District boundaries that will be used for the next ten years. The RDTF will conduct public meetings to collect testimony from residents about their communities and consider their input as they draw the new lines. The RDTF will adopt the new supervisorial district map before April 15, 2022.

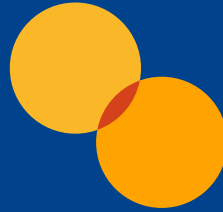
What are the Criteria for Creating New District Boundaries?



Districts must be roughly equal in population



Different parts of the district must connect geographically



Minimize splitting neighborhoods into multiple districts



Comply with local, state, and federal requirements, including the Voting Rights Act

What is a Community of Interest and why is it important?

A community of interest is a neighborhood, community, or group of people who share similar social, cultural, and economic interests and would benefit from being maintained in a single district. A community of interest does NOT include relationships with political parties, incumbents, or political candidates.

Keeping communities of interest together is an important principle in redistricting. It can be especially helpful to communities that have been traditionally left out of the political process. Without the participation and input of traditionally disenfranchised and unorganized communities, those who may not have these communities' best interest in mind will define the communities for them.

How can I define a community of interest?

Communities of interest are self-defined by local community members themselves. They can be described by creating maps and profiles describing common social, cultural, and economic threads tying the community together. Other ways that people can describe their communities of interest include:

Personal Testimonies

Community members can share examples of things residents share in common and what makes the community unique. Imagine describing the community to a visitor from out of town. What is the community's history?

Written description

A written description can describe what connects the people and why it's important that they be kept together.

Community Issues

Describe how various social, cultural, and economic issues bind the community of interest together and differentiate it from surrounding communities. What socioeconomic factors make this community stand out?

Boundary maps

Create a map of your neighborhood or area. Mark the street names and significant locations. They can include significant landmarks and gathering places, including social service agencies, community centers, shopping districts, schools, and religious places. You can do this in digital or paper format.

什麼是選區重劃？

選區重劃(Redistricting)是每十年一次的活動，旨在為我們的社區劃定公平參與和代表的選區界線。這是我們民主社會的一個重要部分，維護我們居民的公平代表權，同時促進我們不同種族背景的公民、文化人口和利益共同體社區的參與。

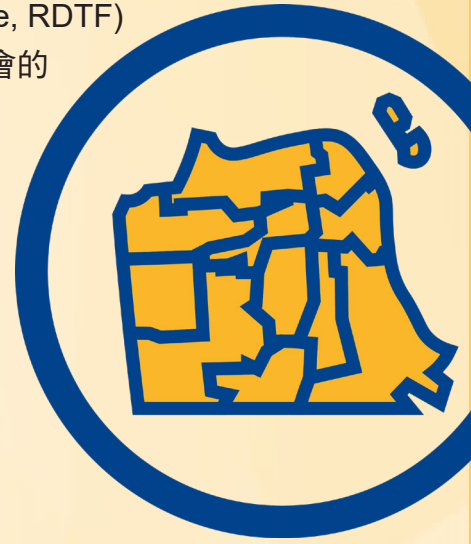
美國政府每十年進行一次全國性的人口普查，統計所有居住在美國的人口。根據這次人口普查的結果，為國會、州和地方選區，包括三藩市市議會各選區，劃定新的邊界線，以確保各投票區能夠反映記錄中的人口變化。

為什麼選區重劃至關重要？

隨著三藩市人口的增長和變化，本市必須按照法律的要求，每十年重新劃分市議會的分區界線，以確保所有居民的平等和公平的代表性。選區重劃直接影響到社區通過選舉和社區政策向政府官員表達他們的目標、理想和目的的機會和能力。這個過程有助於確保利益共同體社區保持完整的、有意義的代表性。

三藩市選區重劃工作組(San Francisco Redistricting Task Force, RDTF)

的任務是確保現有市議會的分界線符合聯邦、州和地方法律規定的要求。作為選區重劃過程的一部分，工作組舉行多次外展聽證會，藉此聽取社區的意見。



誰來重劃 新的選區分區界線？

選區重劃工作組是一個由市長、市議會和選舉委員會任命，由9名成員組成的多元化小組。它負責繪製將在未來十年使用的新的三藩市市議會選區分界線。選區重劃工作組將舉行公開會議，收集居民對其社區的證詞，並在繪製新的界線時考慮他們的意見。選區重劃工作組將於2022年4月15日之前通過新的市議會選區地圖。

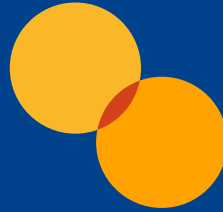

什麼是利益共同體，為何至關重要？

利益共同體是一個鄰里、社區或人群，他們擁有相似的社會、文化和經濟利益，並將從維持在一個區中受益。利益共同體**不包括**與政黨、現任者或政治候選人的關係。

將利益共同體保持在一起是選區重劃的一個重要原則。這樣對那些傳統上被排除在政治進程之外的社區特別有幫助。如果沒有傳統上被剝奪權利和沒有組織的社區的參與和投入，將可能由那些可能沒有把這些社區的最佳利益放於心上的人為他們來界定社區。

如何對利益共同體作出定義？

利益共同體社區是由當地社區成員自己來定義的。他們可以通過創建地圖和資料簡介來描述將該社區聯繫在一起的共同社會、文化和經濟線索。人們可以描述他們的利益共同體社區的其他方式包括：

邊界地圖

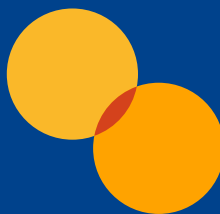

Ano ang Tinututukang mga Komunidad at bakit ito mahalaga?

¿Qué es la redistribución de distritos?

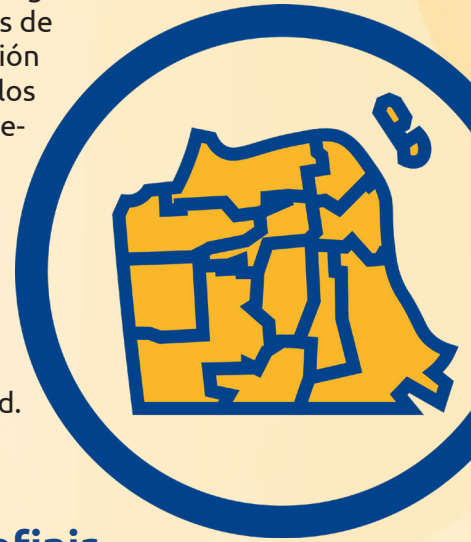
La redistribución de distritos es una actividad que se realiza cada diez años que traza líneas de límite para la participación y representación justa de nuestros vecindarios. Es una parte importante de nuestra democracia que conserva los derechos de nuestros habitantes a la representación justa y a la vez promueve la participación de nuestros ciudadanos diversos de diferentes orígenes étnicos, culturas y comunidades de interés.

Cada diez años, el gobierno de los EE. UU. realiza un censo nacional para contar a todas las personas que viven en los Estados Unidos. Con base en los resultados de este censo, se definen nuevas líneas de límite para distritos congresionales, estatales y locales, incluyendo los Distritos de Supervisión de San Francisco, para garantizar que los distritos de votación reflejen los cambios registrados en la población.

¿Por qué es importante la redistribución de distritos?

A medida que la población de San Francisco crece y cambia, la ley exige que la Ciudad vuelva a trazar los límites de los Distritos de Supervisión cada diez años para garantizar la representación igual y equitativa para todos los habitantes. La redistribución de distritos tiene un efecto directo en el acceso y la capacidad de las comunidades de expresar sus metas, ideales y objetivos a sus funcionarios de gobierno mediante elecciones y políticas comunitarias. Este proceso ayuda a garantizar que las comunidades de interés permanezcan intactas con representación significativa.

El Grupo de Trabajo de Redistribución de Distritos de San Francisco (San Francisco Redistricting Task Force o RDTF) tiene la obligación de garantizar que los límites de los Distritos de Supervisión existentes cumplan con los requisitos legales establecidos por la ley federal, estatal y local. Como parte de ese proceso, el RDTF celebra varias reuniones para la participación e información con el fin de recibir las opiniones a la comunidad.



¿Quién va a redefinir los nuevos límites de distritos?

El RDTF es un grupo diverso de nueve personas designadas por la Alcaldesa, el Consejo de Supervisores y la Comisión de Elecciones. Es responsable de definir los nuevos límites de los Distritos de Supervisión de San Francisco que se usarán por los siguientes diez años. El RDTF celebrará reuniones públicas para recolectar el testimonio de los habitantes sobre sus comunidades y considerar sus comentarios al definir nuevas líneas. El RDTF adoptará el nuevo mapa de distritos de supervisión antes del 15 de abril de 2022.

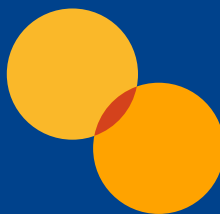
¿Cuáles son los criterios para crear nuevos límites de distrito?



Los distritos deben ser aproximadamente iguales en población



Las diferentes partes del distrito se deben conectar geográficamente



Se debe evitar al máximo dividir vecindarios en distritos múltiples



Se debe cumplir con los requisitos locales estatales y federales, incluso con la Ley de Derechos de Voto

¿Qué es una Comunidad de Interés y por qué es importante?

Una comunidad de interés es un vecindario, comunidad o grupo de personas que comparten intereses sociales, culturales y económicos similares y que se beneficiarían de permanecer juntos en un solo distrito. Una comunidad de interés NO incluye relaciones con partidos políticos, titulares o candidatos políticos.

Un principio importante en la redistribución de distritos es mantener juntas a las comunidades de interés. Podría ser especialmente útil a las comunidades que tradicionalmente han sido dejadas fuera del proceso político. Sin la participación y la opinión de las comunidades tradicionalmente marginadas y no organizadas, aquellos que no velan por los intereses de esas comunidades definirán las comunidades por ellas.

¿Cómo defino una comunidad de interés?

Las comunidades de interés son autodefinidas por los miembros de las comunidades locales. Se pueden describir creando mapas y perfiles que describen los vínculos sociales, culturales y económicos comunes que entrelazan a la comunidad. Otras maneras en las que las personas pueden describir sus comunidades de interés son:

Testimonios personales

Los miembros de la comunidad pueden compartir ejemplos de cosas que los residentes tienen en común y comparten y que hacen que la comunidad sea singular. Imáginese describir la comunidad a un visitante de fuera de la ciudad. ¿Cuál es la historia de la comunidad?

Descripción escrita

Una descripción escrita puede describir lo que conecta a las personas y por qué es importante que permanezcan juntas.

Temas de la comunidad

Describa cómo diversos temas sociales, culturales y económicos unen a la comunidad de interés y la diferencian de las comunidades circundantes. ¿Qué factores socioeconómicos hacen que esta comunidad se destaque?

Mapas de límites

Cree un mapa de su vecindario o área. Marque los nombres de las calles y los lugares importantes. Pueden incluir lugares característicos importantes y puntos de reunión como agencias de servicios sociales, centros comunitarios, distritos comerciales, escuelas y lugares religiosos. Puede hacer esto en formato digital o en papel.

Dear Task Force Members,

Happy Friday! We hope this message finds you well. Below is our weekly update with the progress of our outreach and the next steps for the following week. We have continued to update our city-wide email blast contact list as we send out regular "save the date"/meeting reminder email blasts. In addition, this week, we have started the targeted outreach for **D7 organizations** and continued targeted outreach for **D4 and D9 organizations** with information and an invitation to participate in their respective District Task Force Meetings.

Highlights of The Week: We connected with District 8 priority community organizations list. The district 8 list comprises 20 organizations that received a personalized email with information regarding the date, time, and how to participate in the upcoming meeting. In addition, we included the fact sheet to provide further intel on the redistricting process, communities of interest, and the overall process.

- After connecting with Betsy Eddy of the Diamond Heights Community Association, Betsy sent an announcement about the D8 meeting to an additional 790 contacts on the DHCA email list.
- Additionally, Matt McCabe of the Noe Neighborhood Council curated an exclusive newsletter about today's meeting to another 300 active members in his database, including our materials.
- Overall, for the District 8 meeting, we were able to reach over **1100 additional District 8 residents**, in addition to our email blast of 900 San Francisco-wide contacts!

Why is Redistricting Important?

As our population shifts and grows, the City is legally required to redraw supervisorial district lines every ten years to ensure equal and equitable representation for all San Francisco residents. 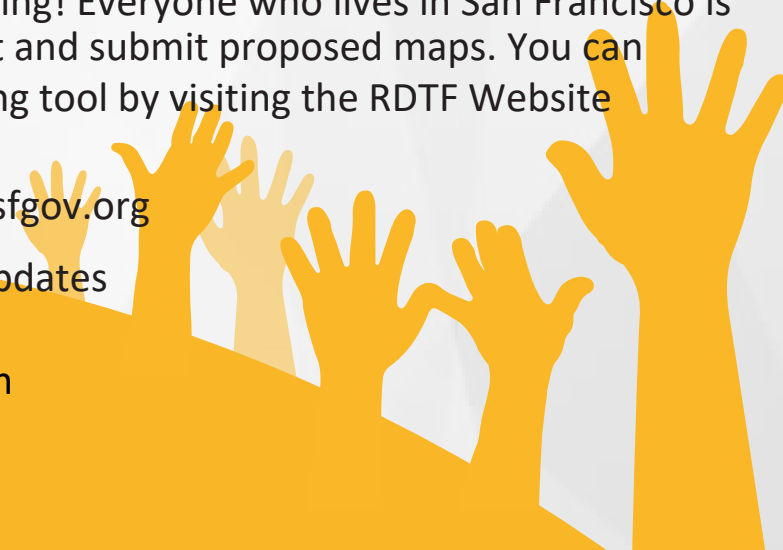
