1. Call to Order and Roll Call

The Redistricting Task Force met in special session through videoconferencing, and provided public comment through teleconferencing, on Wednesday, February 16, 2022. Chair Reverend Arnold Townsend called the meeting to order at 5:33 p.m.

On the call of the roll, Chair Townsend, Member Jeremy Lee, Member Hernández Gil, Member Pierce, Member Castillon, Member Ho, Member Cooper, Member Chasel Lee, and Member Reiner were noted present. A quorum was present.

2. District 4 Boundaries, Neighborhoods and Communities of Interest

Speakers: Dennis Minnick, President (Sunset Heights Association of Responsible People SHARP); requested that the Task Force retain Golden Gate Heights as part of District 7, and not include the neighborhood in District 4, and consider moving the boundary between Districts 5 and 7 north from Judah Street to Lincoln Way.

Speaker; requested that the Task Force retain Golden Gate Heights in District 7, and not include the neighborhood in District 4.

Jessica Ho; requested that the Task Force keep the existing neighborhoods of District 4 together; suggested that if the Task Force must make changes, then the boundary between Districts 4 and 7 should east from 19th Avenue to 17th Avenue; and requested the Task Force release draft maps for the public to review.

Speaker; requested that the Task Force extend the existing boundaries of District 4 east of 19th Avenue to 7th Avenue and Kirkham Street, in order to include the Inner Sunset in District 4.

Frank Noto (Golden Gate Heights Neighborhood Association); requested that the Task Force retain Golden Gate Heights as part of District 7, rather than include the neighborhood in District 4; suggested that moving the boundary east would split the Sunset Heights neighborhood commercial district at 9th Avenue between two supervisorial districts; suggested that the natural boundaries of District 4 are Golden Gate Park, Lincoln Way, and 19th Avenue; and further suggested that the Task Force consider moving the District 4 boundaries south to the Lake Merced area rather than expanding to the east.

Ralph Lane; requested that the Task Force recognize the merchants of Irving Street corridor as a Community of Interest, and not divide them between District 4 and 5; and suggested expanding the boundaries of District 4 east along Irving Street.

Eileen Boken (Sunset Parkside Education and Action Committee SPEAK); recommended that the Task Force recognize the Outside Lands south of Golden Gate Park as a community of interest; suggested joining the Inner and Outer Sunset by moving the boundary between Districts 4 and 7 to the east, keep the Farallon Islands in District 4, not expand the boundaries of District 7 into the Sunset, retain Golden Gate Park in District 1, and suggested moving the District 4 boundaries south toward Stonestown at Buckingham Way.

Carla Kozak (Sunset Heights Association of Responsible People (SHARP)); requested that the Task Force recognize Golden Gate Heights and the Inner Sunset as communities of interest; suggested that the boundary between Districts 4 and 7 be moved off of 19th Avenue; and that the 9th Avenue and Irving corridor be included in District 4.

Doug Marschke; requested that the Task Force redistrict the Inner Sunset into District 4. Christy (Better Housing Policy); requested that the Task Force move the boundary between Districts 4 and 7 to the east to include the Inner Sunset and move the southern boundary to include Lowell High School in District 4.

Katherine Howard; requested that the Task Force expand the area of District 4 to the east along Irving Street, Lincoln Way, and Judah Steet to include the Inner Sunset, and also suggested that Golden Gate Park should remain in District 1.

Tes Welborn; requested that the Task Force recognize progressive voters of the Inner Sunset as a community of interest; suggested that the merchant corridor of the Inner Sunset not be redistricted into a single supervisorial district; and that only a few blocks of the Inner Sunset be included in District 4.

Noelle; requested that the Task Force not redistrict the boundaries of District 4 to include the Inner Sunset and suggested that the southern boundary not be moved to include Stonestown.

Josephine Zhao (Chinese American Democratic Club); requested that the Task Force move the boundaries of District 4 into the Inner Sunset, to include business on the Irving Street merchant corridor, as well as along 9th Avenue.

John Barkan; requested that the Task Force redistrict the Inner Sunset into District 4; suggested adding the area bounded by 17th Avenue, 19th Avenue, and Sloat Boulevard; and suggested moving the District 4 boundaries south toward Stonestown at Buckingham Way.

Amy; requested that the Task Force move the southern boundary of District 4 to include Lowell High School and the Lake Merced area.

Yan (Better Housing Policy); requested that the Task Force recognize the western Sunset as a community of interest, and retain it in District 4, and suggested that the southern boundary be moved to include Lowell High School.

Sandy; requested that the Task Force redistrict the Inner Sunset into District 4.

Jeff Rigo; suggested that the border between Districts 4 and 7 should be set at 7th Avenue, that the Irving Street merchant corridor be included in District 4, and that Forest Hill remain in District 7.

Laurie Liederman; requested that the Task Force retain the Inner Sunset in District 5, if possible; suggested that if it is necessary to move the District 4 boundaries, then the Inner Sunset should be moved into District 4 rather than District 7, and include the Irving Street merchant corridor.

Natalie Simotas; requested that the Task Force retain the Pine Lake Park neighborhood in District 4, and suggested that the District 4 boundaries be moved toward the south.

Matt Sharocki; requested that the Task Force extend the District 4 boundaries to the south of Sloat Boulevard.

Evan Chan; requested that the Task Force retain the Pine Lake Park neighborhood in District 4, and suggested that the District 4 boundaries be moved to the south.

David Pilpel; requested that the Task Force review the boundaries he submitted on file, which retains the core of the Sunset in District 4, along with Pine Lake Park; and recommended that the Task Force not include Lowell High School or Park Merced in District 4, and retain Stonestown in District 7.

Sam; requested that the Task Force redistrict portions of the Inner Sunset into District 4, and suggested including Lowell High School to the south.

Angie Pettitt; requested that the Task Force include the Inner Sunset in District 4.

Mr. Wu; requested that the Task Force include areas bounded by 14th Avenue, Lincoln Way, and Kirkham Avenue into District 4, and suggested including Lowell High School to the south.

Michelle Wong; suggested that the boundaries of District 4 be moved to the south.

Lily (Better Housing Policy); requested that the Task Force include the Inner Sunset in District 4, by adding areas bounded by Lincoln Way, 9th Avenue, and Kirkham Street; and suggested including Lowell High School to the south.

Erica Zweig; requested that the Task Force move the District 4 boundary toward the east into the Inner Sunset past 9th Avenue, and include the Kirkham Street and Lincoln Way corridors.

Speaker (Better Housing Policy); requested that the Task Force include the Irving Street Corridor in District 4; suggested that the District 4 boundaries include 14 Avenue, Lincoln Way, and Kirkham Street; and suggested including Lowell High School to the south.

At the conclusion of the discussion, Chair Townsend declared the matter heard and filed.

3. Q2 Redistricting Consultants Update

Seth Neill, Redistricting Consultant (Q2 Data and Research); presented an update on the roll-out of the San Francisco Redistricting Tool.

Speakers: Sana Sethi (San Francisco Rising); requested that the Task Force begin sharing information about the procedures for creating draft maps. Lauren Girardin (League of Women Voters San Francisco); requested that the Task Force begin sharing information about the procedures for creating draft maps. Josephine Zhao; shared concerns about the accessibility of the online mapping and community of interest tools. Seitse Goffard (Asian Americans Advancing Justice); shared various concerns on the hearing matter. Jen Tse (League of Women Voters San Francisco); shared concerns about the accessibility of the online community of interest tool.

At the conclusion of the discussion, Chair Townsend declared the matter heard and filed.

4. Updates to Regular and Special Meeting Schedule

At the conclusion of the discussion, Chair Townsend declared the matter heard and filed.

Toklas LGBTQ Democratic Club, with Cynthia Dai of the California Citizens Redistricting Commission and Member Chasel Lee.

Speakers: Lauren Girardin (League of Women Voters San Francisco); spoke on various concerns relating to the hearing matter.

At the conclusion of the discussion, Chair Townsend declared the matter heard and filed.

2. District 9 Boundaries, Neighborhoods and Communities of Interest

Speakers: Marc Salomon; requested that the Task Force remove Bernal Heights from District 9, and consider that Bernal Heights be in the same district as Noe Valley.

Christopher Statton; requested that the Task Force recognize and support Latinx and American Indian communities of interest in the Mission, and retain them together; and suggested that all of Valencia Street and the Calle 24 Latino Cultural District be included in District 9.

Speaker; requested that the Task Force recognize the Portola Garden District as a community of interest and retain it in one district, and defined the area as bounded by Silver Avenue, Cambridge Street, John McLaren Park, and Mansell Street to San Bruno Avenue.

Karina; requested that the Task Force retain the communities of District 9 together.

Eric Rottenberg; requested that the Task Force recognize the Portola neighborhood as a community of interest and retain it intact within one supervisorial district.

Valerie Luu; requested that the Task Force recognize the small business community on San Bruno Avenue as a community of interest and retain them together in District 9.

Vanecia Margarita; requested that the Task Force expand the Latinx community voice in District 9, expand the district lines beyond 13th Street, mitigate the impacts of

redistricting on the Latinx community voice, and suggested that all of Valencia Street and the Calle 24 Latino Cultural District be included in District 9.

Trevor Chandler; requested that the Task Force include the Valencia Street corridor in District 9.

Rodrigo Elan; requested that the Task Force expand the Latinx community voice in District 9, expand the district lines beyond 13th Street, mitigate the impacts of redistricting on the Latinx community voice, and suggested that all of Valencia Street and the Calle 24 Latino Cultural District be included in District 9.

Todd Berman; requested that the Task Force recognize the Bernal Heights neighborhood as a part of the Mission, and retain the two together in one supervisorial district; and suggested that the Task Force unite Valencia street with the rest of the Mission district.

Seth Brenzel; requested that the Task Force include both sides of Valencia Street in one supervisorial district.

Paloma Flores (American Indian Cultural District); requested that the Task Force recognize District 9 as the home of the American Indian community; requested that the Task Force expand the Latinx community voice in District 9, expand the district lines beyond 16th Street, mitigate the impacts of redistricting on the Latinx community voice; and suggested that all of Valencia Street and the Calle 24 Latino Cultural District be included in District 9.

Mimi Klausner; agreed with the comments of Paloma Flores, and requested that the Task Force unite the Mission and Bernal Heights neighborhoods in one supervisorial district, and retain them in District 9 with the Portola Garden District.

Amy Beinart; requested that the Task Force recognize the three neighborhoods of the Bernal Hill area as a community of interest and retain them together, as well as recognize the American Indian and Latinx cultural districts and retain them wholly within District 9; and suggested that the Task Force draw and share draft maps as soon as possible, for the communities.

Ligia Montano (Senior and Disability Action); requested that the Task Force consider the impacts of redistricting on low income communities of the City and people who are living in affordable housing, and consider the impacts to affordable housing production.

Randy Gilstrap; requested that the Task Force recognize Saint Mary's Park as a community of interest and retain it wholly in District 9, united with Bernal Heights.

Noah Pascual; requested that the Task Force recognize and retain the Portola as a community of interest, and keep it in District 9.

Phillip Hua; requested that the Task Force recognize and retain the Portola Garden District as a community of interest, help the district to expand its identity and integrity, and retain it in District 9 together with the Alemany farmers market and Bernal Heights.

Penny Mitchell; requested that the Task Force recognize Saint Mary's Park as a community of interest and it retain together with Bernal Heights in District 9 rather than District 11.

Kevin Ortiz; requested that the Task Force recognize the Latinx community north of Division Street as a community of interest, and include it in District 9; requested that the Task Force expand the Latinx and American Indian community voices in District 9, expand the district lines beyond 16th Street, mitigate the impacts of redistricting on the Latinx community voice, and suggested that all of Valencia Street and the Calle 24 Latino Cultural District be included in District 9.

Eric Arguello, President (Calle 24 Latino Cultural District); requested that the Task Force recognize District 9 as the home of the American Indian community; requested

that the Task Force expand the American Indian and Latinx community voices in District 9, expand the district lines beyond 16th Street, mitigate the impacts of redistricting on the Latinx community voice; and suggested that all of Valencia Street and the Calle 24 Latino Cultural District be included in District 9.

Lauren Girardin; requested that the Task Force recognize the connection between the Mission and Bernal Heights and retain them together in District 9, along with McLaren and Saint Mary's Parks and the Portola district.

Larisa Pedroncelli; requested that the Task Force move the border between Districts 9 and 6 to the north; suggested that District 9 include both sides of Valencia Street; requested that the Task Force draw and release draft maps as soon as possible; and suggested that the American Indian community voice needs to be a part of the redistricting process.

Tracy Brown Gallardo (Latino Task Force); requested that the Task Force recognize the vibrant Mission community and keep it whole, include both sides of Valencia Street, expanding upward to 13th Street; suggested that the Task Force recognize the Latino Cultural District and American Indian Cultural District together; and defined the Mission district as Duboce Street, Dolores Street, and Cesar Chaves Avenue to Potrero Avenue.

Roberto Hernandez; requested that the Task Force include Mission High School; Mission Dolores Park, both sides of Valencia Street, and the American Indian Cultural District within the boundaries of District 9; recognize the people who have been gentrified out of the Mission as a community of interest; and suggested that residents of the area near Potrero Avenue and 25th Street residents want to be included as a part of the Mission District.

Josephine Zhao; requested that the Task Force recognize the Portola and Visitacion Valley as communities of interest; and defined the area south of Interstate 280, Cambridge Street to Mansell Street as an area which should be united to Visitacion Valley and included with the Bayview west of 3rd Street in one supervisorial district.

Luis Avalos, Board Member (San Francisco Latinx Democratic Club); requested that the Task Force empower the voice of the Latinx community.

David Pilpel; requested that the Task Force review the boundaries he submitted on file which includes the Portola in District 11, includes areas north of the present border with District 6 as part of District 9, and includes both sides of Valencia Street in one supervisorial district; suggested that the principal issue is where the Portola is included, but that it should not be added to District 10; and suggested that the Task Force consider including Bernal Heights as a part of District 8.

Katie; requested that the Task Force recognize the Portola and Visitacion Valley as communities of interest and recommended that they remain together in one supervisorial district.

Speaker; requested that the Task Force recognize the Portola, Visitacion Valley, and the Bayview as communities of interest and recommended that they remain together in one supervisorial district.
