


Summary of Complaints Received in July 2021

The Department of Police Accountability received **65** cases in **July 2021**, compared with **63** cases in the same period last year. The **July 2021** case total is **16%** higher than the five-year average and **3% higher** than the previous year.

From January through July, the DPA received a total of **462** new cases, compared with the **506** cases filed during the same period in 2020. The July year to date case total represents a **9%** decrease in new complaints over last year.




Year to Date Monthly Comparison of Cases Received
