## Special Meeting

### 1. Call to Order and Roll Call

*The Redistricting Task Force met in special session through videoconferencing and provided public comment through teleconferencing on Wednesday, February 23, 2022. Chair Reverend Arnold Townsend called the meeting to order at 5:32 p.m.*

*On the call of the roll, Chair Townsend, Member Jeremy Lee, Member Hernández Gil, Member Pierce, Member Castillon, Member Ho, Member Cooper, Member Chasel Lee, and Member Reiner were noted present. A quorum was present.*

### 2. District 7 Boundaries, Neighborhoods and Communities of Interest

*Speakers: Denis Minnick; defined the area of 19th Avenue, Lincoln Way, 7th Avenue to Dewey Boulevard as Golden Gate Heights, and requested that the Task Force recognize it as a community of interest to be retained within District 7; suggested that the 9th Street and Irving Street merchant corridors be redistricted into District 7; and requested that the southern border of District 4 be moved further south.*

*Speaker; requested that the Task Force redistrict the Inner Sunset into District 7. Marc Christensen, President (Merced Extension Triangle Neighborhood Association); defined the area of Junipero Serra Boulevard, Brotherhood Way, and Interstate 280 to the south and east as the Merced Extension Triangle and requested that the Task Force recognize the Merced Extension Triangle Neighborhood as a community of interest in District 7.*

*Frank Noto (Sunset Heights Association of Responsible People); requested that the Task Force unify the Inner Sunset east of 19th Avenue and south of Golden Gate Park and include the area in District 7, including the 9th Street and Irving Street merchant corridors.*

*Alice; requested that the Task Force extend District 7 to the north to include the Inner Sunset, and retain Golden Gate Heights in District 7.*

*Karen Breslin (Mira Loma Park Improvement Club); requested that the Task Force recognize Mira Loma Park as a community of interest and retain it wholly in District 7. George Wooding (Midtown Terrace Homeowners Association); requested that the Task Force support the redistricting plan submitted and on file from Christopher Bowman. Speaker; requested that the Task Force extend the boundaries between Districts 4 and 7 to the south.*

*Ivy; requested that the Task Force redistrict the area around Lowell High School into District 4 rather than District 7.*

*Sallie Stevens President (Golden Gate Heights Improvement Association); defined the area of 19th Avenue, Kirkham Street to 9th Avenue as Golden Gate Heights, and requested that the Task Force recognize Golden Gate Heights as a community of interest in District 7; suggested including the Irving Street merchant corridor in District 7, including extending District 7 to Lincoln Way and 19th Avenue; and suggested that the Task Force move the boundary between Districts 4 and 7 south of Sloat Boulevard.*

*Denise LaPointe; requested that the Task Force preserve Twin Peaks Boulevard as the eastern boundary between Districts 7 and 8.*

*Speaker; defined the areas around Sloat Boulevard, Inverness Drive, Lake Merced Boulevard, and Skyline Boulevard as Lakeshore Acres, and requested that the Task Force recognize Lakeshore Acres as a community of interest in District 7.*

*Patrick Carroll (Diamond Heights Community Association); requested that the Task Force recognize and retain Diamond Heights as a community of interest within District 8, and not redistrict the area into District 7.*

*Ms. Yan; requested that the Task Force redistrict the area around Lowell High School into District 4 rather than District 7.*

*Qi Dai; requested that the Task Force redistrict the area around Lowell High School into District 4 rather than District 7.*

*Michelle; requested that the Task Force recognize Merced Manor and Lakeshore Acres together as a community of interest, and redistrict them into District 4; suggested that the Task Force consider extending the District 4 boundaries south of Sloat Boulevard; and suggested that the Inner Sunset be redistricted into District 7.*

*Dona Crowder (Golden Gate Heights Improvement Association); requested that the Task Force preserve Twin Peaks Boulevard as the eastern boundary between Districts 7 and 8; and requested that the area around the corner of Glen Brook Avenue and Saint Germain Avenue be included as a part of District 7.*

*Martha Ehrenfeld, President (Inner Sunset Park Neighbors Association); requested that the Task Force recognize the Irving Street merchant corridor as a community of interest and redistrict it so that it will be within one supervisorial district.*

*May; requested that the Task Force redistrict the area around Lowell High School into District 4 rather than District 7.*

*Steven Depant-Kalani Currier; supported the comments of Marc Christensen, and the map submitted by Christopher Bowman.*

*Claire Sanchez; defined the area of Junipero Serra Boulevard, Brotherhood Way, and Interstate 280 to the south and east as the Merced Extension Triangle, and requested that the Task Force recognize the Merced Extension Triangle Neighborhood as a community of interest in District 7.*

*Mark Scardina, President (Ingleside Terraces Homeowners Association); requested that the Task Force recognize the area around Ocean Avenue, Junipero Serra Boulevard, and Holloway Avenue as a community of interest in District 7.*

*Selena; requested that the Task Force recognize the area south of Sloat Boulevard as a community of interest, and redistrict the area to be included in District 4 rather than District 7.*

*Betsy Eddy, President (Diamond Heights Community Center); requested that the Task Force retain Diamond Heights in District 8, rather than District 7.*

*Neil Hunt (Merced Extension Triangle Neighborhood Association); requested that the Task Force retain the Merced Extension Triangle in District 7, including areas along Brotherhood Way.*

*Erica Zweig; requested that the Task Force recognize the areas around Lincoln Way and the Irving Street and Judah Street merchant corridors of the Inner Sunset as a community of interest and retain the area in one supervisorial district, whether that be in District 4 or 7.*

*Amy; requested that the Task Force redistrict the area around Lowell High School and Merced Manor into District 4 rather than District 7.*

*Lori Liederman; requested that the Task Force recognize the Inner Sunset as a community of interest and include it in District 4 rather than District 7.*

*Lily Wong (Wah Mei School); requested that the Task Force recognize the Sunset Chinese Cultural District as a community of interest and retain wholly within one supervisorial district.*

*Eileen Boken (Sunset Parkside Education and Action Committee SPEAK); requested that the Task Force not split the Inner Sunset into three supervisorial districts, as it is presently.*

*Pierre Smit, Executive Director (Ocean Avenue Association); requested that the Task Force not split the Ocean Avenue merchant corridor into two supervisorial districts.*

*Christy (Better Housing Policy); requested that the Task Force redistrict the area around Lowell High School and Merced Manor into District 4 rather than District 7.*

*Ivy Lee; requested that the Task Force recognize the Inner Sunset as a community of interest, and include the neighborhood in District 7.*

*David Pilpel; requested that the Task Force review the boundaries he submitted on file, and shared other comments with the Task Force.*

*Walter Caplan; requested that the Task Force recognize the single-family home neighborhoods and homeowners in District 7 as a community of interest, and make minimal changes to the boundaries of the district.*

*Cory Silver; shared various concerns with the Task Force.*

*At the conclusion of the discussion, Chair Townsend declared the matter heard and filed.*

*Speaker; requested that the Task Force recognize the Anza Vista, Presidio Heights, and Laurel Heights neighborhoods as a community of interest, and keep them together in District 2.*



*Paulina Behr; requested that the Task Force redistrict the Seacliff neighborhood and include it District 1, rather than District 2.*

*Al Sodini, President (Anza Vista Neighborhood Association); requested that the Task Force recognize the Anza Vista, Presidio Heights, and Laurel Heights neighborhoods as a community of interest, and keep them together in District 2.*

*Richard Lowden; requested that the Task Force redistrict the Seacliff neighborhood and both sides of Lake Street into District 1 rather than District 2.*

*Carol Ann Rodgers, President (Russian Hill Neighbors); requested that the Task Force redistrict Russian Hill into District 3 rather than District 2.*

*Speaker; requested that the Task Force redistrict Russian Hill into District 3 rather than District 2, include the Seacliff neighborhood in District 1.*

*Don Misumi; requested that the Task Force review the Community Unity Map announced by San Francisco Rising, suggested that the boundary between Districts 1 and 2 be moved toward the east, and suggested that the Seacliff neighborhood not be redistricted into District 1.*

*Amy Chiu; requested that the Task Force redistrict the Clement Street merchant corridor to be in the same supervisorial district as Jordan Park.*

*Lynne Newhouse Segal; requested that the Task Force recognize the Pacific Heights neighborhood as a community of interest, and extend the district boundaries southward to Bush Street to include the entirety of Pacific Heights within District 2.*

*Speaker; requested that the Task Force redistrict the Presidio Heights neighborhood and both sides of Lake Street into District 1 rather than District 2.*

*Winston Parsons; requested that the Task Force move the boundaries between Districts 1 and 2 toward the east, not include Presidio Heights in District 1, and requested that the Task Force recognize a community of renters in District 1 as a community of interest, and not dilute the voice of a community of renters in District 1.*

*Heather; requested that the Task Force redistrict the border between Districts 1 and 2 to include both sides of Lake Street in District 1.*

*Tammy Yee; requested that the Task Force not expand the boundaries of District 2 toward Chinatown.*

*Richard Warner; requested that the Task Force consider the Jordan Park, Presidio Heights, and Laurel Heights neighborhoods as a community of interest and retain them together in District 2, and endorsed the map on file from Christopher Bowman.*

*Susan Ford; requested that the Task Force recognize Russian Hill as a community of interest, and retain it wholly within one supervisorial district by moving the boundary between Districts 2 and 3 toward the west to Van Ness Avenue.*

several neighborhood boundary definitions utilized by different departments of the city. Jen Tse (League of Women Voters San Francisco); shared concerns about the accessibility of community of interest visualizations prepared by Q2 and suggested that the Task Force provide an introductory presentation before each mapping session, to elicit more productive public input. Charles Ferguson, President (Presidio Heights Association of Neighbors); suggested that the Task Force consult the legal boundaries of the various neighborhood associations of the city. David Pilpel; shared various concerns with the Task Force.

At the conclusion of the discussion, Vice Chair Reiner declared the matter heard and filed.
