Task Force (TF) Mapping Procedures

Principles:

- The TF will provide Q2 with specific instructions for a starting point for the first maps to be presented to the Task Force on 3-2-22 the first mapping meeting of the TF.
- Mapping requests and changes will be initiated by the TF and they will work with Q2 who will draw the next requested iterative map.
- Discussions will be focused on Communities of Interest, Neighborhoods, District Boundaries, Census
 Data and compliance with The Voting Rights Act.
- Allow Task Force to explore multiple paths or maps.
- Offer clear forward direction and clarity for the mapping process status at the end of each meeting.

Communication

Liaisons on process, clarification or info/questions between TF and Q2 for mapping will be Members Matt Castillon and Chasel Lee. Members Castillon and Chasel Lee will be in charge of coordinating the process and keeping a written log of what feedback or input is incorporated in each map. This feedback should be reflected in the public record and in the Final Report.

Task-Force Centralized Mapping for Follow Up Maps

TF members will initiate all requests for maps or mapping changes.

After the members have shared their comments there will be a recommendation to advance one of the prior maps with specific changes.

Where possible the TF will attempt to advance the next stage of the mapping process off a chosen specific and hopefully single map. If needed multiple map will be advanced but the goal will be to always advance off of one specific map.

As the new map is selected the TF will ask Q2 to come back with that map as the basis with 2 or 3 new/different versions on the next iteration.

After the TF has provided their direction to Q2 there will be public comment.

The members may again discuss the maps and any changes they would like to see if any.

The map may then be advanced without further changes or with changes recommended and approved by the TF. If consensus has been reached then the mapping request will be advanced to Q2. If there is no consensus, a formal vote may be taken.

This will be the process the TF will follow at each mapping meeting until the final map is selected on or before April 14th.

Groups and the public may submit their maps to the TF through the public website, and TF members may pick parts or all of a map to incorporate into their mapping requests. In order to maintain fairness, all outside feedback will be evaluated independently and no outside individual will be given preferential treatment over any other member of the public.

• Specifically, non-TF generated maps are a form of public comment, and no publicly generated maps will be directly presented to a member of the TF by an interest group or non-task force member.

Sample Mapping Advancement and Naming Sequence:

- -Mapping Day 1 (3-2-22): TF provides parameters to Q2 to create Map 1 A
 - -3-9-22 Q2 provides Map 1 A to the TF for discussion on 3-14-22
- -Mapping Day 2 (3-14-22):
 - TF provides new mapping instructions of boundary changes to Map 1 A which will then be returned named Maps 2 A and 2 B.
- -Mapping Day 3 (3-23-22): Q2 will return next mapping day with changes requested by TF Maps 2 A & 2 B
 - TF motions through consensus or vote to move one of the maps let's say Map 2 B forward
 - TF provides new mapping instructions of boundary changes to Map 2 B which will then be returned, if there are three, named Maps 3 A, 3 B and perhaps a 3 C.
 - *From here on in mapping days will be numbered but not dated as dates may be added as we go along.
- -Mapping Day 4: Q2 will return next mapping day with changes requested by TF Maps 3 A, 3 B, & 3 C
 - TF motions through consensus or vote to move let's say Map 3 C forward
 - TF provides new mapping instructions of boundary changes to Map 3 C which will then be returned, if there are two, named Maps 4 A & 4 B.
- -Mapping Day 5: Q2 will return next mapping day with changes requested by TF Maps 4 A & 4 B
 - TF motions through consensus or vote to move map let's say 4 A forward.
 - TF provides new mapping instructions of boundary changes to Map 4 A which will then be returned, if there are two, named Maps 5 A & 5 B.

The mapping continues as noted above until a final map is voted on.

Live Line Drawing

Line drawing is conducted during public sessions at officially agendized task force meetings. Line drawing may also occur at any other designated mapping meetings if the TF decided to do so. Combination of mapping and line drawing meetings may occur at the discretion of the TF.

Two specific dates, because of Q2 turn around requirements have been designated as line drawing days. They are 3-26-22 and 4-9-22.

Consultants (Q2) will be present with a mapper and digital maps at the ready.

The Task Force can start with existing lines, or with someone's proposed new lines, or with a blank map. In some cases the task force may work up "visualizations," which may be rough-sketch districts, and proceed from there.

The Chair or designee will focus on a particular area and then begin taking input from other Task Force members about particular lines.


TF members are free to give whatever reasons they think germane to their proposals, whether it were public input, or balancing populations, or known neighborhood boundaries.

1. Only one change could be considered at a time (though mappers could undo past changes as needed).


Line mapping will be done by consensus.




District 6A detail







Public Input and Communities of Interest

Introduction: What is Redistricting?

San Francisco has 11 supervisorial districts, used to elect the Board of Supervisors.

Redistricting is the process of adjusting the existing supervisorial district boundaries.

Redistricting happens every 10 years, after the release of the decennial Census data used to balance the populations of the supervisorial districts.

Redistricting provides the opportunity to bring the existing districts into compliance with all redistricting criteria.

No draft maps have yet been created by the Redistricting Task Force.

What are the criteria for redistricting?

- ➤ Compliance with US and CA Constitution (equal population)
- Compliance with Federal Voting Rights Act (FVRA) which addresses race and language minorities
- > Preserve recognized neighborhoods
- ➤ Preserve Communities of Interest (COIs)
- Contiguity
- Compactness



Recognized Neighborhoods and Communities of Interest (COIs)

<u>Recognized Neighborhoods</u> are generally based on data and geography collected from official sources (like the Planning Department). Neighborhood data may be submitted by members of the public as well. Neighborhoods may vary in size and definition depending on who is defining them.

<u>Communities of Interest</u> are generally described as a population of residents that share common interests (such as social, cultural, and economic interests) that should be included within a single district for purposes of its effective and fair representation.

COIs are defined by those familiar with the community...

Law does not limit the kinds of interests that may bind a community.

It is up to those who live in or work in a community to identify and establish the interests that unite it.

Interests need not be limited to current situation but can also include common goals.

Communities of Interest <u>do not</u> include relationships with political parties, incumbents, or political candidates.



Examples of Common Interests

Economic interests:

Current situation -- common employment or economic opportunities (or lack thereof).

Goals -- expanding opportunities, development, job creation

Social interests:

Current -- schools, transportation, parks, housing

Goals -- improving recreational opportunities or public safety, preserving historic resources

Cultural interests:

Current -- holidays, cultural businesses

Goals – cultural-meeting centers, official recognition through cultural districts

Why Keep Together

Our neighborhood has suffered because we have historically been divided among 4 different districts (5, 6, 8, 9). There are neighborhood problems unique to living near the end of the Central Freeway that no supervisor currently adequately represents, and why should they? Any problems that arise, their involvement would, at most, benefit only a tiny corner of their district's voters. This is also true of our Police districts, and we are right in the middle of several CBDs that we don't get a say in (West Soma, Civic Center, Castro).

Our neighborhood suffers because it's not always walkable. The freeway interchanges mean that traffic in the main streets in our neighborhood is often aggressive, and folks use small, neighborhood streets as cut-throughs to get around major thoroughfares. We exist where the high-speed road network intersects neighborhood streets, and that transition is jarring and dangerous, especially at intersections with narrow crosswalks, sight-lines limited by overpass columns, poor lighting, and sometimes even missing crosswalks altogether.

If we remain on the border of 4 supervisor districts, the freeway will continue to be a divider. It doesn't need to be! All streets are continuous underneath it, so it should be possible, under one supervisor's leadership, to be a steward of this area, keeping it interconnected. I would love to be able to walk (instead of drive) 3 blocks to Rainbow Grocery along Duboce and 13th St without feeling like I'm going to get run over, just inches away from speeding cars and freeway ramps.

The synergies between our emerging neighborhoods are clear and we need to move forward together as a recognized community of interest. For the many reasons above, we see Market Street as a natural separation or boundary. The street grid and mix of uses change markedly between north and south of Market Street. The neighborhoods North of Market are established. Although the issues there are acute and variable depending on specific blocks, there are many similarities in these established neighborhoods. The neighborhoods South of Market, by contrast, are either mostly industrial PDR areas transitioning to denser growth with a more diverse mix of uses, or – where the bulk of the growth has happened – are the former/current redevelopment areas and planning department areas cited above.

Within this context, we hope you see the clear synergies and needs for the joint advocacy that we have pursued for more than a decade - and need to continue going forward as a clearly defined community of interest. 

Potrero Hill, Dogpatch, and Showplace Square together have a history of common interests, dating back to the Industrial Age when many of the workers in the heavy steel and shipbuilding industries in Dogpatch, and the lighter industries in Showplace Square were staffed by workers living on Potrero Hill.

To the west, the longtime Latino enclave of the Mission has had a distinct culture and language. To the south, an industrial zone has largely separated the community from the more residential parts of Bayview and Visitation Valley.

Personally speaking, the people that I naturally meet on common concerns of interest such as bike and pedestrian safety, managing the rapid new development in the area, and greening this historically industrial part of the City reside on Potrero Hill and Dogpatch. This community in fact has a taxpayer funded greening entity --Dogpatch and Northwest Potrero Hill Green Benefits District (GBD). Residents of this community of interest straddling Potrero Hill and Dogpatch voted to raise their property taxes to fund streetside greening. They literally voted with their wallets to make this a community of interest. The northwest part of the GBD is just east of Potrero Avenue and south of 17th Street, straddling Highway 101, and that is why the freeway should not be used as the dividing line.

Potrero Avenue on the west is a natural dividing line between mostly flat Mission District and Potrero HILL. The bay on the east, and "population deserts" on the north and south by historically lightly populated industrial zones form a natural community of interest.

Community Location

Potrero Avenue on the west, San Francisco Bay on the east, roughly Cesar Chavez St. on the south, and roughly 16th St. on the north. Potrero Avenue on the west is a natural dividing line between mostly flat Mission District and Potrero HILL. The bay on the east, and "population deserts" on the north and south by historically lightly populated industrial zones form a natural community of interest.

Why Keep Together

The common interests, social bonds, and solutions to problems of those on a physical hill differ from the mostly flat SOMA and Mission districts. Working with one Supervisor is more effective when seeking action to solve problems and improve an area of common interests.

Potrero Hill itself has common interests and lifestyle as a mainly lower density

residential area that shares an identity and an active and interested citizenry for its interests, evidenced by the existence of the Potrero Boosters community organization. It should never be split.





Historically, Potrero Hill and Dogpatch have been linked as working class residential and industrial neighborhoods. Although the original character of the two neighborhoods has changed, they remain linked in many ways.

Our schools, parks, restaurants, and our single public library are utilized by residents of both Potrero Hill and Dogpatch.

Our public transit lines serve both communities. We have felt the importance of this link during the Covid-19 pandemic, when an important bus line was

discontinued, the #10-Townsend, linking Dogpatch with Potrero Hill and continuing to South of Market and the Financial District.

Health issues are a common thread for both Potrero Hill and Dogpatch, as we are surrounded by freeways and the rate of respiratory diseases, including asthma, is among the highest in California. We have just one public health clinic that serves both communities.

Our two neighborhoods have become much more aligned to the new neighborhoods just north of us in SOMA. While we live in Potrero Hill and Dogpatch, many of us work in SOMA. And many of the issues we face are like those of SOMA residents: increasing crime and lack of adequate security; encroaching homelessness and absence of creative ways for solving this dilemma; the expansion of UCSF into SOMA and Dogpatch; traffic and parking issues generated by the huge sports complexes; and inadequate transportation.


Community Location

I am proposing a new district that encompasses Potrero Hill, Dogpatch, and SOMA. It is bounded on the east and north by San Francisco Bay; on the west by Mission Street, the Central Freeway, and Potrero Avenue, and on the south by Jerrold Avenue, Napoleon Street, and Islais Creek. The proposed district (see attached map) incorporates all the criteria required by law. It keeps together historical Potrero Hill and Dogpatch and unites them with the vibrant tech/biotech hub of SOMA by merging the part of District 10 that includes our neighborhoods with the southeastern part of District 6 that includes SOMA. The proposed district has a population of 79,428, which is the goal population for a district minus 0.15%. The new district is ethnically diverse: 12.2% Hispanic, 38.6% White, 7.0% Black, 38.4% Asian, and 1.1% Multi-Racial.

Why Keep Together

Our community organizations, like the Potrero Boosters, the Dogpatch Neighborhood Association, and the Potrero-Dogpatch Merchant Association, have been linked for many years. Our community leaders look forward to working with leaders of SOMA neighborhood groups to confront common challenges we face in coming years. Examples of these include the rerouting of Caltrain, the potential truncating of I-280, the effect of climate change on sea and bay level rise; and the question of where to build both market rate and affordable housing in our district. SOMA, Dogpatch, and Potrero Hill need to have a common supervisorial district in the City & County of San Francisco to represent the very similar concerns of our neighborhoods.

NE Waterfront Neighborhoods - Community of Interest Statement

The first draft of the new district map, released on Friday, March 11, 2022, is a gerrymandered abomination. It filets our Potrero Hill - Dogpatch neighborhood right down its spine, lopping off part of our community east of Hwy 101, along with blocks north of 16° Street in Showplace Square. Our community leaders have forcefully argued for keeping Potrero Hill and Dogpatch together. However, I must respectfully ask if the redistricting commissioners were paying attention to the testimony our Potrero Hill and Dogpatch community representatives presented at the recent hearings on Zoom.

In my opinion, while the map submitted by our own community leaders recognizes the historic indivisibility of Potrero Hill and Diogratch, which is one of the necessary criteria, it does not meet the other requirements for an actual district. The criteria include near equal population compared to other districts, contiguousness, compactness, and representation of diverse communities.

Much has changed during the 36 years I have been a Potrero Hill resident. Our neighborhoods, including Dogpatch, have become much more aligned to the new neighborhoods north of us. While we live in Potrero Hill and Dogpatch, many of us work in SOMA. And many of the issues we face are like those of SOMA residents: increasing crime and lack of adequate security; encroaching homelessness and absence of creative ways for solving this dilemma; the expansion of UCSF; traffic and parking issues generated by the huge sports complexes; and inadequate transportation.

Both our Potrero Hill and Dogpatch community leaders and the members of the San Francisco Redistricting Task Force need to start thinking our of the box, so that we do not allow our Potrero Hill-Dogpatch community to become divided. To this end, using the redistricting map tool, I have designed a district that incorporates all the criteria listed above (see attached image). It keeps together historical Potrero Hill and Dogpatch and unites them with the vibrant tech/biotech hub of SOMA by merging the part of District 10 that includes our neighborhoods with the southeastern part of District 6 that includes

The new district I have proposed is both compact and contiguous, bounded by the northeastern waterfront, Mission Street in SOMA, the Central Freeway, Potrero Avenue, and Islais Creek. The population of this new district is 79,428 (goal population minus 0.15%) and it is ethnically diverse: 12.2% Hispanic, 38.6% White, 7.0% Black, 38.4% Asian, and 1.1% Mulh-Recial. I have given the new district a colorful nickname, "SOMA Pot Patch", which incorporates a bit of each of the names of its components, but it may be formally known as "Northeastern Waterfront Neighborhoods."

At the most recent Redistricting Task Force online hearing on Saturday, March 5, 2022, many leaders and community residents of the Visitacion Valley and Portola neighborhoods testified that it was important for them to have their neighborhoods AND Bayview included in one new supervisorial district. Our proposal to combine Potrero Hill and Dogpatch with 50MA in a new "Northeastern Waterfront Neighborhoods" district would serendipitously have the effect of supporting the aspirations of Visitacion Valley and Portola residents to combine with Bayview in one "Southeastern Waterfront Neighborhoods" district.



Please keep the high-density, mixed income waterfront neighborhoods of Embarcadero, Rincon Hill, South Beach, and Mission Bay together for the following reasons:

Our communities are significantly impacted by the Bay Bridge and Highway 280 traffic transitioning from 50 -70 MPH speeds to our high-density residential 25 MPH streets. Pedestrian safety infrastructure and traffic law enforcement are especially important in our neighborhoods.

Our communities rely upon good relationships between our Supervisor and the Port of San Francisco as our neighborhoods are adjacent to and include Port of San Francisco properties.

Our communities are significantly impacted by the regional event centers of Oracle Park and Chase Center or events like the San Francisco Marathon - adding to the traffic on roadways, utilization (or surges) on the public transit routes, and crimes of opportunity that 19,000 - 50,000 attendee events attract to our area.

Our communities have added thousands of units of below market rate affordable housing, but no new K-12 schools for the children of those families, very little in the way of new pubicly owned parks (mostly privately owned public open spaces like Yerba Buena Gardens, Salesforce Park, and the various office building smoker plazas). The desire and health need for public recreation and publicly owned parks unites us in Embarcadero, Rincon Hill, South Beach, and Mission Bay.

Our communities are subjected to second class consideration for Public Works cleaning services - forcing us to form our own Community Benefit Districts and charge ourselves a property assessment tax that is in addition to the tax we pay for funding Public Works in order to get the clean streets traditionally residential neighborhoods take for granted.

4th Street eastward south of Market Street and north of Mariposa Street more or less covers Embarcadero, Rincon Hill, South Beach, and Mission Bay.

Why Keep Together

Potrero Hill, Dogpatch and Showplace have worked together for almost 100 years. All have common problems of industrial land being converted to office, warehouse and residential use.

We have pollution from 2 freeways, high asthma rates and significant industrial pollution that needs to be remediated before development.

Transportation Plan for the Eastern Neighborhoods Plan was never passed by the Board of Supervisors. Only the development plan was passed in January 2009.

This has led to numerous gaps in transit and significant unfunded traffic safety issues.

Freeway commuters use our neighborhoods as a bypass to save a few seconds on their commutes. Leading to unsafe driving, injury and fatal accidents.

We are divided between three Police Districts (Mission, Bayview and Southern) leading to lack of coordination on traffic safety, public safety and crime issues.

Our area (Potrero Hill, Dogpatch and Showplace) are focused on development issues, traffic safety, public transportation, use of our neighborhood as parking lots for major developments like Chase Stadium, UCSF, Pier 70 (20th & Michigan), multiple Amazon warehouses (7th & Berry & 20th & Tennessee), Power Station (23rd and Illinois) and Mission Bay.

These developments impact our neighborhood with high speed commuters, traffic, vehicle pollution and large diesel trucks traveling on neighborhood streets

We are stronger if we are all in the same district to work with city agencies to address our concerns.

In the 1926 Potrero Boosters and Merchants bylaws defined the boundaries of association as:

For almost 100 years we have worked together to form a cohesive community. Spinning off the Dogpatch Association, Dogpatch & NW Potrero Hill Green Benefit District and Potrero Dogpatch Merchants Assn.

Our association helped develop the Showplace Parking plan about 5 years ago before there were many residents.

We also supported the new residents at 7th and King get a Residential Parking Program established.

The Sustainable Streets Committee that I co-chair with DNA Vice President is working on Traffic Safety and Traffic Calming for the entirety of Potrero Hill, Dogpatch and Showplace.

Just yesterday our team created a list of intersections in all the neighborhoods that need painted crosswalks in response to a request by the Eastern Neighborhoods CAC.

There were over 30 intersections with yellow access ramps and NO painted crosswalks. This effort will make disabled, seniors and young people safer when crossing streets.

Our team worked with the SFMTA, Bridge Housing and CARE San Francisco to find a solution for a high injury corridor in Potrero Public Housing on 25th St. that is currently being implemented by SFMTA.

We are also advocating for Traffic Calming by Starr King School at 23rd and Wisconsin.



We, the undersigned neighborhood organizations, are writing to express our support for the redistricting plan shown below for District 3: 1 This plan adjusts District 3: 8 boundaries by simply extending the existing western boundary of Van Ness northward all the way to the Bay. This approach incorporates the missing "noth" bounded by Van Ness, Union St, Jones-Columbus-Leavenworth, and the Bay into D3. The remaining boundaries of D3 are unchanged.

This plan is similar to the one previously submitted by the Barbary Coast Neighborhood Association, North Beach Neighbors, Russian Hill Neighbors and other signatory organizations. It meets the Task Force's redistricting criteria while offering significant benefits, which include:

- Uniting the Russian Hill neighborhood, which is currently split between D3 and D2. The Russian Hill Neighbors sent a letter to the Task Force on February 11 requesting a plan that unifies their neighborhood and combines it with their peer neighborhoods in District 3.
- Maintaining the integrity of existing neighborhoods (e.g., North Beach, Chinatown, Telegraph Hill, Russian Hill, Nob Hill, Polk Street, and Barbary Coast). This proposal does not create new splits in any neighborhood nor any new divisions in D3 racial/ethnic populations under the city charter.
- Meeting the district population requirement within 1% of "ideal." The population of D3 with the current boundaries is 72,474 or 8.9% below the ideal number of 79,545. By extending the northwestern boundary to Van Ness, D3's population would be 78,908 a mere 0.8% below the ideal.

San Francisco's neighborhoods are the foundation of the City.

Neighbors meeting neighbors, helping neighbors, addressing problems, opportunities and challenges as neighbors. This was the reason the Russian Hill Community Association was formed in 1992 – because a neighbor was threatened by a proposed development which would result in the loss of light in her apartment.

Concern spread from next door to across the street and then across several streets. Neighbors learned to read plans, understand Gity requirements, protocols and processes.

The end result was the <u>overturning of the developer's approvals</u> by the Planning Department, the Planning Commission and the Board of Appeals because the plans were found to be fraudulent. Neighbors helping neighbors.

San Francisco's neighborhood associations are the mortar that strengthens neighborhoods.

RHCA's original boundaries stretched from Leavenworth to Polk and from Union to Broadway. We worked with the 2010 Redistricting Task Force to make sure that RHCA would remain in one District. The Task Force's originally proposed boundary was ultimately moved from Green Street to Union Street to accommodate RHCA boundaries, acknowledging the nature of the RHCA and the role it played in the community.

Now our boundaries extend to other areas where neighbors need assistance, from Van Ness up to Jones and from Filbert over to Washington.

San Francisco neighborhood associations in the North-East Quadrant work together,

Over the years we've learned the importance of working with other neighborhood associations to better serve each of our own neighborhoods. In particular we are aware of the importance of maintaining and extending the ties of multigenerational Chinese on Russian HOII with Chinatown, supporting the community benefit districts along Polk Street and working with our Nob Hill neighbors to the south.

Re: Ellis Becomes Southern Border of D2 Between Van Ness and Gough

The Cathedral Hill area of San Francisco resulted from the SF Redevelopment Agency's 1958 decision to demotish a large area of Japantown and the Fillmore District to create a new residential neighborhood of mid rise and high rise housing.

The current neighborhood of Cathedral Hill is bounded by Van Ness Avenue, Fillmore Street, Sutter Street and Ellis Street. In 2013, the area between Laguna and Fillmore, Geary and Ellis was designated as part of the Japantown Historical Economic Sustainability Strategy (JCHESS) map. The remaining part of the neighborhood between Gough and Van Ness was split between D2 and D5 in 2012.

Almost sixty years later, Cathedral Hill has continued to expand high density housing, both in standard and senior assisted housing developments, from Van Ness Avenue to Gough Street, while the neighborhood contained in the JCHESS area has remained near its original population with no new residential developments.

We continued to add senior housing along this corridor after 2012, with the addition of the Coventry Senior Apartments on Sutter, the Coterie Senior Living on Van Ness, and the proposed new Martin Luther Senior Housing on Elis. They join the larger group of senior housing facilities on Cathedral Hil, including The Avenue, The Broadmoor, The Carlisle, the original Martin Luther Senior Housing and the Sequoias.

We believe there is a community of interest of senior residents who would benefit from being in the same Supervisorial District. As the CPMC California, Pacific and Van Ness hospital campuses are also in D2, we believe the senior residents in this Community of Interest would be better served by being part of District 2.

Therefore, Cathedral Hill Neighborhood Association (CHNA) supports the boundary of District 2 to be extended from Geary Boulevard to Ellis Street, including the western side of Van Ness, and both sides of Franklin and Gough Streets, and that the Sequoia's Senior Living at 1400 Geary Street be relocated from D5 to D2 as well.

This area was previously in D2 until redistricting in 2012, and by returning from D5 would add approximately 2,000 new residents to D2, which is currently underpopulated. Attached is the map submitted by the Van Ness Corridor Neighborhoods Council, which reflects these changes in the borders between D2 and D5.

The Van Ness Corridor Neighborhoods Council is a coalition formed in 2017 by established San Francisco neighborhood organizations that border on Van Ness Avenue from Lombard Street to Division Street. Mutual Interest

Our COI is the Japantown/Fillmore Western Addition. Japantown's borders are well established in two documents adopted by the San Francisco Planning Department and the Board of Supervisors. They encompass all of our important cultural organizations and institutions vital to the survival of our Cultural District and one of only three Japantowns remaining in the United States.

Japantown's COI, however, reaches beyond these borders and includes the Fillmore/ Western Addition with whom we share strong historical and physical connections, especially with the Black communities. Our bond stems from the shared experience of government exploitation and oppression, particularly through urban renewal of the Western Addition in the '60s and '70s, that decimated our communities and lives. As a result, there is an enduring partnership of solidarity, activism and coalition-building/allyship expressed through institutions such as Rosa Parks Elementary School, Japanese Community Youth Council, the Buchanan YMCA, that continues to define our shared identity.

Community Location

We would like to preserve the existing/current northern boundaries of D5, specifically California street to the north, which encompasses crucial cultural and historic assets and institutions in Japantown. Other important Japantown/Fillmore Western Addition institutions important to keep within the D5 boundaries are: Booker T. Washington Community Center at 800 Presidio; Japanese Community Youth Council at 2012 Pine St; Buddhist Church of San Francisco at 1881 Pine Street and its facilities along Austin Alley; Rosa Parks Elementary School campus at 1501 O'Farrell; and Buchanan YMCA/St; and St. Francis Square. We would support integrating boundaries that the Fillmore/Western Addition Community identifies as part of their specific boundaries as part of our COI to keep our communities connected in D5.

Why Keep Together

There are three key reasons to keep our COI intact in District 5.

1) Japantown and the Fillmore/Western Addition share a number of organizational and institutional initiatives. JCYC and its programming overlap with the goals and interests of organizations in the Western Addition, including Booker T. Washington. Millenial-led organizations such as Japantown For

Justice, have also catalyzed exciting new partnerships with Black community-based initiatives. There are also shared projects, such as the recently constructed crosswalk median at Buchanan and Geary, that involve and represent Japantown and the Fillmore/Western Addition. Keeping our shared COI together will support shared funding, advocacy, and implementation.

- 2) Both Japantown and the Fillmore/Western Addition are socially and economically vulnerable communities that support and advocate for one another. Keeping our shared COI intact in District 5 will strengthen the social and economic fabric of our community. Splitting/separating our communities would be destructive.
- 3) It would be unjust to tear apart our COI and subject us to further government-imposed trauma. Our COI has endured too much. Keeping Japantown/Fillmore Western Addition intact and whole is a matter of restorative justice and equity.

We believe that our very diverse community is here to stay and we love the vitality and creativity it brings. We also work with the neighborhood merchants on events, Haight Ashbury Merchant Association [HAMA].

"Although the Castro emerged as a gay neighborhood in the 1960s, the support it provided to LGBTQ people often was qualified by such limitations as socioeconomic status, race, age, and gender identity. Because Hayes Valley largely escaped the forces of gentrification into the 2000s, it offered less expensive housing and commercial spaces and retained a vibrant culture accessible to an LGBTQ population o[lesser means and greater diversity." (2019 BOS legislation for Castro LGBTQ Cultural District)

This community was actively discriminated against by those living in the Castro

because the group lived in a low-rent, high-crime area, that also included a unique commercial district. Conversely, in Hayes Valley, all residents were embraced regardless of racial/economic circumstances. Many endured the destruction of Hayes Valley and building of the Central Freeway, and years later many in this LGBTQ community became core organizers to remove the Central Freeway. This acceptance of all later became a part of the Hayes Valley Neighborhood Association (HVNA) bylaws and a core value in recognizing the need for affordable housing. This group worked tirelessly to assure that 50% of the former freeway parcels were dedicated to marginalized groups (TAY, developmentally disabled, formerly homeless) as well as general BMR housing.

Community Location

Our Community of Interest is mostly within the current Hayes Valley Neighborhood Assn boundaries (N on Webster from Haight, E on McAllister, S on Van Ness, W on Market, N on Buchanan, W on Waller, N on Fillmore, E on Haight to Webster, N on Webster) and includes the UC Regents site of 340 units at Alchemy Apts, Haight Street Art Center, a community garden and openhouse's LGBTQ Senior Housing at 55 Laguna.

Why Keep Together

Notably, the former Oak Hill Neighborhood Association, and the larger and ongoing Hayes Valley Neighborhood Association ("HVNA") included significant LGBTQ leadership since their formation. The HVNA took a groundbreaking position by stating a commitment to maintaining neighborhood diversity in its bylaws. LGBTQ people also had prominent roles in the campaign to demolish the Central Freeway after the 1989 earthquake and in the subsequent creation of Octavia Boulevard and Patricia's Green, as well as in advocating development of at least 50% affordable housing on parcels cleared by the freeway removal." (2019 BOS legislation for Castro LGBTQ Cultural District)

The need for LBGTQ-friendly elder housing was also important to this Hayes Valley LGBTQ community, particularly with many facing aging on a small fixed income. This community worked hard to see the new LGBTQ-friendly elder housing development at the 55 Laguna complex become a reality, as well as

ensuring it was a part of the larger neighborhood, not closed off as the developer had originally planned. Members of Hayes Valley Neighborhood Association fought hard for the inclusion of am significant number of BMR units in the large apartment complex, as well as for the low-income LGBTQ openhouse complex. Along with supporting the addition of the openhouse LGBTQ community, neighbors and members of HVNA also advocated for a neighborhood-serving community garden and neighborhood-serving community space which became the Haight Street Art Center, which has many connections in the neighborhood, especially with John Muir Elementary School and the students there. It is very important to recognize the role the HVNA community played in the establishment of the first in the nation LGBTQ-friendly senior supportive housing, and ensuring its inclusion into the larger neighborhood rather than treating it as a stand-alone (and thus isolated) institution.





What is your community of interest?

My community of interest is known as The Potrero. It includes Potrero Hill, the Design District, Dogpatch, and the Third Street Corridor, extending to the Central Waterfront.

If you take a tour of our community, you will note the many turn-of-the-century homes, historical nightlife venues, and light industrial warehouses dating back to the 1906 earthquake. But, you'll also be struck by the sheer number of new multi family apartment complexes, office spaces, and creative businesses—development largely driven by UCSF and a biotech hub to our North East.

Because of the rapid pace of change, residents have a unified voice in preserving the essential character of The Potrero, expressed through groups such as the Dogpatch Neighborhood Association and the Potrero Hill Boosters. In 2015 the community even established the city's first community benefit district devoted to carving out healthy green spaces in the public realm—the Dogpatch NW Potrero Hill Green Benefit District.

Our neighborhoods also have another huge challenge—that is, highways 101 and 280. The 101 has exits at Cesar Chavez, Vermont Street, and Seventh Street. The 280 has exits at Mariposa, 6th Streets, and King Street. Heavy traffic from large commercial vehicles as well as commuter cars must use this infrastructure to enter San Francisco. The easy entry and "getaway" provides the perfect opportunity to commit crimes in the City and flee at high speeds on our streets. Additionally, freeway overpasses promote illegal dumping and encampments, as well as the attendant sanitation and fire hazards.

Where is it located?

The Potrero Hill / Dogpatch COI is roughly bounded by Cesar Chavez Street, Potrero Avenue, Division Street, 7th Street, 16th Street, and the Bay.

Why should it be kept together?

The Potrero should be kept together in a single district so that it can continue to advocate, with the help of one supervisor, for responsible development. In regard to the blight caused by freeway infrastructure, we need one supervisor who can navigate the complexities of working with San Francisco social services as well as Caltrans and CA Highway Patrol to mitigate the impacts on residents.

Mutual Interest

Diamond Heights was developed by the former San Francisco Redevelopment Agency to be a model community. By design, the neighborhood was developed with market rate single family homes, condominiums, rental units and 641 units of HUD subsidized affordable rental housing. In 1981, Casa De Vida was built with 21 affordable HUD subsidized rental units for mobility challenged persons. Diamond Heights is unique to the City with its broad range of economic diversity. It is a neighborhood of single-family homes and condominium complexes distinguished by its distinctive, mid-century architecture. The community is served by the Diamond Heights Community Association, a neighborhood organization organized in the 1960's when the San Francisco Redevelopment Agency created Diamond Heights. The Agency mandated that planning in the neighborhood be coordinated with the neighborhood organization.

The DHCA has 800 people on its email list. Announcements inform residents of resources, candidates forums, community issues, events and safety concerns pertaining to Diamond Heights. The DHCA is a member of the Coalition for San Francisco Neighborhoods. We are a neighborhood with high voter turnout and civic engagement.

Community Location

The Diamond Heights community of interest is as follows: Clipper Street west from Douglass Street to Portola Drive; Portola west to O'Shaughnessy Boulevard; O'Shaughnessy southwest to Bosworth Street; Bosworth east to Elk Street; Elk north to Sussex Street; Sussex east to Bemis Street; Bemis northeast to Miguel Street; Miguel northeast to Beacon Street; Beacon northwest to Harry Walk; Harry Walk northeast to Laidley Street; Laidley northwest to 30th Street; 30th west to Castro Street; Castro north to Valley Street, Valley west to Diamond Street: Diamond north to Duncan Street; Duncan west to Douglass Street; and Douglass north to Clipper Street.

Why Keep Together

Over time, the DHCA has developed a strong, working relationship with the D8 supervisor on important issues facing the district, be that crime prevention, traffic safety, recreation, parks, and more. The synergies the DHCA has developed would be lost or significantly reduced if all or a portion of Diamond Heights were removed from D8 to D7 and the voice of Diamond Heights at City Hall would be diminished. Diamond Heights has many issues in common with its D8 neighbors, Noe Valley and Glen Park. It is cut off from D7 by Glen Canyon Park, which forms a physical barrier to the west.

In 1926, 94 years ago, the Potrero and Dogpatch communities saw the need to have a community association that represented the interests of residents and businesses.

The Potrero Boosters are the third oldest neighborhood association in the City.

For almost 100 years we have worked together to form a cohesive community. In spite of our communities being bisected by two freeways (101 & 280) in the 1960's and our steep geography.

Organizations helped by Potrero Boosters in their formation as our neighborhood grew were:

- The Dogpatch Neighborhood Association (DNA)
- Dogpatch North West Potrero Hill Green Benefit District (GBD)
- Potrero Dogpatch Merchants Association (PDMA)

We all work together for the benefit of our Potrero and Dogpatch community with the neighbors, businesses, City Agencies and State Agencies.

The Sustainable Streets Committee that I co-chair with DNA Vice President Donovan Lacy works on Traffic Safety and Traffic Calming for the entire Potrero & Dogpatch area.

Recently, our team worked with the SFMTA, Bridge Housing and CARE San Francisco to get support from SFMTA to implement a solution to an unknown Vision Zero high injury corridor in Potrero Public Housing on 25th St. It had 2 fatalities and 6 injury accidents in under three years.

Projects of the Dogpatch / Potrero Sustainable Streets team benefit the Dogpatch / Potrero community.

- Safer intersections program to improve pedestrian safety & visibility
- Permanent Minnesota Slow Street in Dogpatch
- 18th St. Neighborhood Commercial District Traffic Calming
- Safer 17th Street bike route
- Traffic Calming installations in Potrero Hill, Potrero Public Housing and Dogpatch where we coordinate & track annual application process by impacted blocks

- North South Bike route (Bayview to SOMA)
- Traffic Calming at Potrero Community Health Center & Starr King School at request of School Principal and community leaders in Potrero Public Housing

The 1926 bylaws defined the boundaries of the Potrero Boosters and Merchants Association now known as the Potrero Boosters Neighborhood Association:

- Potrero Avenue on the west
- 16th Street on the north
- San Francisco Bay on the east
- Cesar Chavez St (formerly Army St. in 1926)on the south

These boundaries today describe

- Potrero Hill
- North West Potrero Hill (Potrero Ave., Utah St. & San Bruno St.)
- Potrero Public Housing

There is not a community wide association for the residences in Showplace Square (South of Division; west of 7th St to Potrero Ave.)

Potrero Boosters have members and help the residential occupants with Planning Dept. issues and SFMTA traffic / parking issues impacting their homes .(e.g. proposed Amazon Warehouse is just one of many issues)

Why Keep Together

We are a diverse community of all income levels that work together for the benefit of our overall neighborhood and the City.

The organizations I have mentioned and many others work for the benefit of the entire Potrero / Dogpatch community.

People depending on their interests serve groups mentioned by me and other community groups. Many people are officers of more than one community organization focused on common issues;

- Schools
- Parks and Recreation
- Public Safety and Crime reduction
- Sustainable Streets (my focus)
- Converting old industrial land into usable space for recreation
- Neighborhood Commercial District improvements on 18th, 20th and 22nd St.
- Food Distribution (SF Food Bank, CARE -SF and other community groups)
- Clean up of waterfront and Islas Creek (DNA and GBD lead these efforts)

I got involved in the Potrero Hill community when I moved here in 1979. Many of us worked for years on the multiple plans for Mission Bay. I Co-Chaired the original Potrero Hill Mission Bay committee in the 1980's.

The Potrero Boosters and Dogpatch Neighborhood Assn. were the lead community intervenors at CPUC regarding shutting down the old polluting power plant at Potrero

that was causing significant air pollution for our neighborhood and our neighbors in Bayview / Hunters Point.

We worked with our Bayview neighbors on issues like our assistance to the community CPUC intervenors on shutting down the old polluting Hunters Point power plant. Today we now all enjoy Heron Head Park instead of a polluting power plant.

A City & developer paid Aerial survey in 1998 referred to all of Dogpatch as an 'Industrial Wasteland" that should be torn down. A few years later the Dogpatch Historic District was created in much of the same area.

The Potrero Boosters, Dogpatch Neighborhood Association and Bayview leaders created a plan document over many months from 1998 to 2001 on our views for Eastern Neighborhood development..

This set of documents described how our City could use what Supervisor Sophie Maxwell said "I'm not for banning, I'm for planning," (SF Business Times 10/22/2001).

The final January 2009 Eastern Neighborhood Plan used the ideas and philosophy from that early community developed document. The goal was to help both Communities and Developers know the guidelines for the Eastern Neighborhoods.

Recently Potrero Boosters and Dogpatch supported our District 10 neighbors for the 15 3rd Muni Rapid Bus to get Bayview residents downtown faster than the slow T Third line.





Mutual Interest

Before World War II, there were over 80 Japanese and Japanese American communities across the country, at least 40 in California alone. Today, San Francisco Japantown is just one of three remaining communities in the U.S. (the others are San Jose Japantown and Little Tokyo in Los Angeles). Egregiously racist government policies such as the wartime incarceration of 120,000 Americans of Japanese ancestry in remote desert prison camps and the City's damaging use of eminent domain and evictions as part of "redevelopment" and "urban renewal" projects are responsible for the destruction of the Japanese American community. In both cases, Japanese American families and businesses were forcibly removed and largely uncompensated, impoverishing not only families and businesses, but entire communities, for decades. San Francisco Japantown has weathered these impacts and remains home to businesses, churches, community centers, social service agencies, schools, senior facilities reflecting the diversity of Japanese culture and tradition. Japantown was the very first City-designated cultural district.

Furthermore, Japantown collaborates closely with the Western Addition and Fillmore Districts, especially the Black communities, based on a shared history of resilience in the face of institutional racism. For example, the Black and Japanese communities have worked closely together at the Buchanan Street YMCA, the Booker T. Washington Community Service Center, and the Japanese Community Youth Council, just to name a few of the many agencies promoting collaborations. These strong ties remain today and continue to shape the lives of countless youth and individuals. During the pandemic, the Japanese American Religious Federation, a consortium of faith leaders, has partnered with African American/Black faith leaders in the Western Addition to create a new

initiative called "We Are One" which has been recognized by Mayor London Breed.

Community Location

Please see the attached map with highlighted borders. This map has been formally adopted by the City & County of San Francisco as part of the Japantown Cultural Heritage and Economic Sustainability Strategy (JCHESS) (approved by the San Francisco Planning Commission and the Board of Supervisors in 2013), and reinforced by the Japantown Special Area Design Guidelines (approved by San Francisco Planning Commission in 2019). The boundaries are as follows.

- 1. Northern boundary: California Street between Steiner & Gough.
- 2. Western boundary: (1) Steiner between California & O'Farrell, (2) Fillmore between O'Farrell & Ellis.
- 3. Eastern boundary: (1) Gough between California & Geary, (2) Octavia between Geary & Ellis.
- 4. Southern boundary: (1) O'Farrell between Steiner & Fillmore, (2) Ellis between Fillmore & Octavia,
- (3) Geary between Octavia & Gough.


We look to community leaders in the Western Addition and Fillmore District, especially the Black communities, to determine their boundaries which we will strongly support.

Why Keep Together

Despite our resilience, Japantown is a vulnerable community. As a result of the pandemic, many businesses have closed and tourism has plummeted. It is absolutely essential that the existing Cityadopted boundaries of Japantown be honored so that Japantown can survive and thrive for many generations into the future. It is also vitally important that Japantown's historic and cultural ties with the Western Addition and the Fillmore District, especially Black communities, be protected and they, too, are vulnerable. In many varied ways, these communities contribute to the cultural life and diversity of San Francisco and sustain its world-class status.



For those of us back on Potrero Hill and the south slopes, we recreate at Potrero del Sol, Heron's Head, and Warm Water Cove. It's an under the radar slice of the city that's maybe not intuitive until you look at a bus map (and topography). We need to stay connected to our little micro-neighborhood of "the hill and where it spills". If you want a community school, we have Starr King and Bryant which are the best to bike, walk or bus to. We have a bit more housing density back here than the many single family homes just north of us, and we will continue to increase in density with the Rebuild so we aren't worrying about diminishing parking because we are more into buses, bikes, walking and trains. So we go where the buses go, and where the walker finds the path of least resistance.

Community Location

Its a small slice of the city that follows the (pre-pandemic) path of the 48/19/10 buses as they run along the backside of Potrero Hill on 26th, connecting this highway bound area to itself and to the city. For streets, this COI is from about 22nd St down to Islais channel, bound on the West by Potrero Ave and to the east, by the bay.

Why Keep Together

We are more closed off to the North by topography beyond the Rec Center. To the south, Cesar Chavez is dangerous to cross on foot with the light at Connecticut being one of the few spots. To the east the 25th street foot bridge is unlikely to open back up. That pushes both buses and residents to use 23rd street where it crosses the 101 as a corridor to the city to the west. To the east, the Rebuild Potrero project is tying the area from the bay to the hill even more tightly together.



Mutual Interest

Our mutual interest is sustaining the Buchanan Mall in the Western Addition as a whole. It is a community area whose roots are recovering from the harm of the Redevelopment Era that wiped out 2 communities: African American and the Japanese families, their businesses, and their support organizations that were eliminated. Community Green Spaces, accessible by various communities, were part of the overall plan when the Buchanan Mall was designed as part of Redevelopment in the 1960's and 70's. Part of the Mall extends into Japantown, where Ruth Asawa's sculpture is a centerpiece of the cobblestone mall area

The Buchanan Mall community of interest includes a wide group of interested

partners who want to re-establish neighborhoods and communities, j including the Hayes Valley Neighborhood Association, faith-based groups, schools, Ella Hill Hutch Community Center, Western Addition residents (elders, children, and families, some who have been born and raised in the Western Addition) who live nearby, artists and designers from across the city and Bay Area, and activists who have returned to the WA. The Citizen Film organization, led by Sophie Constantinou, has been one of the lead organizations, recruiting locals and finding others, some who were formerly incarcerated that have created new businesses, that support the activation of the Mall, creating new jobs, building lives, and new wealth for the community at large.

Community Location

The Buchanan Mall is the former Buchanan Street between Geary Street and Grove Street in the Western Addition. While the Mall is a single street, its impact radiates to the residents who live east to Van Ness and west to Divisadero.

Why Keep Together

Dividing this Mall and separating the residents who experienced the Redevelopment cultural catastrophe into different Districts is a continuation of the harm done in the 1960's and 70's. The Buchanan Mall must remain as part of the Western Addition community and its common experience of cultural and racial inequity as their homes were demolished and not replaced.

Citizen Film began engaging with the community surrounding the Buchanan Mall south of Geary Street about 5 years ago to redesign the green space and reactivate it for the benefit of all. A combination of recovered memories and future visions, expressed in new visual art, and sustainable green spaces with newly designed permanent lighting is now beginning construction, block by block. Significant community engagement has been done and funding is now in progress for the new Buchanan Mall. Maintained by SF REC and Park Department, the department and the Rec and Park commission has approved



By including all of the HUB (which is part of the Market/Octavia Better Neighborhood Plan https://sfplanning.org/market-street-hub-project) within D5, HVNA can positively impact the new developments to be sure that the new residents will be a part of the community and not isolated in high-rise towers above the street. **See the attached map, the red area circled.** Here is a link to the HUB general plan https://generalplan.sfplanning.org/Market-and-Octavia-Area-Plan 2020-Update.pdf Our community of interest is well informed on the issues within the HUB and how the new developments may negatively intensify or negatively create anew.

Currently, the HUB is segmented into 4 supervisorial districts: D5, 6, 8, and 9. This community has found it difficult to bring all 4 supervisors together to form a coherent group to achieve common goals of creating a new community within the HUB. We believe 1 supervisor (D5) should be responsible for the HUB. Our community of interest has initiated efforts to comment/influence/support the HUB development (though only part of the HUB lies within D5) to include more green space, community accessible space at street level, include more and safe forms of transit, and avoid car traffic logjams that currently exist in the HUB and have yet to be addressed by developers and SFMTA. The HUB is a part of the Market/Octavia Plan (https://sfplanning.org/market-octavia-area-plan) In addition, creating more affordably priced housing is a priority for this community, so there will be equal access for new living spaces. We believe there is new opportunity to create new communities within the HUB, and HVNA can positively influence the final outcome.

The SF Mid-Market neighborhood is a high-density mixed-use community located in the heart of the city. Perhaps San Francisco's most uniquely diverse neighborhood, Mid-Market includes three of San Francisco's eight cultural districts: SOMA Pilipinas, Compton's Transgender, and Leather and LGBT. The resident population of Mid-Market is broadly diverse across race/ethnicity, educational background, and income level. Our community includes a large mix of both families who have lived in the neighborhood for decades and newer arrivals from all over the globe. Affordable housing buildings, SROs, market-rate housing, and condo buildings are nestled together alongside a wide range of commercial activity and government offices. This is partly because Mid-Market is a regional transit gateway, anchored by two BART and three MUNI Metro stations. As a result, the neighborhood sees intense foot traffic and commuter density each day. Mid-Market is also home to a large volume of supportive services, with people on both sides of Market street regularly accessing these services. Mid-Market also holds a unique place among other neighborhoods in SF as the social and cultural heart of the city. The community is home to a high concentration of cultural venues and regularly hosts many

large social events, celebrations, and protests attended by San Franciscans from every corner of the city.

But despite sitting in the heart of SF, Mid-Market is plagued by an enduring humanitarian crisis. Large public squares and corners in the neighborhood are dominated by open-air drug markets and street vending of stolen goods. Sidewalks are covered in loose trash, feces, broken glass, and needles. Random acts of violence, rampant property crime, and overstretched SFPD and community ambassadors mean that residents, commuting workers, and visitors to Mid-Market alike are regularly assaulted, robbed, and killed. It's no surprise then, that most people avoid walking the streets of Mid-Market after dark.

But the homeless residents of Mid-Market have it the worst of all. City services in Mid-Market are overstretched and underfunded, so many living on the street have trouble getting the addiction counseling and mental health care they so desperately need. And unlike the housed residents of Mid-Market, homeless residents have no refuge from the danger on the streets. They are regularly assaulted, exploited, and trafficked by the drug dealers and criminal syndicates operating on the streets of Mid-Market.

All those who live and work in Mid-Market are united in their desire to live in a safe, inclusive, and vibrant neighborhood. The community desperately needs larger investments in SFPD and community ambassador programs to ensure an end to open-air drug markets, fencing of stolen goods on sidewalks, and rampant violent crime. Residents of Mid-Market are uniquely proud that their neighborhood hosts such a large volume of supportive services, but want to see larger investments in city services to ensure that no one goes without care. Without large investments in public safety and supportive city services, Mid-Market's pressing humanitarian crisis will never be resolved.

Why Keep Together

To resolve the pressing humanitarian crisis in Mid-Market, large-scale investments in city services are needed. In order to achieve those investments, Mid-Market needs to be able to speak to a single SF Supervisor who understands the broader situation across the whole neighborhood. If the neighborhood is cut up and placed in several different districts, the Supervisors with smaller parts of Mid-Market in their district will have little reason to devote attention and energy to the issues facing those areas. Why would they? They'll have many different neighborhoods in their district to compete for their time. Ensuring Mid-Market is kept whole in one Supervisorial district is the only way to ensure that the neighborhood gets the attention and help it so desperately needs.

Additionally, the Mid-Market neighborhood should be kept whole because it is unique in SF for its diversity. Our community is home to people who live in every kind of housing type, people of every educational background and income level, both long-time residents and new immigrants from all over the world. All of us are hurt by the current conditions in our community—all of us want change. Our diversity of experience and perspective is our biggest strength, and we want to be kept together.



It is located between Potrero Avenue and the Bay, north of Cesar Chavez and Islais Creek, and South of Division, Townsend and Seventh, 16th or Mariposa (to the east of 280).

Why Keep Together

Historically, the Potrero District consisted of Potrero Hill, Dogpatch and Irish Hill. Development along the shore has caused the future to mirror the past. The neighborhoods face the same transportation issues, the same development issues, the same need for public facilities, the same policing issues, and so on. Residents in these neighborhoods work together, and families are part of the same school communities. They share common neighborhood and merchant groups. A management district for open space assess taxes and managed open space in Dogpatch and Northwest Potrero. The area suffers the impact of Caltrans and works to solve issues related to both the 101 and 280 corridors. Over COVID 19, a virtual holiday scavenger hunt took residents across the whole of the area. They are a single community with different neighborhood flairs.
