1. Call to Order and Roll Call

The Redistricting Task Force met in special session, in-person with remote access and public comment via telephone and videoconference, on Saturday, April 2, 2022. Vice Chair Ditka Reiner called the meeting to order at 10:10 a.m.

On the call of the roll, Member Jeremy Lee, Member Hernández Gil, Member Pierce, Member Castillon, Member Ho, Member Cooper, Member Chasel Lee, and Vice Chair Reiner were noted present. Chair Townsend was noted not present.

A quorum was present.

Chair Townsend was noted present at 10:24 a.m.

2. Mapping

Member Chasel Lee provided a presentation on mapping and public input, including an overview of the redistricting process, important criteria for redistricting, recognized neighborhoods and communities of interest, compactness, contiguity, census geography, and the next steps for the Task Force. Ana Flores, Deputy City Attorney (Office of the City Attorney); shared concerns about the Final Map deadline for the Task Force. Jaime Clark, Redistricting Consultant (Q2 Data and Research); answered questions raised throughout the discussion.

Speakers: Geoffrea Morris; endorsed the 4D map and offered opposition to the 4A 4B and 4C maps as pertains to District 10.

Richard Rothman; requested that the Task Force divide Golden Gate Park more evenly between supervisorial districts, and requested that the Task Force not include the Seacliff of Presidio Terrace neighborhoods in District 1.

Speaker; endorsed the 4D map.

Oscar James; endorsed the 4D map as pertains to the District 10 boundaries.

Cheryl Thornton; defined the area of Potrero Avenue, 16th Street to the bay waterfront, Highway 101, Mansell Avenue to Bayshore Avenue, Geneva Avenue, Potrero Hill, Bayview Hunters Point, and Sunnydale as a community of interest, along with Jackson Park, the 3rd Street corridor, the Sunnydale Recreation center, the 4 HOPE SF sites and the Chase Center, and requested that the Task Force retain this community of interest wholly within District 10.
