


Dear Vice President Cindy Elias and San Francisco Police Commissioners:

Summary of Complaints Received in March 2022


The Department of Police Accountability received **53** cases in **March 2022**, compared with **63** cases in the same period last year. The **March 2022** case total is **5%** lower than the five-year average and **16%** lower than the previous year.

From January through March, the DPA received a total of **159** new cases, compared with the **200** cases filed during the same period in 2021. The March year to date case total represents a **21%** decrease in new complaints over last year.





Most complaints were received over the phone and online.



Please find the attached table, which summarizes cases received in **March 2022**. The table is prepared in compliance with San Francisco City Charter section 4.136 and Police Commission Resolution number 97-04, which require the Department of Police Accountability (DPA) to provide the Police Commission with a monthly summary of cases received, including the number and type of complaints filed.
