### **4. Review and Approval of Surveillance Technology Policy: Non-City Entity Cameras (Action Item)**

Asja Steeves and Deputy Chief David Lazar presented the changes to the policy on Non-City Entity Cameras on behalf of the Police Department.

Jillian Johnson summarized a letter submitted to COIT and the San Francisco Police Chief on March 30<sup>th</sup> from the Electronic Frontier Foundation (EFF) and ACLU of Northern CA. The letter objected to the approval of the Police Department's policy as presented to PSAB on March 25<sup>th</sup>.

Public comment was given.

Mike Makstman made a motion to approve the policy for COIT's review under the condition that SFPD amend the policy to prohibit live monitoring of cameras within residences and consider clarifying the policy definitions and use cases where appropriate, per the EFF/ACLU letter. Guy Clarke seconded. Mike Makstman, Guy Clarke, Michelle Littlefield, Mark de la Rosa, and Jillian Johnson voted to approve the policy to move forward to COIT with the recommended amendments. Taraneh Moayed and Nnena Ukuku abstained from the vote. The motion passed to be reviewed in the next COIT meeting.
