Director Tang provided updates regarding two merchant walks to inform businesses about ABE/accessibility grants, the recent OEWD grant to provide rent relief which received over \$11 million in funding requests. \$2 million will be rewarded to a total of 160 businesses.

Commissioner Carter said SF Black Wall Street has a new incoming cohort of black entrepreneurs. Vice President Zouzounis noted that Polk merchants have been discussing a bar's change of use to allow offsale alcohol and the impacts that it may have on other liquor stores. Also wanted to get more information about SF's restaurant meals program and EBT accessibility to businesses. How can the City better support?
