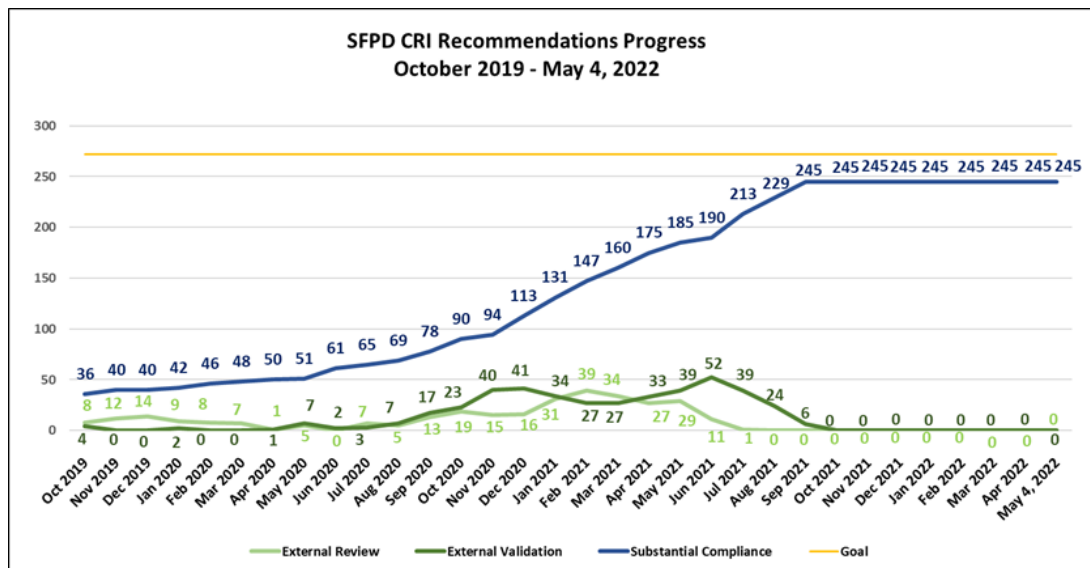

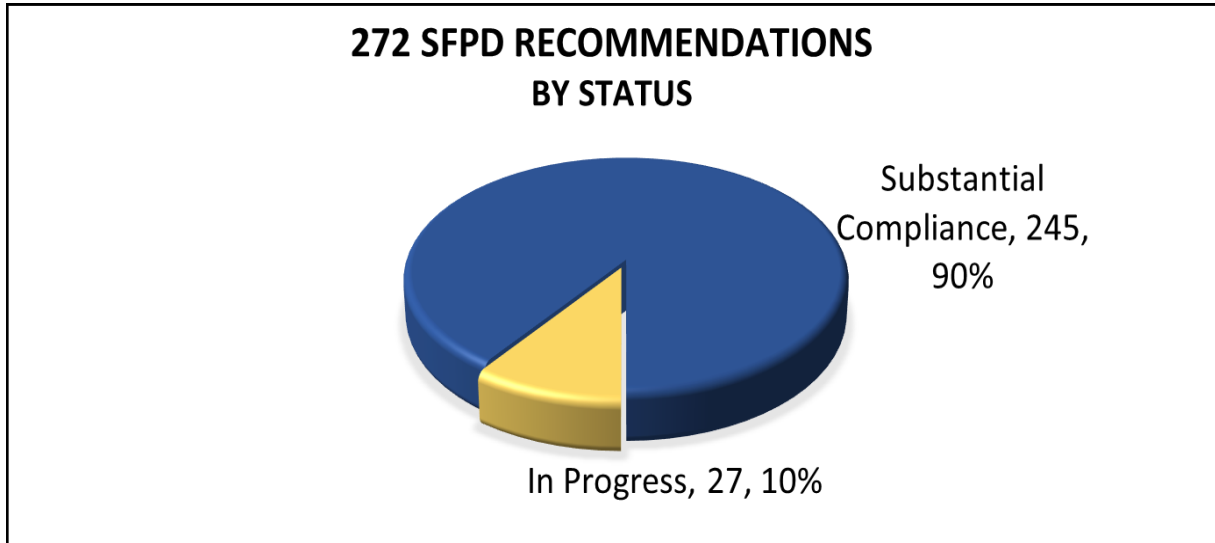

Collaborative Reform Initiative: Overview



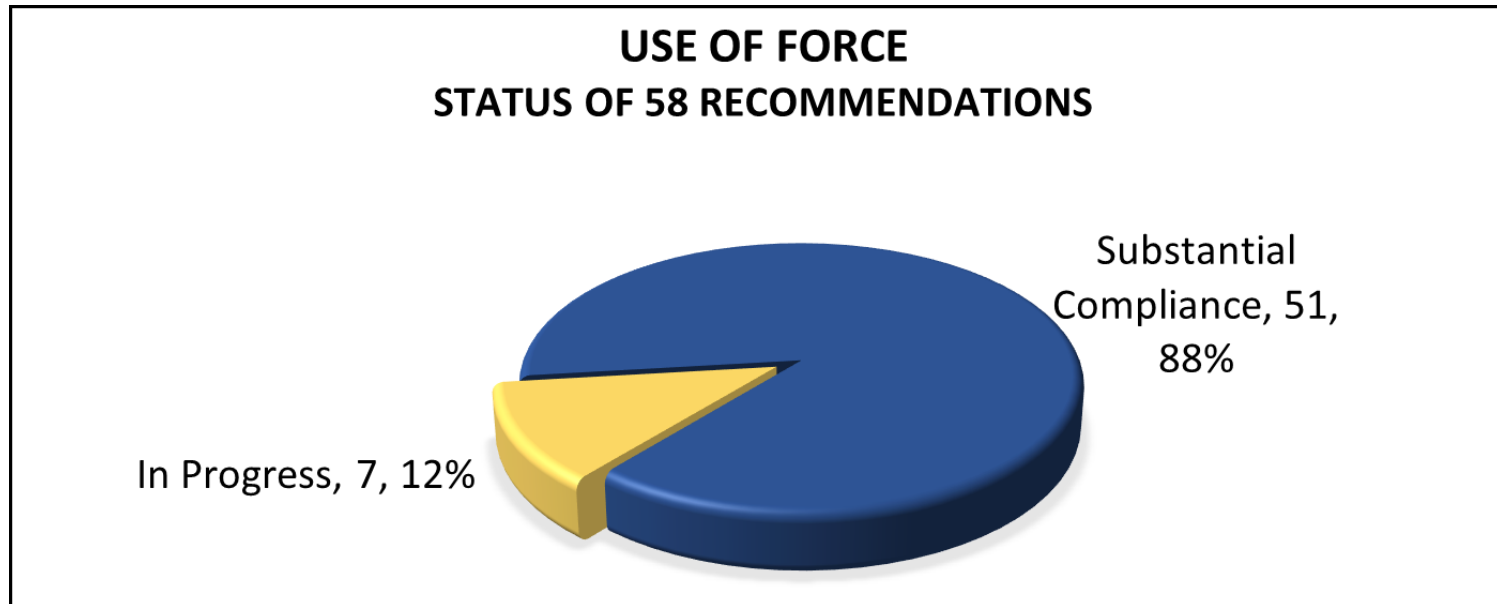
Terms	Definitions

External Review	Recommendation submitted to Hillard Heintze for review.
External Validation	Recommendation submitted to CAL DOJ for review.
Substantial Compliance	Recommendations determined to meet compliance measures.

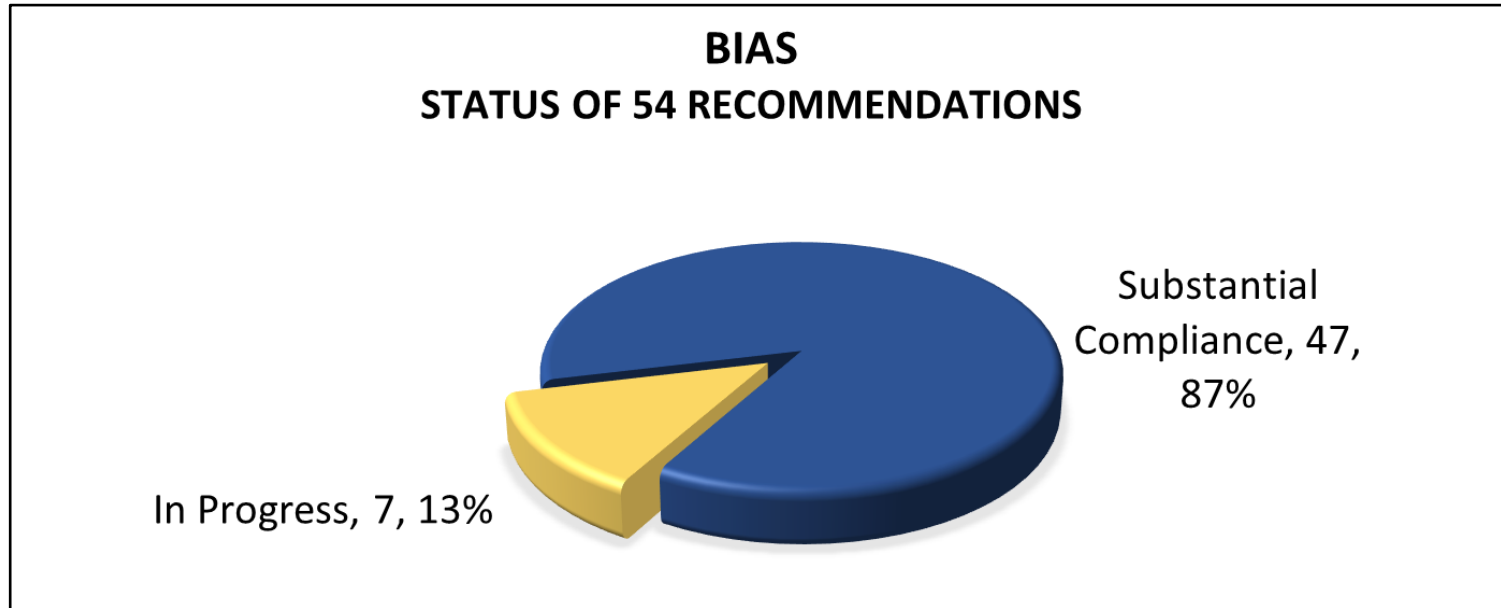

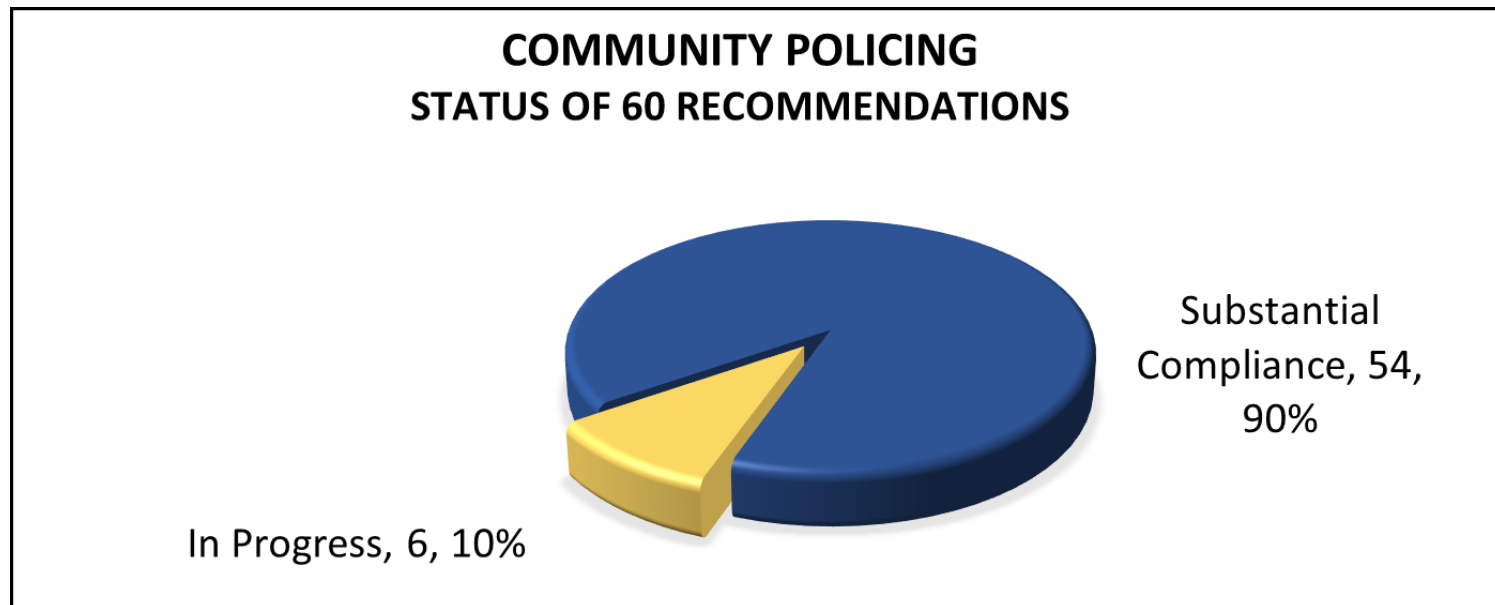

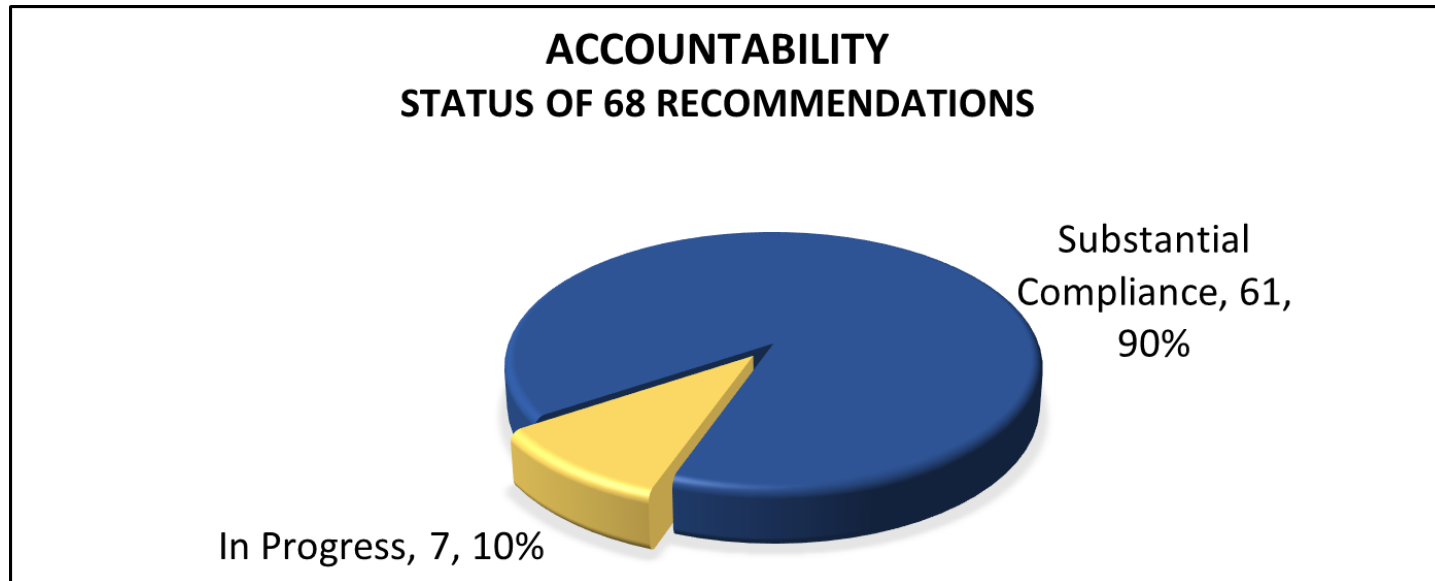

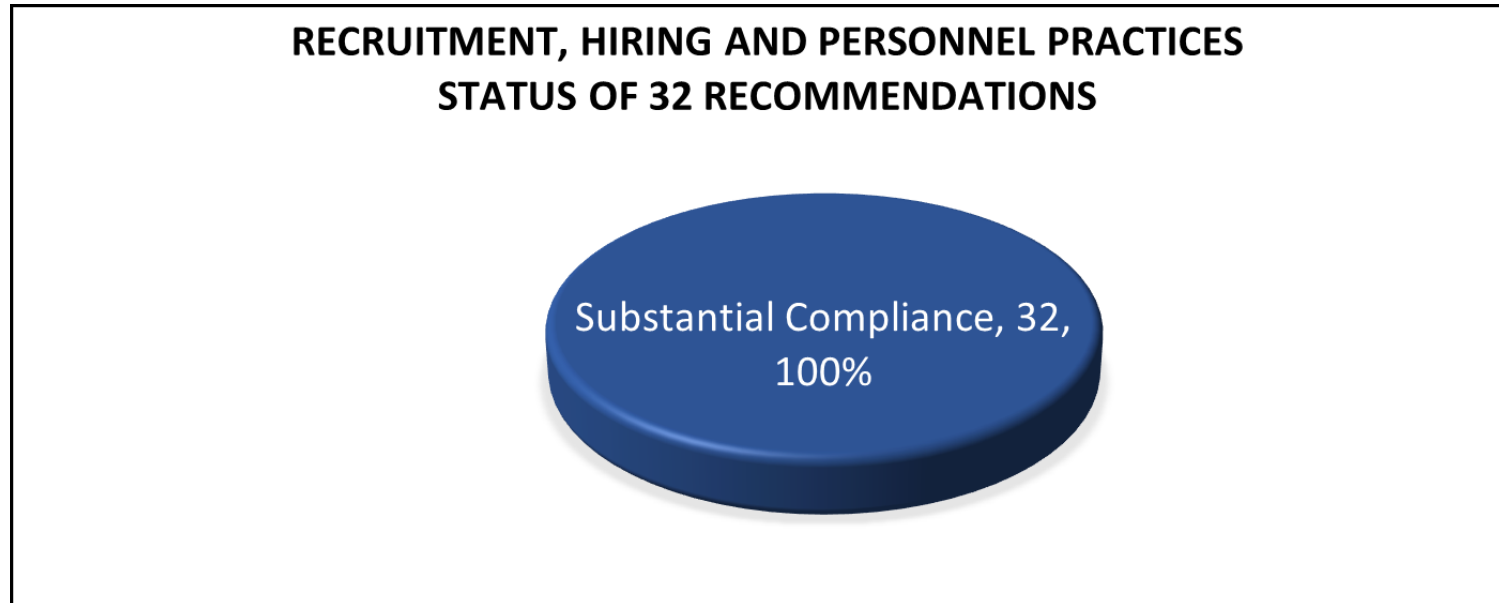

Recommendations Beyond Phase III

- **Within 12 months**
(1.1, 20.4, 26.1, 40.6, 48.1, 55.2, 69.2, 69.3)
Examples:
 - Demographic report for discipline
 - Chief's advisory forum meetings
- **Within 18 months**
(48.2, 39.1, 22.1, 68.1, 79.1, 79.2, 79.3)
Examples:
 - Strategic plan alignment
 - Use-of-Force data collection and analysis
- **Two years**
(40.2, 41.1, 21.1, 28.1, 28.4, 28.5, 30.3, 30.4, 35.3)
Example:
 - Use-of-Force enhanced data collection plan and implementation
 - Dashboard Review System (DRS) implementation
- **3-4 years**
(20.1, 20.2, 20.3)
Example
 - Arrest data and consistency across agencies
 - Record Management System implementation
