SAN FRANCISCO SUPERIOR COURT ANNOUNCES APPOINTMENT OF CRISTEL M. TULLOCK AS NEW CHIEF OF ADULT PROBATION

SAN FRANCISCO - The San Francisco Superior Court today announced the appointment of Cristel M. Tullock as the new Chief of Adult Probation, capping more than two decades of a steady rise at the agency.

Tullock, previously served as the acting chief deputy of the department prior to the retirement of Karen Fletcher last year, and she has been a key figure at Adult Probation, representing it on key issues with the court's justice partners, the Board of Supervisors, the Mayor's Office and other state and national agencies.

The SFAPD is recognized for its effective community support strategies and innovative reentry services. The Adult Probation Department supervises approximately 6,000 clients on court-ordered supervision, diversion programs and post release community supervision. It is an integral part of the City's criminal justice system, providing court services, supervision and a large portfolio of reentry services, housing, and support for all currently and formerly justice involved individuals. The department supports 50 treatment programs and 18 housing programs that are managed by community partners through the Community Assessment and Services Center (CASC).

"I am proud to be the new Chief of Adult Probation," Tullock said. "This will give me the opportunity to apply my 22 years of experience and rich personal perspective to this key leadership position." Under my leadership, I will ensure that the department maintains its strong reputation and that we continue to be an active positive contributor to supporting the community and our courts.

"The focus on criminal justice reform is an opportunity for probation to demonstrate our critical role in helping people restore their lives," Tullock added, "because probation is distinguished by the balanced approach it applies to social justice, social work and law enforcement."

Tullock is the first African American adult probation chief.

"The court congratulates Cristel Tullock as the new Chief of Adult Probation," said the Presiding Judge Samuel K. Feng. "We look forward to working with her and her department."

Tullock, who started her career at the agency as a deputy probation officer, has also worked as a psychotherapist, a coordinator overseeing the reentry of sexually violent predators, and has developed multiple programs including two schools in partnership with Five Keys Charter Schools. She has also represented the department on several interagency committees and has led and developed a number of key initiatives.

"My diverse life experiences as a mother with children attending public schools, a first-generation African-Latina, a lesbian, and a former high school dropout sit at the center of my drive to help people make sustainable life changes," Tullock said. "These personal experiences have broadened my perspective and contributed to my success."

Tullock starts in her new role beginning today.

New Mayoral Appointees for the Reentry Council

Antonio Napoleon

Antonio Napoleon was born in San Francisco in 1983, raised in the Mission District and went to school at Sacred Hearts. He was raised by his mother, but influenced by his father to be part of the 24th Street gang. Antonio started gang banging and using drugs at 14 years old and ultimately ended up in jail when he was 18. Because he was placed on the Mission Street gang injunction, Antonio was arrested and went to jail many times. He went to prison when he was 19 years old and was released when he was 27 years old. Antonio went to treatment five times before he was able to maintain consistent recovery time. He has not used drugs or alcohol for over 3 years and is currently employed at the Positive Directions TRP Academy as a Case Manager. Antonio is committed to his community and helping people like himself make the changes necessary to live and thrive.



Allen Harven (Puff)

Allen Harven was born in San Francisco in 1975, grew up in the Western Addition and went to school in the Fillmore. When Allen lost his mother at 11 years old, he was put into foster care. At 14 years old, he ran away from his foster care placement and began living on the street. He was first arrested at 16 years old and spent the next few years going in and out of jail. Allen first went to prison in 1998 on drug charges and then went in and out of prison for the remainder of his twenties and most of his thirties. During this time, he continued to use drugs. After going to treatment 4 times, Allen finally got clean in 2015 and has been clean and sober ever since. Today, Allen works as a Case Manager at the Positive Directions TRP Academy and he and his wife are raising his sister's son. He is determined to ensure that his nephew has a stable home life – something he did not have as a child. Allen's commitment to change and to helping people in the community is evident in all he does.



**RESOLUTION MAKING FINDINGS TO ALLOW TELECONFERENCED
MEETINGS UNDER CALIFORNIA GOVERNMENT CODE SECTION
54953(e)**

WHEREAS, California Government Code Section 54953(e) empowers local policy bodies to convene by teleconferencing technology during a proclaimed state of emergency under the State Emergency Services Act so long as certain conditions are met; and

WHEREAS, In March, 2020, the Governor of the State of California proclaimed a state of emergency in California in connection with the Coronavirus Disease 2019 (“COVID-19”) pandemic, and that state of emergency remains in effect; and

WHEREAS, In February 25, 2020, the Mayor of the City and County of San Francisco (the “City”) declared a local emergency, and on March 6, 2020 the City’s Health Officer declared a local health emergency, and both those declarations also remain in effect; and

WHEREAS, On March 11 and March 23, 2020, the Mayor issued emergency orders suspending select provisions of local law, including sections of the City Charter, that restrict teleconferencing by members of policy bodies; those orders remain in effect, so City law currently allows policy bodies to meet remotely if they comply with restrictions in State law regarding teleconference meetings; and

WHEREAS, On September 16, 2021, the Governor signed AB 361, a bill that amends the Brown Act to allow local policy bodies to continue to meet by teleconferencing during a state of emergency without complying with restrictions in State law that would otherwise apply, provided that the policy bodies make certain findings at least once every 30 days; and

WHEREAS, While federal, State, and local health officials emphasize the critical importance of vaccination and consistent mask-wearing to prevent the spread of COVID-19, the City’s Health Officer has issued at least one order (Health Officer Order No. C19-07y, available online at www.sfdph.org/healthorders) and one directive (Health Officer Directive No. 2020-33i, available online at www.sfdph.org/directives) that continue to recommend measures to promote physical distancing and other social distancing measures, such as masking, in certain contexts; and

WHEREAS, The California Department of Industrial Relations Division of Occupational Safety and Health (“Cal/OSHA”) has promulgated Section 3205 of Title 8 of the California Code of Regulations, which requires most employers in California, including in the City, to train and instruct employees about measures that can decrease the spread of COVID-19, including physical distancing and other social distancing measures; and

WHEREAS, Without limiting any requirements under applicable federal, state, or local pandemic-related rules, orders, or directives, the City’s Department of Public Health, in coordination with the City’s Health Officer, has advised that for group gatherings indoors, such as meetings of boards and commissions, people can increase safety and greatly reduce risks to the health and safety of attendees from COVID-19 by maximizing ventilation, wearing well-fitting masks (as required by Health Officer Order No. C19-07), using physical distancing where the vaccination status of attendees is not known, and considering holding the meeting remotely if feasible, especially for long meetings, with any attendees with unknown vaccination status and where ventilation may not be optimal; and

WHEREAS, On July 31, 2020, the Mayor issued an emergency order that, with limited exceptions, prohibited policy bodies other than the Board of Supervisors and its committees from meeting in person under any circumstances, so as to ensure the safety of policy body members, City staff, and the public; and

WHEREAS, the Council has met remotely during the COVID-19 pandemic and can continue to do so in a manner that allows public participation and transparency while minimizing health risks to members, staff, and the public that would be present with in-person meetings while this emergency continues; now, therefore, be it

RESOLVED, That the Reentry Council finds as follows:

1. As described above, the State of California and the City remain in a state of emergency due to the COVID-19 pandemic. At this meeting, the Reentry Council has considered the circumstances of the state of emergency.
2. As described above, State and City officials continue to recommend measures to promote physical distancing and other social distancing measures, in some settings.

3. As described above, because of the COVID-19 pandemic, conducting meetings of this body and its committees in person would present imminent risks to the safety of attendees, and the state of emergency continues to directly impact the ability of members to meet safely in person; and, be it

FURTHER RESOLVED, That for at least the next 30 days meetings of the Reentry Council and its committees will continue to occur exclusively by teleconferencing technology (and not by any in-person meetings or any other meetings with public access to the places where any policy body member is present for the meeting). Such meetings of the Reentry Council and its committees that occur by teleconferencing technology will provide an opportunity for members of the public to address this body and its committees and will otherwise occur in a manner that protects the statutory and constitutional rights of parties and the members of the public attending the meeting via teleconferencing; and, be it

FURTHER RESOLVED, That the secretary of the Reentry Council is directed to place a resolution substantially similar to this resolution on the agenda of a future meeting of the Reentry Council within the next 30 days. If the Reentry Council does not meet within the next 30 days, the secretary is directed to place a such resolution on the agenda of the next meeting of the Reentry Council.

Victoria Westbrook started the meeting by introducing Interim Chief of Probation, Sharon Jackson.

Chief Sharon Jackson gave a quick introduction about herself and work experience.

1. Call to Order and Introductions (discussion only)

Jabari Jackson, representing the formerly incarcerated members, called the meeting to order. He thanked Council members and members of the public for attending the meeting. He acknowledged the other five Co-Chairs: I would like to start by acknowledging the five other co-chairs:

Victoria Westbrook completed Reentry Council Roll Call, and gave a quick update on Zoom functions and the chat options for Public comments.

Jabari Jackson asked if anyone had a public comment:

5. Review and Adoption of Meeting Minutes of July 22, 2021

Jabari Jackson asked for a motion to adopt the minutes from July 22, 2021.

Karen Roye made a motion.

Sheenia Branner seconded the motion.

Motion passed.

6. Validation of the PSA in San Francisco Presentation – Johanna Lacoe, Research Director, California Policy Lab, UC Berkeley (discussion only)

During our last Reentry Council Meeting, questions and concerns were raised regarding the Pre-trial validation report published by the California Policy Lab. David Mauroff from Pre-trial Diversion agreed to present information about the report and the validation findings at this meeting. The full slide presentation can be found in the Public packet beginning on page 12. Johanna Lacoe, the Research Director from the California Policy Lab, UC Berkeley was introduced and invited to present.

Johanna Lacoe presented about the Validation of the Public Safety Assessment (Pretrial) Tool in San Francisco. There was a robust discussion about what was presented. Members of the council and public were concerned that 55 out of 100 people who were released pretrial reoffended during the pretrial period and that 18/100 of the group reoffended with a violent crime. Johanna emphasized that the report was about the validity of the PSA tool and not about Pretrial Diversion’s public safety rating or the practices of Pretrial Diversion. David Mauroff of Pretrial Diversion emphasized that the public safety assessment is just a tool that provides information to the courts. It is ultimately the courts who decide who gets released pretrial. Additionally issues were raised about the racial bias present in the PSA tool and questions about how it could be fixed or calibrated surfaced.

7. Staff Report on Activities of the Reentry Council and its Subcommittees (discussion & possible action).

Jabari Jackson asked Victoria to give council members an update on the San Francisco Reentry Council and Subcommittees.

Victoria provided an update about the Mental Health Transitional Housing program. The program continues to be successful and at capacity.

Victoria Westbrook invited Steve Adami to speak about the San Francisco Fair Chance Ordinance.

Steve Adami stated that the San Francisco Fair Chance Ordinance dictates that the look-back period for an employer to review felony convictions is seven years. However, the City and County of San Francisco review felony convictions dating back thirteen years as a government employer.

Steve Adami and Michael Brown from the reentry council brought up the Fair Chance Ordinance issue with the human rights commission. Steve Adami stated that they connected with Dorsey Nunn, a driving force behind the Fair Chance Ordinance. Steve also stated that he is also working with the San Francisco Mayor's Office who is now working with DHR to make the changes made internally through the civil service commission. An update on the Fair Chance Ordinance change will be made hopefully announced during the next reentry council meeting.

Steve Adami introduced Cedrick Akbar to speak about the Positive Directions T. R. P Academy.

Cedrick Akbar provided an update about the TRP academy, an abstinence based, therapeutic teaching community program. During the first month of the program 40 student were enrolled and 83 referrals were received. For referrals please go to [TRP Academy | CASC Reentry Center \(reentrysf.org\)](https://reentrysf.org).

People can self-refer into the program.

Steve Adami provided an update on the Reentry stabilization Navigation Center that will be launched in partnership with THC and Westside Community Services. The proposed site is at 245 11th ST. However, there are some zoning challenges. In the meantime, the program is launching in an SRO hotel with licensed clinicians on-site with 24-hour access. People in the justice system will be prioritized into the program. This navigation center will allow clients to stay till they get to the next step in life with no time limit. The Adult Probation Department is leveraging half a million dollars to launch the program. Our City Our Home funded the staffing for the site.

Victoria Westbrook provided an update on Subcommittee activities.

- Victoria Westbrook, Jabari Jackson, and Yolanda Morrisette provided a presentation about the Reentry Council at the Virtual Reentry Resource Conference Hosted by the Archdiocese of San Francisco.
- The Legislation, Policy, and Practices Subcommittee did a mini training on the California Legislation process. The plan is to have a more proactive approach by inviting community based organizations and different advocacy groups into the meeting in January in preparation of the identification of bills to bring before the Reentry Council in April 2022..

- The Direct Services Subcommittee is moving forward with the housing survey.
- During the Women 1st Subcommittee meeting, Community Forward SF presented on their Women Center project. Information is provided in the public packet on page 28. Additionally, Laura Murray, one of the people highlighted in the Rebound Documentary shared her remarkable story with the subcommittee members. Rebound is about two women who were able to rebound from incarceration, addiction, and abuse through the pursuit of higher education.

8. Regular Update on Activities of the Juvenile Justice Coordinating Council, Sentencing Commission, Collaborative Courts, and Community Corrections Partnership, STARR (discussion only).

- Chief Miller from Juvenile Probation provided an update on the Juvenile Justice Coordinating Council. The main activities of the council are one of its subcommittees charged with getting a plan of what San Francisco is going to do with juveniles now that they will no longer go to DJJ and the DJJ will be closed. If anyone would like to follow these efforts, all meetings are public and occur every other Tuesday from 4pm – 6pm. The next meeting is November 9th. The Juvenile Probation website has meeting archive information and links for all future meetings.
- Robin Candler provided an update on about the STARR program. STARR is working on getting people into residential treatment and low threshold case management.
- Tara Agnese provided an update on the Community Corrections Partnership realignment report. Outreach has been done to the members of the CCP for input and additional feedback. A draft report will be submitted before presenting it to the board of supervisors.
- Karen Roye provided an update about the San Francisco Sentencing Commission meeting on September 21st. Staff reported updates regarding the Safety and Justice Challenge, noting that the jail population is increasing. Partners are working to understand and address the issue. SJC fellows, five community leaders with lived experienced of the system, have developed conclusions from their participatory action research on expanding diversion options. Their recommendations will be given at the October SJC meeting. Representatives from the California Police Lab shared their initial analysis regarding people who experienced frequent contact with the criminal justice and public health systems in San Francisco. One key finding is that over 96% of those with highest use of both systems had experienced homelessness. The California Policy Lab will be continuing their analysis and will create a policy brief in the next few months. The next meeting of the San Francisco Sentencing Commission will be on December 14th at 10am.

- Victoria Westbrook provided an update on the Criminal justice Racial Equity Workgroup. The next meeting will be held on November 18th. Marisa Arrona will work with the group to formalize our mission, values, and action items for the coming year. There will be three strategy meetings. Victoria Westbrook invited people to join the group.
- Sabrina Shumake from APD provided an update about the internal and external racial equity initiatives within the Adult Probation Department. We concluded our SAMHSA Community of Practice opportunity, focusing on Diversity, Equity, and inclusion in reentry services and provided intensive technical assistance. The APD Community of Practice team included nineteen members from the reentry community, most of which were people of color and those who were formerly incarcerated. The technical assistance provided an opportunity to explore service delivery outcome measures other than recidivism rate. Internally, APD is working on implementing their racial equity plan. Additionally, they are identifying racial equity training for the department and sharing recommendations with department leadership.
- Sherriff Paul Miyamoto reported that 200 people have completed their cultural humility classes.

Who we serve

- People who have been arrested without being convicted of a crime
- People who have been convicted of a crime
- People who were sentenced to probation – both those who successfully completed and those who were unsuccessful
- People who were sentenced to county jail
- People who served time in prison
- People whose convictions are affecting their immigration status
- People who committed crimes as victims of human trafficking
- People who are required to register as sex offenders
- **Generally, the arrest or conviction must have occurred in San Francisco (some exceptions)**

Who we cannot serve

- People who are currently on probation or parole in any county, though we may be able to help some people terminate probation early in SF
- People who were arrested, charges have not been filed, but the statute of limitations has not run
- People who have no arrests or convictions in San Francisco (some exceptions)

When in doubt, fill out an application!

- Many people may not be sure whether they qualify so **err on the side of applying**
- If they don't qualify, we will contact them to let them know why, and whether they may qualify at some time in the future
- **The majority of clients will not need to come to court.** We will appear in court for clients and send them documentation of their expungements
- We may need to collect documents from clients, including declarations by the client about the nature of the offense – **it is important to collect as much contact info as possible**

HISTORY & MISSION



The Public Defender's Office, under the leadership of Jeff Adachi, recognized a need to focus on youth and community building in order to prevent young people from being clients of the Public Defender.

Mobilization for Adolescent Growth in our Communities program ("MAGIC") was therefore co-founded in 2004 by the Public Defender's Office and leaders of Bayview Hunters Point community-based organizations ("CBOs") to address and improve the quality of life of Bayview Hunters Point children, youth, and families.

In 2006 MAGIC expanded to serve the Fillmore District and Western Addition communities, forming Mo'MAGIC, with B'MAGIC serving Bayview-Hunters Point (together, the "MAGIC Programs").

Collective Impact Model

Following a collective impact model, the MAGIC Programs operate as “backbone support organization[s],” identifying gaps in the system and empowering community partners to address their needs.

BMAGIC hosts a monthly meeting with BVHP CBOs to build in accountability and transparency in our collaborative work, formalize partnership and honor our collective vision.

Meetings are hosted on the 3rd Tuesday of every month from 1pm-3pm, online via Zoom.

On average, we host 50 organizations per meeting.

MoMAGIC meetings are held twice a month, on the 1st and 3rd Thursday from 11am-12pm online via Zoom.

There are 4 subcommittees that meet once a month - Social, Health & Wellness, Education and Sports.
On average, we host 40 attendees per meeting.

Beginning this year, BMAGIC and MoMAGIC will host all MAGIC meetings to build & strengthen partnerships in Bayview, Fillmore and across San Francisco.

To date, MAGIC programs have hosted a total of 650+ Convener Meetings.

COVID RESPONSE

When the COVID-19 Pandemic hit San Francisco in 2020, the MAGIC Programs and our partners immediately mobilized to provide aid and resources to the residents of Bayview and Fillmore communities.



BMAGIC launched the Out of School Time Programs Committee in partnership with 22 CBOs & City agencies. We partnered with SFDPH's City-Wide Holiday Giveaway to help 5,000 families receive donations.

We opened our doors to 3rd Street Youth Center & Clinic's Food Distribution to assemble 1,200 food bags. We created a COVID-19 Resource List in our Community Calendar to help those affected by COVID-19.



MoMAGIC partnered with SFUSD and Simply the Basics to distribute 25,000 hygiene kits.

We partnered with BMAGIC & Alliance for Period Supplies to distribute 380,000 menstrual supplies.

We also partnered with Collective Impact to distribute 500,000 PPE Supplies.

In addition, we also distributed 7,500 undergarment donations.

Every August, MAGIC programs offer children & youth ages 5-18 new backpacks filled with school supplies.
