
#### Re: San Francisco Department of Police Accountability April 2022 Monthly Statistical Report

Dear Vice President Cindy Elias and San Francisco Police Commissioners:


### **Summary of Complaints Received in April 2022**

The Department of Police Accountability received **64** cases in April **2022**, compared with **66** cases in the same period last year. The **April 2022** case total is **8%** higher than the five-year average and **3%** lower than the previous year.

From January through April, the DPA received a total of **223** new cases, compared with the **266** cases filed during the same period in 2021. The April year to date case total represents a **16%** decrease in new complaints over last year.

Most complaints were received over the phone and online.

The table is prepared in compliance with San Francisco City Charter section 4.136 and Police Commission Resolution number 97-04, which require the Department of Police Accountability (DPA) to provide the Police Commission with a monthly summary of cases received, including the number and type of complaints filed.
