


Summary of Complaints Received in May 2022

The Department of Police Accountability received **59** cases in **May 2022**, compared with **68** cases in the same period last year. The **May 2022** case total is **3%** lower than the five-year average and **13%** lower than the previous year.

From January through May, the DPA received a total of **282** new cases, compared with the **334** cases filed during the same period in 2021. The May year to date case total represents a **16%** decrease in new complaints over last year.

Most complaints were received over the phone and online.
