### SIGNIFICANT BULLETINS/NOTICES ISSUED:

- 22-008 [Traffic Citations Involving LIDAR/RADAR](#); The purpose of this notice is to inform members of how to correctly complete citations involving LIDAR/RADAR to avoid the invalidation of traffic citations.
- 22-009 [Find Assigned Investigator](#); The purpose of this notice is to inform members of a new feature in Crime Data Warehouse ("CDW").
- 22-010 [Domestic Violence Radio Suffix Code](#); The purpose of this notice is to remind members of requirements around radio code usage and domestic violence incidents.
- 22-014 [Include Case Numbers in Social Media and Other Communications About Cases](#); Members shall include the SFPD case number (whenever available) for all social media posts and other public-facing messages about cases, including newsletters, news releases, or statements.
- 22-020 [Robbery Investigation Protocols](#) (**Superseded**); The Robbery Unit is responsible for the investigation of most robbery cases. While the Robbery Unit may not handle every robbery case, they will review all robbery reports and consult with the OIC of other department investigative units to determine the most appropriate investigative unit.
- 22-024 [2022 Legislative Updates](#); *The following legislative updates are meant as a summary of changes to the law. For exact language, please refer to the specific code section referenced.*
- 22-026 [Updated Data Collection for Use of Force and Firearm Drawn/Exhibited](#) (**Supersedes DB 18-171**); The purpose of this Department Notice (DN) is to mandate the use of electronic entry for Supervisory Use of Force Evaluations and Firearm Drawn/Exhibited data collection. This DN also outlines the technical procedures for completing the Supervisory Use of Force Evaluation and Drawn/Exhibited Firearm data collection to comply with the latest revisions to DGO 5.01 - *Use of Force and Proper Control of a Person.*
- 22-027 [Reporting Suspicious Activity "See Something Suspicious Say Something Specific"](#); Members shall review Department General Order 8.10 First Amendment Activities to ensure any/all effort(s) made to gather and document information is within policy.
- 22-029 [DPA Complaint Log](#); SFPD Form 599 (Rev. 03/22) is used to track complaints received at District Stations from members of the public against on-duty SFPD officers (DGO 2.04 Complaints Against Officers).

- 22-031 [Obtaining a Public Safety Statement at an OIS or OID](#); A Public Safety Statement is information obtained by a supervisor using questions intended to determine existing threats to public safety and identify transitory evidence that must be preserved.
- 22-032 [Robbery Investigation Protocols](#) **(Supersedes DN 22-020)**; While the Robbery Unit may not handle every robbery case, they will review all robbery reports and consult with the OIC of other department investigative units to determine the most appropriate investigative unit.
