1) CALL TO ORDER

2) APPROVAL OF THE MINUTES OF THE HEALTH COMMISSION COMMUNITY AND PUBLIC HEALTH COMMITTEE MEETING OF JULY 19, 2022 MEETING

3) CENTER FOR PUBLIC HEALTH RESEARCH: SHINE STRONG PROGRAM

Sean Arayasirikul, Ph.D, Trans Research Unit for Equity, Center for Public Health Research, presented the item.

Commissioner Comments:

Commissioner Giraudo asked the end date for the project funding. Dr. Arayasirikul stated that funding will end in 2025. He noted that the team has worked on sustainability of the project. The team plans to apply for a renewal in 2024 so there is no gap. The original grant began in 2020.

Commissioner Chung stated that she is proud of this project. This is something that does not exist elsewhere in the world.

Hali Hammer, MD, Director of SFHN Ambulatory Care, presented the item.

Commissioner Giraudo asked if there will be increased space for services targeting children and youth in the renovated Southeast Health Center. Dr. Hammer stated that the Southeast Children's and Family Therapy Center will be moved to Southeast Health Center and will be expanding services as part of this move. She also stated that there is integrated behavioral health services in all DPH primary care clinics.
