6. Redistricting Process Initiative

Commissioner Dai provided a summary of documents in the meeting packet.

Speaker Gwenn Craig, former Chair of the San Francisco Elections Task Force, provided <a href="https://historical.com/historic

Commissioner Dai asked Ms. Craig if there was any preference on the Task Force among the four plans. She said that it was left up to the voters.

President-elect Jerdonek asked Ms. Craig if the task force model used thirty years ago, when Ms. Craig served, could be used again today.

VP-elect Shapiro asked a question about the choice of eleven districts: in 2022 does it meet the same representation needs that it met thirty years ago?

Ms. Craig responded that people were not amenable to change.

Speaker Alesandra Lozano, California Common Cause's (CCC's) Voting Rights & Redistricting Program Manager, gave her presentation via WebEx. She provided a

brief background on how CCC monitored 60 jurisdictions in the past redistricting cycle at the local level. She compared and contrasted other local redistricting bodies in the Bay Area and the rest of the state, noting that San Francisco is an outlier in onboarding commissioners. Commissioner Bernholz asked if their data shows budgets by jurisdiction and jurisdiction size for comparison purposes, and Ms. Lozano agreed to follow-up with this information.

President-elect Jerdonek asked if there are any recommendations on what parts of City government should run the applicant selection process to ensure that it is apolitical. Ms. Lozano replied with some example non-partisan entities. President-elect Jerdonek asked if the same criteria could be used for selecting members of a city charter commission.

Commissioner Dai stated the focus for the next meeting planned for September.

Public Comment

David Pilpel asked if the presentations of both speakers could be made available in written form.

Lauren Girardin commented on the exchange regarding the number of supervisors: have any jurisdictions established when the number of council members should change?

7. Review of the June 7, 2022 Consolidated Statewide Direct Primary Election Director Arntz said the biggest challenge was that over one hundred poll workers came down with COVID and that it spread to office personnel. Despite that, he felt the election was conducted in a free, fair, and functional manner.

VP-elect Shapiro asked what guardrails are in place for Election Day incidents. Director Arntz explained the processes that should take place when there is adverse behavior between polling place inspectors and other poll workers.

Commissioner Dai asked about the relative number of ballots received after the 7-day deadline versus a late postmark. Director Arntz said that all envelopes are tracked, even prior to Election Day.
