Committee Reports

- Legislative Committee
 - Chair Jason Chittavong reported the Legislative Committee voted to present two items for the Commission's consideration:
 - Legislative Committee be set at a maximum five-member body.
 - The VAC re-instate a Rules Committee
 - President Mansori thanked Commissioner Chittavong for the report. She noted committees will be discussed later in the meeting under Unfinished Business. At that time the two items presented by the Legislative Committee will be discussed.
- Communication and Events Committee
 - o Chair Nicholas Rusanoff stated the committee had no report at this time.

Supervisor Liaison Reports

- District 1: Sup. Chan Commissioner Bullard
 - o No report Commissioner Bullard absent.
- District 2: Sup. Stefani Commissioner Miller
 - o No update as reported by Commissioner Miller.
- District 3: Sup. Peskin Commissioner McDonald
 - o No report Commissioner McDonald absent.
- District 4: Sup. Mar Commissioner Barnickel
 - Commissioner Barnickel thanked the group for their work on the affordable housing for veterans legislation. He noted it was a two year effort and stands out as a great achievement in the 40+ year history of the VAC.
 - Mentioned three projects in progress in District 4: one on Irving Street, another near the Great Highway, and one near SF Zoo. All will include affordable housing for veterans.
 - Update regarding VA Hospital: Last month, Commissioner Barnickel and Supervisor Mar presented three retiring nurses with Certificates of Honor from the Board of Supervisors.
- District 5: Sup. Preston Commissioner Chittavong
 - Spoke with Supervisor Preston and scheduled monthly meetings with the supervisor and his legislative aide. Commissioner Chittavong noted the supervisor has past experience working directly with veterans in need of housing.
- District 6: Sup. Dorsey Commissioner Rusanoff
 - Commissioner Rusanoff recently met with Supervisor Dorsey at a fundraising event.
 He noted the supervisor voted in favor of BMR legislation. Will be in monthly conversation regarding veterans issues in District 6.
- District 7: Sup. Melgar Commissioner Chan



- No update Commissioner Chan reported he had planned to meet with the supervisor at an event, but event was cancelled. Scheduled to meet next month.
- District 8: Sup. Mandelman Commissioner Dacumos
 - O Have been in conversation with Supervisor Mandelman about SB9, but noted SB9 was recently vetoed by the Mayor. Commissioner Dacumos further noted she is pursing efforts to have Filipino veterans of WWII honored during the month of October for Filipino heritage. President Mansori suggested this topic be discussed later in the meeting under the Unfinished Business agenda item.
- District 9: Sup. Ronen Commissioner Miller
 - o No update as reported by Commissioner Miller.
- District 10: Sup. Walton Commissioner Ellington
 - O Working with Supervisor Walton's staff to schedule a speaking engagement for the supervisor at a veterans community awards gala. Commissioner Ellington further noted she will need to connect with Commissioner Rusanoff about a dental college in Supervisor Dorsey's district that has offered free screenings during Veterans month.
- District 11: Sup. Safai Commissioner Bullard
 - o No report Commissioner Bullard absent.

UNFINISHED BUSINESS

- Supervisor/Commissioner Liaison Review [Discussion]
 - President Mansori began by noting there are two commissioners representing more than one district each, with Commissioner Bullard reporting for Districts 1 and 11; and Commissioner Miller for Districts 2 and 9. She asked if commissioners without a liaison assignment will volunteer to take a district. After discussion, Commissioner Wong agreed to take over as liaison for District 2.
 - President Mansori thanked Commissioner Wong, and added the commission will
 continue to check in on liaison assignments and make changes as appropriate. She
 concluded by asking for any further comments or suggestions regarding liaison
 assignments. As there were none, the meeting moved to the next agenda item.



• Committees [Discussion]

- o Communication and Events Committee President Mansori requested the committee hold its first meeting before September 13, and set a recurring meeting schedule.
 - Communication and Events Committee Chair Nicholas Rusanoff confirmed the committee will meet before the end of August.
 - Commissioner Dacumos commented that Fleet Week events will be discussed at the August 12 meeting of the SF Council. She will bring updates to the committee. She further commented on the possibility of having the Congressional Gold Medal for Filipino veterans in conjunction with Filipino heritage month of October. President Mansori recommended Commissioner Dacumos bring this topic to the attention of the Legislative Committee, and the committee bring it to the next commission meeting for a vote. President Mansori noted the time constraint in getting this done before October, as the VAC meets on a monthly basis. With that in mind, she can step in as commission president to move things along at a faster pace, however the preference is the process begin with the Legislative Committee.
 - President Mansori asked for any further comments related to communication and events. Commissioners Barnickel and Ellington shared details of veterans events upcoming in the next few months; noting events are not sponsored by the VAC, but will be of interest to the veterans community. President Mansori thanked the commissioners and requested they email event details to the VAC secretary. She acknowledged there are several commissioners who work with veterans non-profit organizations, and stated that while the VAC cannot endorse such events, information can be published on the VAC website for community awareness and engagement.
- O Legislative Committee President Mansori clarified expectations of the committee, and stated the correct title is "Legislative and Rules Committee." As a non-chartered commission, the VAC does not publish or write policies, the commission only advises. As such, the Legislative and Rules Committee can work on bylaws and veterans issues legislative work. President Mansori continued by saying the structure of committees is a work in progress, as administrative support and the commission structure evolve. The plan is to eventually create separate committees.
 - Commissioner Chittavong thanked President Mansori for the clarification, and followed up on the committee's request to become a five-member body. President Mansori advised submitting this as an actionable item for the next commission meeting agenda.
 - President Mansori opened discussion about placing limits on number of committee members and creating additional committees.
 - Commissioner Ellington requested clarification on items voted on by committees. President Mansori responded that committees vote to present an item to the full commission for action. No item is approved without the majority vote of the commission. President Mansori added the Executive Team is working to find online training for



- commissioners that will provide updated information about commission work, as well as compliance with Sunshine Ordinance and Brown Act.
- Commissioner Chittavong noted the Legislative and Rules Committee remains a seven-member body, but asked about reduction/selection process should the committee be approved to become a five-member body. President Mansori responded that currently the commission president decides on service of committee members. She suggested revisions to the committee selection process as an example of an item the Legislative and Rules Committee can vote on and bring to the commission.
- After discussion, President Mansori stated the following items will be added to the next meeting agenda for further discussion:
 - Commission to set a timeline on when to create separate, threemember committees.
 - Commission to re-establish Rules as a separate committee.
- President Mansori called for any additional comments on committees. As there were no further comments, the meeting moved to the next agenda item.

NEW BUSINESS

- Policy Roundtable Event [Discussion]
 - O President Mansori suggested the commission hold a policy roundtable sometime in the last quarter of the year. She suggested an in-person meeting open to the public, and recommended the Veterans Memorial Building as a possible location. If commission is interested, this will be added to next month's agenda for a vote. After discussion, it was determined commissioners are interested in scheduling a policy roundtable event, and the item will be added to the September meeting agenda. President Mansori asked the Communication and Events Committee Chair to include this topic for detailed discussion at the committee's meeting in August. She requested the Committee Chair bring recommendations for the event to the next commission meeting.

GOOD WELFARE

This is the opportunity for members of the Veterans Affairs Commission to share special thanks and congratulatory remarks for the good welfare taking place in the veterans community.

- Good Welfare Comments included:
 - o Congratulations to all involved on achievement to pass the recent veterans housing legislation.



- Acknowledgement and congratulations to Allyson West of the San Francisco Superior Court, on the occasion of her retirement. Thanks offered to Ms. West for her dedicated work as director of the collaborative justice programs.
- Acknowledgement and thanks to Michael Blecker, the executive director of Swords to Plowshares, for his participation in the BMR legislation, and for taking over the mentorship program at the Veterans Justice Court.
- o Commissioner Rusanoff thanked Courtney Ellington for her efforts on recent housing legislation.

PUBLIC COMMENT

- Public Comments included:
 - Michael Blecker with Swords to Plowshares commented on the important achievement of passing recent veterans legislation.


