

**Re: San Francisco Department of Police Accountability July 2022 Monthly Statistical Report**

Dear Vice President Cindy Elias and San Francisco Police Commissioners:


**Summary of Complaints Received in July 2022**

The Department of Police Accountability received **64** cases in **July 2022**, compared with **65** cases in the same period last year. The **July 2022** case total is **7%** higher than the five-year average and **2%** lower than the previous year.

From January through July, the DPA received a total of **398** new cases, compared with the **462** cases filed during the same period in 2021. The July year to date case total represents a **14%** decrease in new complaints over last year.



Most complaints were received over the phone and online.



Please find the attached table, which summarizes cases received in **July 2022**. The table is prepared in compliance with San Francisco City Charter section 4.136 and Police Commission Resolution number 97-04, which require the Department of Police Accountability (DPA) to provide the Police Commission with a monthly summary of cases received, including the number and type of complaints filed.

## Summary of Cases Received

CASE	RECEIVED	SUMMARY
00051255-22	7/1/2022	The Orange County Sheriff's Department failed to investigate the complainant's identity theft report.
00051258-22	7/1/2022	The Officers failed to respond promptly to a scene.
00051274-22	7/5/2022	An officer failed to take the complainant's minor daughter to Huckleberry Youth Programs, a crisis intervention and resolution services and emergency shelter for high-need youth, resulting in her daughter hurting herself.
00051277-22	7/5/2022	The complainant alleged he was inappropriately cited for a parking violation. When he asked the officer to explain why they had cited him, the officer pointed a can of pepper spray at him. The complainant alleged he asked for the officer's name and for them to contact a supervisor. The officer refused both requests.
00051292-22	7/5/2022	The complaint raised matters not rationally within the Department of Police Accountability's jurisdiction.
00051278-22	7/6/2022	The complainant alleged that the San Francisco Police Department is trespassing on property where he and others are claiming to have tenant's rights. Also, he alleged that the officers were bullying them.
00051304-22	7/6/2022	The complainant alleged he called the San Francisco Police Department to request they stop the fireworks from going off in his area. He alleged they have been ineffective at solving this issue.
00051458-22	7/8/2022	The officers pulled over the complainant for a missing front license plate. The complainant was wrongfully detained, handcuffed, and disrespected.
00051328-22	7/9/2022	The officer illegally detained a First Amendment Activist filming at an Airport.
00051412-22	7/10/2022	The complainant stated he was detained for an extended period at a police station. Officers used force on the complainant.
00051321-22	7/11/2022	The complainant called the station, and Public Service Aide was rude. The complainant then spoke to an officer who was also rude. Officers at the station are always rude in general.
00051322-22	7/11/2022	The officer has cloned the complainant's phone.
00051326-22	7/11/2022	Officers failed to take action when they responded to a restaurant regarding unruly customers.
00051333-22	7/11/2022	Officers used force to hurt a person and took the person's car.
00051334-22	7/12/2022	Officers harassed the complainant about where he was parked, and the complainant moved the motor home to a different location.
00051335-22	7/12/2022	A Public Service Aide refused to take an incident report from the complainant until ordered to by a Sergeant. An officer threatened the complainant and used profanity.
00051336-22	7/12/2022	The vehicle was illegally searched as it was not listed on the search warrant.
00051459-22	7/12/2022	The complainant stated that officers engaged in inappropriate behavior with members of the public.
00051356-22	7/13/2022	Officers failed to respond promptly to the scene and failed to write an incident report.
00051358-22	7/13/2022	The officer minimized the scene of a four-car crash by an unlicensed reckless driver and did not take appropriate action.
00051362-22	7/13/2022	The officers were dismissive about his call for help, placing the complainant on a Mental Health Evaluation and using force.
00051365-22	7/13/2022	The officers failed to remove a homeless encampment blocking a designated exit.
00051369-22	7/14/2022	The officers failed to thoroughly investigate an assault and document accurate information in the incident report. In addition, the officers incorrectly issued a party a citation that failed to include great bodily injury.
00051374-22	7/14/2022	The officer wrote an inaccurate police report and failed to provide specific information detailing the incident.
00051377-22	7/15/2022	The complainant raises matters outside of the Department of Police Accountability's jurisdiction.
00051381-22	7/15/2022	The complaint raises matters outside the Department of Police Accountability jurisdiction.
00051383-22	7/15/2022	The officer inappropriately issued a parking citation. In addition, the policy at SFO regarding loading passengers is unreasonable.
00051391-22	7/18/2022	The officer yelled and threatened the complainant's husband.
00051396-22	7/18/2022	The officer let the person the complainant complained about know where the complainant lived. The officer did not properly investigate the complaint.
00051398-22	7/18/2022	The officer was rude and told the complainant to file online instead.
00051401-22	7/18/2022	The officer did not investigate properly.
00051410-22	7/18/2022	The operator was rude and unprofessional towards the complainant. The operator hung up the phone on the complainant.
00051407-22	7/19/2022	The officer had inappropriate behavior and made inappropriate comments.
00051408-22	7/19/2022	The officers failed to take required action and failed to properly investigate an incident involving an assault.
00051416-22	7/19/2022	An officer was unhelpful and acted unprofessionally.
00051427-22	7/20/2022	The officer cited the complainant for operating a scooter while intoxicated. The officer cited the complainant for inappropriate vehicle code violations based on the circumstances of the offense.

## Summary of Cases Received

CASE	RECEIVED	SUMMARY
00051429-22	7/20/2022	An officer parked a department vehicle on a sidewalk forcing pedestrians to walk in the roadway.
00051436-22	7/21/2022	The complainant alleged that she went to two of the city's San Francisco Police Department stations to file reports. At one station, the officer at the front desk refused to provide her with the number of reports she requested. The officer inappropriately filled out the reportee follow-up form at the other station.
00051437-22	7/21/2022	The complainant alleged that an officer inappropriately provided him with a citation for his tent. He alleged the officer was discriminating against him because the officer did not cite any of the other tents in the immediate vicinity.
00051438-22	7/21/2022	The complainant alleged that he had called the San Francisco Police Department numerous times to file a noise complaint against his neighbor. He stated that the officers had failed to respond promptly.
00051439-22	7/21/2022	The complainant alleged that crime is rampant around her home. She alleged that the San Francisco Police Department had failed to appropriately patrol the area.
00051499-22	7/21/2022	The complainant alleged that a dangerous individual had taken her two young sisters. She attempted to have the San Francisco Police Department remove the children from this dangerous situation, but the San Francisco Police Department refused or failed to assist.
00051500-22	7/21/2022	The complainant alleged he had been housed in Administrative Segregation for too long.
00051445-22	7/22/2022	The complainant stated that officers failed to properly investigate a crime, and two officers made inappropriate comments to her.
00051446-22	7/22/2022	The officer failed to properly care for or monitor a person in custody.
00051449-22	7/22/2022	The officer was extremely rude when the complainant requested the officer remove a ticket she had issued.
00051471-22	7/26/2022	The officer failed to take the required action when he did not stand by until a search warrant was issued.
00051472-22	7/26/2022	An officer failed to take required action.
00051473-22	7/26/2022	The officers misrepresented the truth and failed to write a report.
00051509-22	7/26/2022	Officers hacked the complainant's phone and have been tracking and harassing him daily.
00051503-22	7/27/2022	The complainant stated that San Francisco Police officers conspired with the cartel mob suspects.
