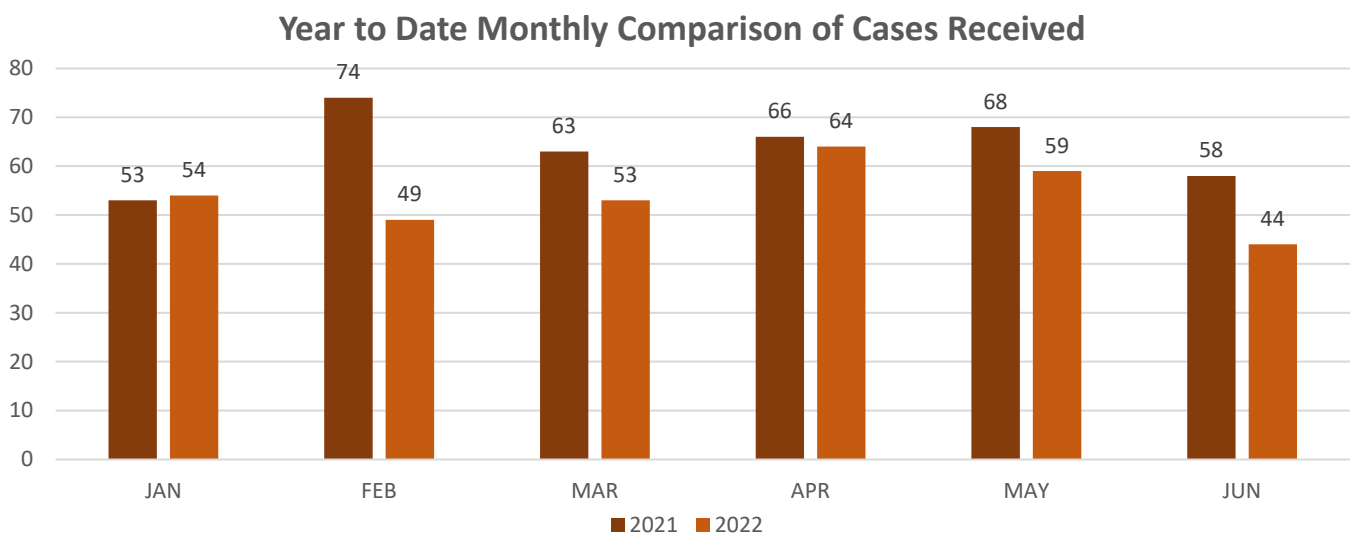
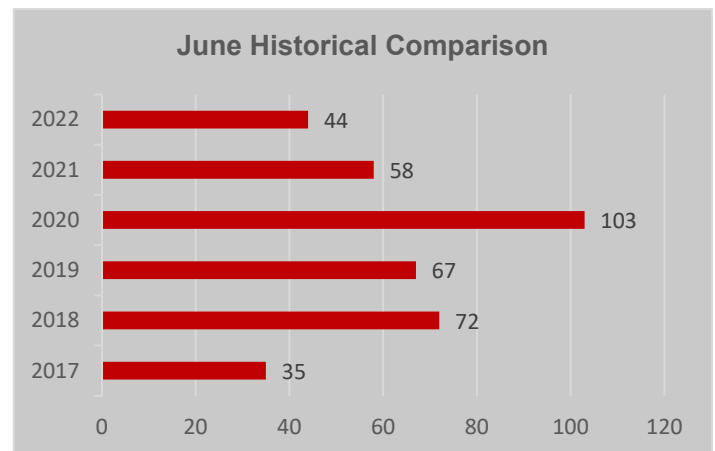
Re: San Francisco Department of Police Accountability June 2022 Monthly Statistical Report

Dear Vice President Cindy Elias and San Francisco Police Commissioners:

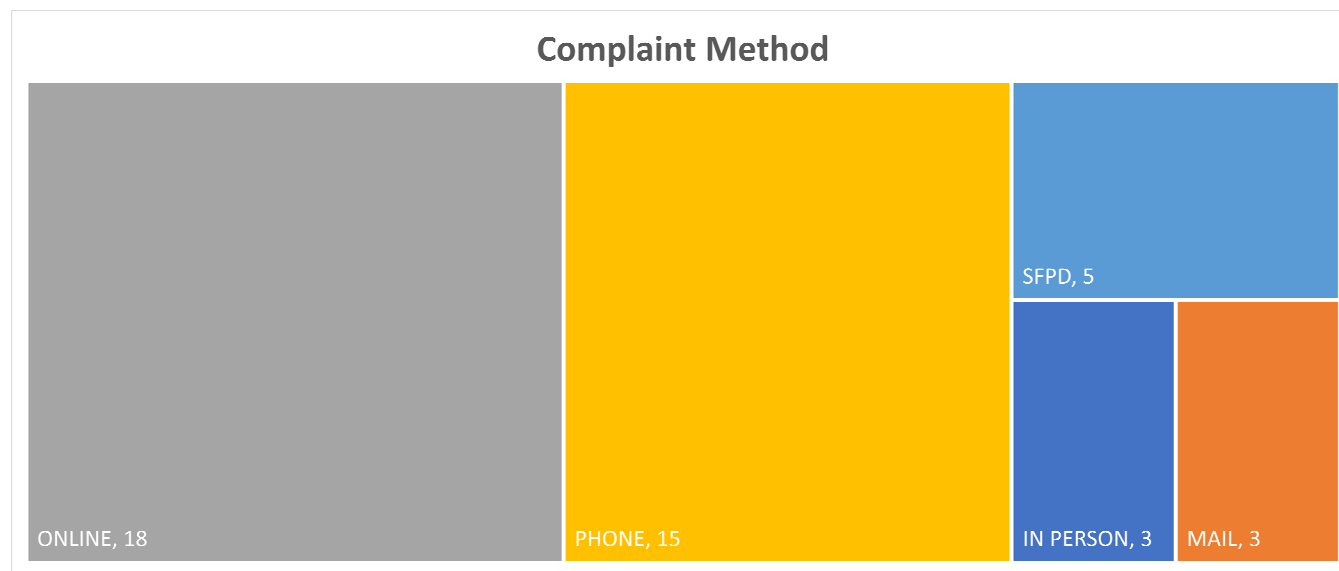
Summary of Complaints Received in June 2022

The Department of Police Accountability received **44** cases in **June 2022**, compared with **58** cases in the same period last year. The **June 2022** case total is **34%** lower than the five-year average and **24%** lower than the previous year.

From January through June, the DPA received a total of **336** new cases, compared with the **397** cases filed during the same period in 2021. The June year to date case total represents a **15%** decrease in new complaints over last year.



Most complaints were received over the phone and online.



Please find the attached table, which summarizes cases received in **June 2022**. The table is prepared in compliance with San Francisco City Charter section 4.136 and Police Commission Resolution number 97-04, which require the Department of Police Accountability (DPA) to provide the Police Commission with a monthly summary of cases received, including the number and type of complaints filed.

Summary of Cases Received

CASE	RECEIVED	SUMMARY
00050930-22	6/1/2022	Another driver slapped the complainant. The complainant stated that the driver should have been handcuffed and put in a police vehicle for the assault.
00050940-22	6/2/2022	The complainant stated that the police were harassing him.
00050941-22	6/2/2022	The officer brandished a shotgun in front of the children.
00050945-22	6/2/2022	The complainant stated that the officer wrote an inaccurate incident report regarding a vehicle accident.
00050973-22	6/3/2022	The complainant that San Francisco Police Department did nothing when he reported being attacked with a deadly weapon.
00050967-22	6/6/2022	The officers did not conduct a proper investigation of a DUI incident, failed to properly supervise, and wrote an incomplete incident report.
00050972-22	6/6/2022	Officers parked blocking a crosswalk and then performed an illegal U.-turn
00050988-22	6/8/2022	Officers were discourteous and rude and failed to take the required action. An officer authored an inaccurate incident report.
00050990-22	6/8/2022	Police officers concealed multiple police reports covering up assaults inflicted upon the complainant.
00050997-22	6/8/2022	The officer illegally detained the complainant, failed to issue a timely Certificate of Release, and prepared an inaccurate incident report.
00051000-22	6/8/2022	Officers failed to properly investigate.
00051016-22	6/8/2022	Officers acted inappropriately and displayed childish behavior.
00051088-22	6/8/2022	911 call takers have been calling screening using the complainant's name to prevent police from being dispatched to incidents reported by the complainant.
00051091-22	6/8/2022	The officer refused to write an incident report.
00051093-22	6/8/2022	The officer failed to write a report related to a traffic collision.
00051094-22	6/8/2022	Officers failed to issue a vehicle with a citation for illegal parking and tinted windows. An officer also tried to evade providing their star number.
00051090-22	6/8/2022	An officer accused the complainant of lying to law enforcement.
00051008-22	6/9/2022	Deputies detained the complainant from another jurisdiction. The complainant stated that one of the deputies in plainclothes failed to provide his name and badge number.
00051029-22	6/13/2022	Officers arrested the complainant when they were the victim of Domestic Violence.
00051037-22	6/14/2022	The complainant called 911 to report an incident, disregarding the call.
00051047-22	6/14/2022	The officer unsafely made a turn directly in front of the complainant.
00051068-22	6/15/2022	The officer has repeatedly been harassing the complainant's husband over the past few months.
00051069-22	6/15/2022	The complainant stated that the named officer was rude to the complainant over the phone.
00051084-22	6/16/2022	The officers did not properly investigate, unlawfully ran his name, failed to accept a private person's arrest, and failed to write an incident report.
00051104-22	6/17/2022	The complainant stated that San Francisco Police officers conspired with the cartel mob suspects.
00051114-22	6/17/2022	The complainant stated that a large crowd was celebrating in the street, and an officer took a person to the ground. The complainant believes the officer used unnecessary force.
00051118-22	6/17/2022	The officers arrived late to report an assault in progress. In addition, the officers failed to follow up with the complainant who reported the crime.
00051120-22	6/17/2022	The complainant stated that he had insufficient knowledge of bicycle laws, some officers were dismissive of his complaints, and the reporting officer wrote an incorrect traffic collision report.
00051122-22	6/17/2022	The complainant stated that officers failed to take required action because of his race; one officer also sneered at him.
00051131-22	6/21/2022	A Maryland State Police officer unlawfully arrested the complainant, committed perjury, tampered with evidence, falsified evidence, and did not follow proper procedure.
00051159-22	6/22/2022	The officers failed to take action on an unruly crowd and engaged in biased policing.
00051161-22	6/22/2022	The officer was rude and engaged in biased behavior.
00051175-22	6/23/2022	The complainant states that there is a lack of traffic enforcement by the San Francisco Police Department.
00051177-22	6/23/2022	The complainant tried to make a report, but the officers refused to take it.
00051160-22	6/23/2022	The complainant states he was stopped and searched illegally and then given a citation for no reason.
00051194-22	6/25/2022	The complainant stated in an online complaint that she noticed an officer at various locations throughout the city, which included a satanic lodge, and he was a motorcycle cop.
00051206-22	6/27/2022	The officer tailgated the complainant in a tinted windows vehicle, conducted an illegal stop, and did not use any turn signals as he changed lanes. The complainant called 911, and an outside agency showed up and refused to conduct a citizen's arrest on the officer that initiated the illegal stop.
00051207-22	6/27/2022	This complaint raises matters not rationally within the Department of Police Accountability jurisdiction.
00051216-22	6/27/2022	This complaint raises matters outside the Department of Police Accountability's jurisdiction.
00051218-22	6/28/2022	An officer failed to forward a courtesy report to Interpol.
00051241-22	6/29/2022	The officer intimidated and abused her power to make false reports against the complainant and sue her.
