Nondiscrimination and Cultural Competency:

The Contractor will participate in applicable cultural competency requirements.

Other Significant Issues:

Omnicell, Inc. provides medication management, dispensing and storage of pharmaceuticals through highly specialized pharmacy cabinets, packagers, and pharmaceutical carousels. The items are part of an integrated pharmacy automation and management system in use at Zuckerberg San Francisco General Hospital (ZSFG) and Laguna Honda Hospital (LHH) of the San Francisco Health Network. This contract will allow the Department to buy updated automated dispensing cabinets for SFHN pharmacies and associated software licensing and software/equipment. The dispensing cabinets will maximize patient care and use the latest technology to monitor pharmaceutical usage and mitigate diversion.

The project scope will allow for the purchase, implementation, and ongoing support for the following items across the network:

ZSFG XT Cabinets: 69	LHH XT Cabinets: 28
ZSFG Anesthesia Workstations: 8	ZSFG Omnicell One Platform
Jail XT Cabinets: 3	LHH Omnicell One Platform

Additionally, with an 84-month service term, SFHN Pharmacy will maintain service for the majority of the equipment's lifecycle, while keeping costs predictable.

Omnicell, Inc. ("Omnicell" or the "Company") is a publicly traded corporation. The Company is incorporated in the state of Delaware. Through the vision of the autonomous pharmacy, a combination of automation, intelligence, and technology-enabled services, powered by a cloud data platform, Omnicell supports more efficient ways to manage medications across all care settings. Healthcare facilities worldwide use Omnicell automation and analytics solutions to help increase operational efficiency, reduce medication errors, deliver actionable intelligence, and improve patient safety

Omnicell, Inc. was selected under the authority of Section 21A.2 of the Administrative Code through the Department's membership in the Group Purchasing Organization (GPO), Vizient, which was formerly known as University HealthSystems Consortium and the University Health Systems Consortium Services Corporation Purchasing Program (Novation).

Omnicell, Inc. was selected under SFGOV-0000006742. Omnicell, Inc. was the highest ranked proposer. SFGOV-0000006742 was a joint solicitation between the Department of Public Health and the San Francisco Public Works. San Francisco Public Works will be tasked with a separate project for all of the construction services associated with the physical installation of the equipment. All construction services, as applicable, will follow the published structural compliance standards of the California Department of Health Care Access and Information (HCAI), formerly the Office of Statewide Health Planning and Development (OSHPD).

The RFP allows for a contract of up to nine years which includes contract options which may or may not be exercised.
