

This presentation will provide data and context for the 89 sustained DPA cases pending Chief's review, as of September 16, 2022.

- The Internal Affairs Division maintains case tracking for all sustained DPA cases.
- The information is maintained using a case tracking program, Administrative Investigative Management (AIM) database and shared with DPA via SharePoint.
- > SharePoint tracks various data including, but not limited to:
 - Current status of all sustained DPA cases
 - 3304 date of all the sustained DPA cases
 - Factors/Variables as to why sustained DPA cases are still pending

- Determination of progressive discipline

Open - Pending Chief's Hearing

 Member is appealing the Notice of Intent to Impose Discipline

Open - Pending Chief's Hearing Appeal

 Member has had hearing with a Deputy Chief and is requesting a Police Commission Hearing

Open - Pending Chief's Review

 Case is still being reviewed by the Risk Management Office for presentation to the Chief of Police

Open - Pending Meet & Confer

 Chief requests a meeting with DPA to discuss recommended discipline and/or finding

Open - Pending Police Commission

 Member is waiting on Police Commission Hearing

What is the 3304 Date?

Statute of Limitations

"No punitive action...shall be undertaken for any act, omission or other allegation of misconduct, if the investigation is not completed within one year of the public agency's discovery by a person authorized to initiate an investigation of the allegation of an act, omission or other misconduct." (3304 Government Code).

3304 Status of the 89 Sustained DPA Cases

- 80 cases have met the 3304 date (Chief of Police has made a determination regarding the allegations and the member has been notified of the discipline decision).
- 9 cases are approaching the 3304 date.
