(4) SPECIAL ITEM: INFORMATIONAL PRESENTATION BY THE PLANNING DEPARTMENT

Overview of the Planning Department's Review/Entitlement Process.

A presentation on the Planning Department's review process for common types of applications (building permits, discretionary review, conditional use authorization, variances, large project authorization etc.). The presentation will also cover Section 308.2 of the Planning Code and discuss the appeal process of actions taken by the Zoning Administrator, including but not limited to variances, letters of determination, revocation and suspension requests, and notices of violations.

SPEAKERS: Corey Teague, Zoning Administrator.

PUBLIC COMMENT: Robert Fruchtman stated that he found the presentation informative and thanked the Zoning Administrator. He further urged the commissioners to take into account, when making decisions on appeals, the fact that appeals drive up the costs of construction and housing projects and contribute to delays. He referenced the 2017 study by the U.C. Berkeley Terner Center which talked about the major drivers of rising housing construction costs in San Francisco. The study stated that one challenge was the frequency of appeals on projects, and it further noted that every permit in San Francisco was appealable.
