The Mayor's Office of Housing and Community Development (MOHCD) of the City and County of San Francisco is pleased to announce that the new integrated <a href="Lender Closing Checklist">Lender Closing Checklist</a> is now available on the MOHCD website at <a href="https://sfmohcd.org/housing-program-forms-and-documents">https://sfmohcd.org/housing-program-forms-and-documents</a> as well as on individual homeownership program webpages. The new Lender Closing Checklist is intended to eliminate the program applicants who are applying for multiple MOHCD programs to fill out multiple applications, and create alignments in lender package submissions between the Below Market Rate (BMR) Programs and Downpayment Assistance Loan Programs (DALP).

# **BMR Lender Closing Checklist**

BMR Lender Closing Checklist shall be used for consideration of MOHCD's final approval in connection with a Below Market Rate (BMR) home purchase. If a BMR applicant who has been conditionally approved by MOHCD for Below Market Rate Downpayment Assistance Loan Program (BMR DALP) and/or Teacher Next Door (TND), the reserved program funds will be reflected on the MOHCD's Conditional Approval Letter. At the time of the lender package submittal, lender shall complete the "Other MOHCD assistance programs" section in the BMR Lender Closing Checklist. See below.

### **Market-Rate DALP Lender Closing Checklist**

The Market-Rate DALP Lender Closing Checklist shall be used for consideration of MOHCD's final approval in connection with a market-rate home purchase. If a market-rate applicant who has been conditionally approved by MOHCD for multiple assistance loan programs (for example, General Downpayment Assistance Loan Program (General DALP) and Teacher Next Door (TND)), the reserved program funds will be reflected on the MOHCD's Conditional Approval (or Pre-Approval) Letter. At the time of the lender package submittal, lender shall check all programs that apply under the "MOHCD Assistance Programs" section in the Market-Rate DALP Lender Closing Checklist. See below.

## **Combined DALP Loan Application**

As mentioned in the 3/25/2021 Homeownership Partner training, the "Combined DALP Loan Application" has been discontinued. Instead, lender will be using the new Lender Closing Checklist to submit lender packages for consideration of MOHCD's final approval.

#### **Effective Date**

Effective June 1, 2021, any new lender packages using the legacy Combined DALP Loan Application will not be accepted by MOHCD. Lenders are encouraged to use the new Lender Closing Checklist immediately.
