III. A. DEPT OF HOMELESSNESS AND SUPPORTIVE HOUSING

DISCUSSION

HSH

Per Member Rachowicz, shelter capacity is being reinflated towards pre-COVID levels. New congregate sites have been added to the list: 711 Post (aka the Ansonia Hotel, which could eventually house 250), A Woman's Place and Dolores. Intakes at MSC-South are paused for pest treatment. Starting October, they will, along with Next Door, be getting CAAP beds. Baldwin is a non-congregate SRO Navigation Center. Embarcadero has begun reinflating; capacity will be 200 by year end. Operations are winding down at the Good Hotel and most guests will move to the Monarch. Civic Center is closing. Family shelter capacity refers to rooms, except at BVHM and Hamilton Family Emergency, where it is measured by guests. Alternative Shelter Programs (Gough Cabins and Pier 94) capacity is also based on units. Hospitality House will be men only. Its opening date is dependent on contract negotiations.

Explanatory documents - <u>Vacancy Report</u>

Member comment: Member Creech wondered what the plan is for handling the closure of SIP sites. HSH is working to provide permanent supportive housing. Some may be placed (temporarily) at the Baldwin. Member Watson asked about the Monarch, and about pets. Member Rachowicz confirmed that all sites allow animals.

The City Attorney has not responded to the question we submitted; however, HSH says this SOC is still relevant, especially in relation to the provision of shelter for CAAP participants.

It makes sense to consider reducing the frequency of inspections for shelters that have relatively few complaints and findings during inspections, so amending AC §20.304.
