Police Department

Typical 19B STP and SIR Process



COIT sets schedule based on tool category OR at request from Department



Department SME drafts STP and SIR, submits to COIT. Privacy Surveillance Advisory Board (PSAB) working group provides feedback to Department.



Department presents SIR and STP to PSAB for policy development at public hearings. PSAB recommends to move forward to COIT. COIT hearing; then Rules Hearings; then full Board.



Department receives approval and final STP, as developed by COIT and Board. Posts on website. Disseminates to members through a written directive.

Non-City Entity Camera STP Uses

- 1. Temporary live monitoring (a) during an exigent circumstance as defined by Administrative Code, Section 19B, (b) during Significant Events with public safety concerns only for placement of police personnel due to crowd sizes or other issues creating imminent public safety hazards, or (c) in the course of a specific criminal investigation if an SFPD Captain or member in rank above Captain confirms in writing that the department has credible information of criminal activity and live monitoring is being requested in furtherance of that criminal investigation. Temporary live monitoring will cease, and the connection will be severed, within 24 hours after the non-city entity has provided access to SFPD. SFPD shall not record or duplicate the live monitoring feed using any electronic device, including body worn cameras or cell phones. If SFPD observes misdemeanor or felony violations on the live monitoring feed, nothing in this policy ordinance prohibits SFPD from deferring to authorized use No. 2 or No. 3 of this section.
- 2. Requesting, obtaining, and reviewing historical video footage for purposes of gathering evidence relevant to a specific criminal investigation.
- 3. Requesting, obtaining, and reviewing historical video footage for purposes of gathering evidence relevant to an internal investigation regarding officer misconduct.

Approved STP

- Requests to access non-city entity cameras for temporary live monitoring during significant events for deployment needs, or credible intelligence relating to domestic terrorism or during criminal investigations
 - Limit monitoring to max of 24 hours
 - Prohibited from recording footage
 - Standardized tracking
 - Department-wide quarterly reporting requirement
 - Chain of command and Captain-rank approval required before request is submitted to non-city entity
- Requests for non-city entity for historical footage relating to a criminal investigation
 - SFPD Form 468 for all requests
- Annual Report requirement for all technologies approved through 19B process

Due 60 days after first full quarter after ordinance adoption

Focus on deployment needs and criminal investigations

No Central Location. Incident Based requests



Clear prohibition on p. 2 of STP

Camera placement, facial recognition, AI, misuse, lack of public reporting: ALL addressed in STP

SFPD STPs=City Laws that are informed by DGOs

Required quarterly report to track and review data allowing for data informed course correction



Policy Ordinance Enactment and Effective Date

Disseminate new live monitoring request form to members. This tracks staff time, approvals, length of monitoring time and result of monitoring operations.

Disseminate updated SFPD Form 468 (includes historical footage section for victims and witnesses to complete)

Training

Data team is building dashboard and/or report that will overlay census tract on our current incident report methodology
