On behalf of San Francisco Public Works, I wish to express our support for the Virginia Garden Walk Project's 2021 Community Challenge Grant application. The area is a greenery, retaining wall, and stairway located along the 300 block of Virginia Avenue.

We've reviewed the group's proposal and think their vision would amplify the natural beauty of the space. We support their plans to plant succulents along the retaining wall. Should they receive the grant, we'd work with the group to make sure the vegetation was appropriate native plants and pollinators for the area. Our department would also commit to having our engineers review the integrity of the retaining wall and stairway. We'd cover any expenses related to the repair of essential structural issues on the city infrastructure.

We'd require their mural be layered with a protective coating. They would also need to obtain any necessary permits from our Bureau of Street Use & Mapping division and San Francisco Department & Planning. We'd provide them with an in-kind staffing liaison from our department to help them navigate these processes.

Attach a separate document if needed). | The Virginia Garden Walk has a multi-panel retaining wall that spans several houses on the 300 block of Virginia Ave. Amos' mural will weave the iconic scenary of San Franicsco with the intimate neighborhood stories of Bernal Height. His monochrome design on a painted surface is a reductionist approach to the urban landscape which strips away the complexity of city life to evoke the connections that define our community. The panoramic mural is not intended to be visible in its entirety from the street. Rather, each section will be like a window to the walker, who is drawn into the secret garden path only to discover the beauty of the city hidden within. |
| mural areation and  | The retaining wall will be power washed. Then a coating of acrylic primer and/or base coat will be applied. The mural will be painted with acrylic paint. After the mural is completed, an antigraffiti sealant is applied to provide durability and ease of care. Any tagging on the surfaces can be removed by soap and water. The 10 year maintenance plan includes quarterly checks and abatement of graffiti by the FoVGW. The artist has agreed to provide touch up services free of charge.  |







I am happy to offer up my enthusiastic endorsement of the Virginia Garden Walk as the garden's stewards seek a Community Challenge Grant to transform the site with new plants, irrigation, solar lighting, and public art. I have lived in Bernal Heights for more than 30 years, and I visit the garden regularly as I walk and run errands in this pedestrian-oriented neighborhood. It is a heavily used walkway, connecting the Mission Street and Cortland Avenue commercial corridors and offering us a stretch of greenery and natural habitat.

Bernal Heights is rich with community greenspaces that have been adopted by and faithfully cared for by neighbors, from the Esmeralda Slide Park and the Bernal Cut to the Tompkins Stairway Garden, where I am a volunteer. (We remain deeply grateful for the Community Challenge Grant that enabled us to transform the site in 2019.) #### Dear Friends,

As an artist, arborist and landscape designer I am honored to write a letter in support of the Virginia Garden Walk (VGW) mural. It is a rare experience in an urban area to be blessed with both an entire long block of historical open space on one side and a 60' expanse of wall on the other. This presents an opportunity to create a wonderful, enhanced footpath as one traverses the uphill or downhill walk from Cortland to Mission or vice versa. When Janet told me how the mural was going to illuminate and express scenes from Bernal and San Francisco history, I could envision the cozy, secret walk with green space to one side and public art on the other.

San Francisco has embraced the idea of art for everyone, and murals historically have told stories and enhanced public space for – well since the pictographs on cave walls. Besides what mural art provides for the public, it also demonstrates support of our local artists who choose to share their art on empty walls rather than in the traditional gallery/museum system..

As a painter myself, I chose to leave that part of the art world and explore the popular and revolutionary art form of the simple postcard, publishing women's history postcards for almost 20 years. I feel fortunate that my large scale paintings from the 70s are permanently installed on a university campus where hundreds of people walk down the hall daily. I tell you this because I understand and support politically the importance of visual art and the path painters like Amos Goldbaum have chosen.

As a Bernal resident, I am invested in the VGW and have contributed many hours pruning and restoring the trees and shrubs and helping to shape a holistic vision for this green corridor. As we walk along the footpath, plants greet us on the one side and scenes of the past weave into the mural on the other side. It becomes an encompassing experience. The natural scene and the painted scene become one. It will be like two hands reaching out to each other.

Your support of the mural makes possible this extraordinary walkway, which will enhance the community, provide opportunity for dialogue and conversation and integrate and transform what otherwise is a harsh hardscape wall into an outdoor gallery connected to the garden park.

In consideration of the City's approval to place the Work on City property, the Artist agrees to waive and does hereby waive voluntarily all rights to attribution and integrity with respect to the Work and any and all claims as may arise under the Visual Artists Rights Act of 1990, 17 U.S.C. §§106A and 113(d) ("VARA"), the California Art Preservation Act (Cal. Civ. Code §§987 and 989 )("CAPA"), and/or any other local, state, foreign or international law, as currently drafted or as may be hereafter amended, that conveys the same or similar rights ("Moral Rights Laws"), with respect to the Work, its display, removal from display, exhibition, installation, conservation, storage, study, alteration and any other activities conducted by the City, its officers, employees, agents, contractors, licensees, successors or assigns. If the Work is incorporated into a building such that the Work cannot be removed from the building without physical defacement, mutilation, alternation, distortion, destruction, or other modification (collectively, "Modification") of the Work, Artist waives any and all such claims under any Moral Rights Laws arising out of or against any current or future owners of the site, and its agents, officers and employees, for Modification of the Work.

The City has the absolute right to change, modify, destroy, remove, relocate, move, replace, transport, repair or restore the Work, in whole or in part, in City's sole discretion.

The City has no obligation to pursue claims against third parties for modifications or damage to the Work done without the City's authorization. However, the City may pursue claims against third parties for modifications or damage or to restore the Work if the work has been modified without the City's authorization. If the City pursues such a claim, it shall notify the Artist, and Artist shall cooperate with the City's efforts to prosecute such claims.

If the City modifies the Work without the Artist's consent in a manner that is prejudicial to Artist's reputation, Artist retains the right to disclaim authorship of the Work in accordance with 17 U.S.C. § 106A (a) (2).

Artist bears the sole responsibility for providing the City with any changes to the Artist's Address for Notice. Notice of changes must be mailed to the Arts Commission, 401 Van Ness Avenue, Suite 325, San Francisco, CA 94102 AND to the City Agency with jurisdiction over the property.
