On behalf of San Francisco Public Works, I am pleased to support the Friends of the Glen Park Greenway in their application for the temporary installation of "Stook," a sculpture by Adam King, in the native meadow on the Greenway.

Public Works has been in partnership with the Friends of the Glen Park Greenway for many years and is pleased by their continued stewardship and creativity in imagining and caring for this special community space. The temporary sculpture will enhance the Greenway in its references to the harvesting of grasses and agricultural life. In addition, there is strong support from the community for the piece.

3) Brief narrative description of the proposed project.

The site is a project of the San Francisco Parks Alliance lead by the Friends of the Glen Park Greenway, a neighborhood group. A master plan for the five blocks was subject to public review and extensive community input. This block, between Brompton and Lippard was approved for a Native Plant Meadow. Implementation of the Meadow was started following the installation of the new trail. The meadow predominantly features native grasses with seasonal native flowers. About a year ago the Friends of the Glen Park Greenway invited me to do a piece for the Greenway.

The piece is titled 'Stook (Black King)' and is one in a series based on the Chess Pantheon. The geometrical generation of the form is an exercise in itself. but is misdirection; a means to an end; the order and internal logic may give the result a sense of inevitability, meanwhile a separate process, on another level to the mechanics of form making, aims for something that resonates with readings. The name 'Stook' focuses those readings on the agrarian history of the harvesting of a grass meadow, gathered and bound in sheaves which are then stacked temporarily in stooks before collection into haystacks. Other readings vary with each individual; the rope and bollard shape suggest a maritime context, or perhaps a differential gear box, cooling towers, or an animist totem and more. The sub-title (Black King) is to further layer alternate interpretations, and engagement. All the while the dominant reading remains an abstracted stack of sheaves to a greater or less degree.

The installation is temporary because long term, it is for sale. A percentage from the


sale, above a reserve, will go to the Greenway.





- 6) List of proposed materials. 2x4s and rope painted with rubberized roofing tar. (A blow torch failed to ignite it.)
- 7) Budget, including the funding source for the project. Self-funded, the piece ultimately will be for sale.
- 8) Timeline, including dates of installation and deinstallation. Installation is approximately one week following final approval. Duration is approximately 3 months but could be as long as 6 months, any extension would be subject to the approval of the neighbors and the Executive Group.
- 9) Maintenance plan for duration of display. I will inspect and maintain the piece regularly.
- 10) Structural engineering drawings to ensure safety and stability of proposed installation. Structural engineering calculations by ZFA Engineers are provided separately. The calculations have also been reviewed by SFPW engineering.
- 11) Thorough ADA compliance review. Per DPW ADA review the site is not subject to full ADA access since it is a trail. Nicholas Dewar, leader of the Glen Park Greenway Executive Group writes "The Glen Park Greenway is considered to be a Trail. We filed forms documenting ADA compliance/exemption to the satisfaction of the City's Disability Access Coordinator. Our forms were based on the forms voluntarily used by the Trails Program of the SFRPD." Signage and QR code links to additional information will be placed at approximately 3 foot high nearby the installation, adjacent to a level area. Non-compliant but stepfree access is possible from Brompton. However, the steep-side walk is non-compliant.

- 13) Signed Waiver of Proprietary Rights for Artworks Placed on City Property or Private Property. Not applicable. The piece is on loan.
