# **Chief's Report**

- Weekly crime trends
- Major/Significant Incidents

Chief Scott reported on crime trends YTD: Violent Crime up 7 percent; homicide down 5 percent; rape up 9 percent; robbery up 4 percent; assault up 12 percent; human trafficking down 56 percent. Property Crimes up 7 percent; burglary down 21 percent; motor vehicle theft up 5 percent; arson down 11 percent; larceny theft up 15 percent. Gun violence is down 1 percent compared to 2021; Seven shooting incidents for the week ending on 10/16/22; total 152 incidents resulting in 175 victims YTD. Two homicides for the week ending 10/16/22; there are a total of 42 homicides YTD with 28 resulting from a firearm; 61% overall clearance. Guns seized 849; ghost guns seized 163 YTD.

Significant Incident: Two reported incidents. Homicide in Tenderloin occurred on 10/18/22. No suspect in custody, still investigating. Seven non-fatal shootings, 23<sup>rd</sup> and Mission 10/11, Mission and Lilac 10/11, Baker and Oak 10/12, two victims at 600 Block of Larch 10/16, Parking lot Broadway and Kearny 10/14- all investigations ongoing. Bomb calls related to schools, fake call, FBI involved, cause of concern, active shooter protocols. Bomb call in Mission District, under investigation.

Significant arrest: None. 10/14 lowrider event without incident. Northern had concerts, no incidents or security issues.

Strategies: President Elias asked Chief Scott to speak on homicide reward money article. Chief Scott speaks on topic and requests to agendize. Chief Scott takes questions from Commissioners. President Elias requests public to submit questions to the commission office for when the matter is on agenda.

# **DPA Director's Report**

- Report on recent DPA activities, and announcement

Chief of Staff Sarah Hawkins for Executive Director Henderson reported the following: In the year 2022: 546 cases opened; 574 closed; 256 pending; 51 cases sustained; 24 cases past 270-day; 18 cases mediated. Cases received in the past week: 9 new cases; 5 (Southern) Failing to write an incident report, improperly driving a vehicle, and failing to respond to a car break-in. 1 (Tenderloin) failing to remove a drug dealer. 3 (Airport) Failing to provide a name and badge number, acting aggressively towards a person.

Audits: Two audits in progress. Handling of Officers' misconduct by SFPD and Compliance with SFPD DGO 8.10. Interim Audit on Officer Misconduct update in December.

Outreach: DPA tabled at Phoenix Day event over the weekend. Providing outreach materials to libraries. Can be found on community calendar on the DPA's website and posted on Twitter, Facebook, Instagram and on DPA's website.

President Elias- DGOs and working groups. Working with Chief and DPA. DPA would help Commissioners, working groups with assigned DGOs. Update on Commissioners moving DGOs along. Met with DPA and SFPD regarding 5.08, SME identified, SFPD working on draft DGO.

Commissioner Benedicto- Along with Commissioner Walker and DPA, attended SFPD's CMCR (Critical Mindset Coordinated Response) training, other Officers and Departments attended training. Commissioner Yanez does not want to combine DGOs or work groups, recommends activating working group for Social Media DGO-independent of Media Relations DGO. Mentions DPA also on board, asks to start clock on that. Language Access DGO will be initiated next year.

Vice President Carter Obertstone- Spoke on Committee who recommends changes regarding penal codes. Two are particularly relevant, discussed low level offenses (stated offenses) for traffic stops and consent searches. Mentions because of similarities for 9.01.

Commissioner Yee- On 10/21 will attend recruit graduation. Planning on attending 9.01 meeting. Commissioner Walker- No updates regarding DGOs. Spoke on CMCR training attended President Elias- Speaks on CMCR training. Commissioner Walker to collaborate on 6.13 Prejudice based Incidents, asked for President Elias for assistance. DGO 9.01, asked Commander Yep and Jones to provide data regarding banned traffic stops. Wants data and racial makeup from department of how many stops have been made for the banned offenses. Department agreed to provide data. President Elias says the have not received data. Director McGuire has not yet provided. Chief Scott discusses data being sent today 10/19/22. Continues to discuss working group and providing data to Commissioners involved. Human Rights Commission

Commissioner Benedicto- Working group 10/26 collaboration with Glide and HRC. Commissioner Byrne- Had question regarding protocol on use of stationary. Agendize uses of Letterhead.

(HRC) agreed to help facilitate, work with Glide.

Commissioner Yanez- In contact with SFPD Policy Director, Diana Oliva-Aroche, regarding impact on juveniles. Juvenile DGO revision, with Commissioner Benedicto.

Discussion and possible action to approve the draft Memorandum of Understanding between the San Francisco Police Department and the San Francisco District Attorney's Office regarding the Investigation of Serious Uses of Force and In-custody Deaths for meeting and conferring with the San Francisco Police Officer's Association, at required by law. Judge Walker (Retired) assisted with the negotiation of the draft MOU that the DA's Office and SFPD have agreed upon. (DISCUSSION & POSSIBLE ACTION)

Chief Scott presented on the process and major changes on MOU. DPA Acting Director Hawkins provided and spoke on concerns and recommendations. Commander Yep, Attorney Betz and Deputy City Attorney Porianda spoke on behalf of SFPD. DPA Attorney Diana Rosenstein spoke on behalf of DPA.

Motion by Commissioner Benedicto to not approve the MOU as written as this time to direct the Chief to go back to the District Attorney and the Mediator to consider the changes suggested tonight including forthcoming changes suggested by the Police Accountability and present them to the

District Attorney and the Mediator and once that is done, return to the Commission for discussion and action. Second by Commissioner Carter Oberstone. Approved 4-3.

The Chief gave us assurances that he would extend it but the result is there has been not vote on it and I'd like to make the record clear as to what this Commission is doing tonight, and I believe that my motion is distinct because it can't rule on the extension so can you tell us whether or not we can have a vote on this?" DCA Porianda responded by saying that the portion of Commissioner Byrne's motion to provisionally adopt the MOU is moot because of the motion that was adopted rejecting it.
