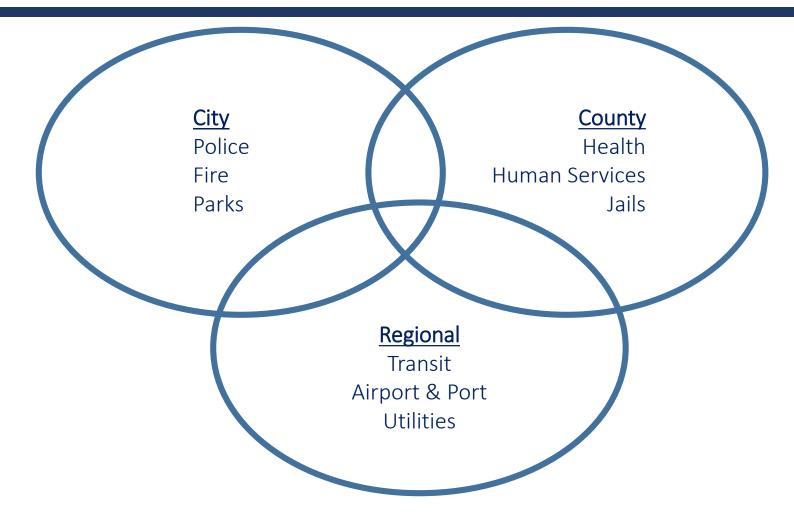

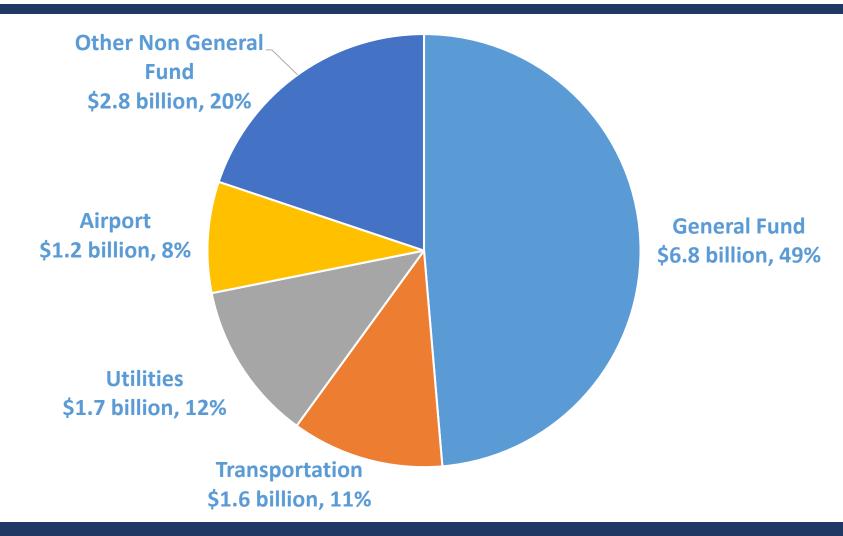


The City's Organizational Structure





The City's FY 2022-23 Budget - \$14.0 billion



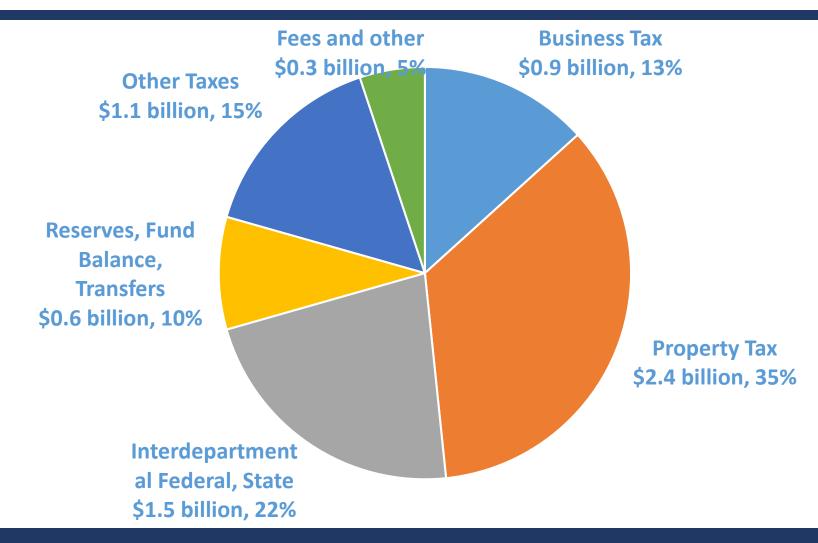

Factors that shape the City budget

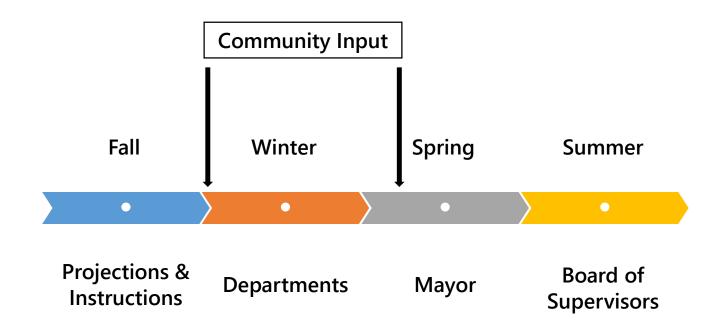
- How much money is available?

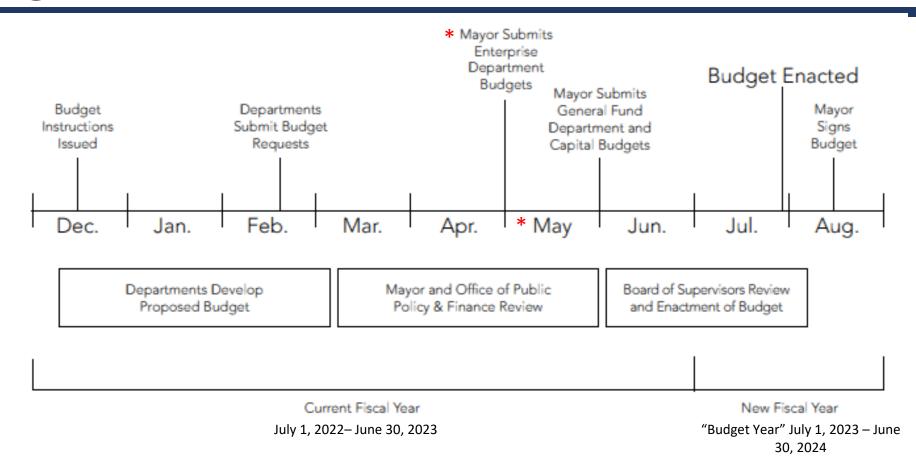


Community Input Timing

- Departmental touchpoint
 - Departments hold public meetings to solicit feedback on budget priorities and proposed budgets
 - January and February
- Mayor's Office touchpoint
 - Staff across the Mayor's office meet with community groups
 - March
- Board touchpoint
 - BoS staff meet with community groups
 - June onwards

Key milestones that inform fiscal standing

December Budget Outlook & Instructions issued

January Mayor, Controller, and BLA publish Five-Year Financial Plan or Joint Report

Governor's Proposed Budget

February Controller's 6-Month Report (current year)

Department Budget submissions due (Feb 21, 2023)

Mid-March Update to Five-Year Financial Plan Report (future years)

May Controller's 9-Month Report (current year)

Governor's "May Revise" – aka revised proposed budget

Mayor's Proposed May 1st budget for select departments

June Mayor proposes balanced budget to the Board of Supervisors (by June 1)

Budget and Finance Committee hearings

July Budget considered and finalized by the Board of Supervisors

FY 23 and FY 24 Budget Overview

- Mayor's proposed FY 2022-23 and FY 2023-24 budget is \$14.0 billion and \$13.9 billion, respectively
- Makes critical investments in:
 - Labor and wage equity
 - Economic recovery, small businesses, and streets
 - Public Safety
 - Homelessness and behavioral health
 - Children, youth, and families, housing, and other investments



Outlook for Upcoming Budget

- Pace of economic recovery, especially downtown, still uncertain
- Downtown recovery key to driving economic activity in large and small business taxes, hotel taxes and property tax
- Major cost pressures including:
 - Continuing to address public safety, street conditions, homelessness and housing
 - Labor negotiations with Police and Fire unions
 - Hiring challenges across City Departments
