San Francisco Administrative Code Section 95.2 authorizes the County Clerk to issue City Identification Cards to residents of the City and County of San Francisco. Applicants must appear in person at the Office of the County Clerk, complete an application and certify the information under penalty of perjury, present documents establishing identity and residency, and have a photograph taken. If a card is lost, stolen, or destroyed, applicant must apply for and meet requirements for a replacement card.

Acceptable forms of documentation. Documentation not listed below CANNOT be accepted.
