(1) SPECIAL ITEM

Board of Appeals Budget Priorities for Fiscal Years 23-24 and 24-25. This is an opportunity for members of the public to provide the Board input on budget priorities pursuant to Section 3.3(b)(1) of the Administrative Code in advance of the Board's consideration of the FY 23-24 and FY 24-25 budget.

(2) PUBLIC COMMENT

At this time, members of the public may address the Board on items of interest to the public that are within the subject matter jurisdiction of the Board except agenda items. With respect to agenda items, your opportunity to address the Board will be afforded when the item is reached in the meeting with one exception. When the agenda item has already been reviewed in a public hearing at which members of the public were allowed to testify and the Board has closed the public hearing, your opportunity to address the Board must be exercised during the Public Comment portion of the calendar. Each member of the public may address the Board for up to three minutes. At the discretion of the Board President, public comment may be limited to two minutes. If it is demonstrated that comments by the public will exceed 15 minutes, the President may continue Public Comment to another time during the meeting.

SPEAKERS: Lance Carnes stated that at the January 18, 2023 Board meeting, he heard BUF quote an inaccurate statistic, namely that 50% of Ficus trees are on the verge of failing. Mr. Carnes stated that he believes the number is closer to 10% based on information from the City's survey of street trees that was conducted in 2017.

(3) COMMISSIONER COMMENTS & QUESTIONS

SPEAKERS: President Swig expressed his sadness that the 49ers lost in the NFC Championship game.

(4) ADOPTION OF MINUTES

Discussion and possible adoption of the January 18, 2023 minutes.

ACTION: Upon motion by Commissioner Trasviña, the Board voted 5-0 to adopt the January 18, 2023 hearing minutes as amended by Commissioner Lemberg. The amendment changed the words "power ball" to "power wall" in the public comment made by Josh Klipp under Item 3.

Appealing the ISSUANCE on November 14, 2022, to 737 Buena Vista LLC, of a Public Works Order (DENIAL of an application to remove two street trees with replacement; Tree # 1 is 45 feet high with a 15-foot spread; the tree is in fair condition and not an immediate threat to safety; Tree # 2 is 45 feet high with a 25-foot spread; the tree is in poor to fair condition but not an urgent or immediate threat to safety).

ORDER NO. 207311. FOR HEARING TODAY.

ACTION: Upon motion by Commissioner Trasviña, the Board voted 5-0 to grant the appeal and issue the order on the condition it be revised as follows: (1) to allow for removal of the two subject trees, (2) to require the determination holder to plant two 48"-box replacement trees, (3) plant three consistent 48"-box trees in the three empty tree wells in front of the property to partially satisfy Department of Public Works Permit No. 781189, (4) pay the current in-lieu fee (\$2,302) for the inability to plant a fourth tree due to PG&E's placement of a utility vault on the sidewalk to fully satisfy Department of Public Works Permit No. 781189; (5) remove and replace the recently vandalized magnolia tree in front of the property to the north, 755 Buena Vista Avenue West, with a consistent 48" box tree; and (6) the determination holder shall maintain and water the replacement trees for three years. This motion was made on the basis that the department erred in not fully taking into account the condition of the trees and the public interest in the underlying project.
