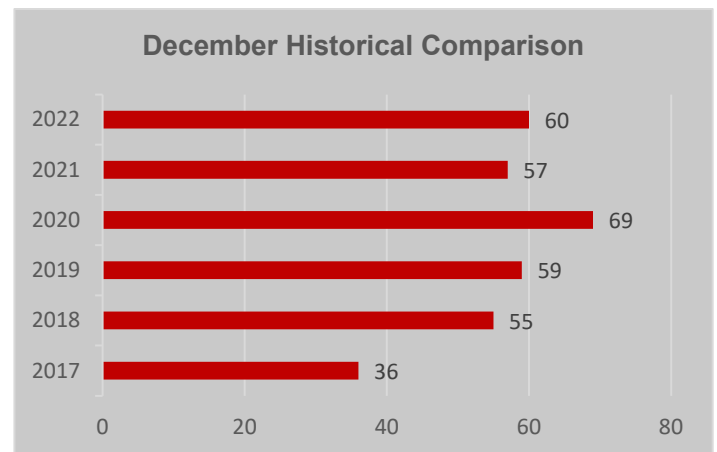

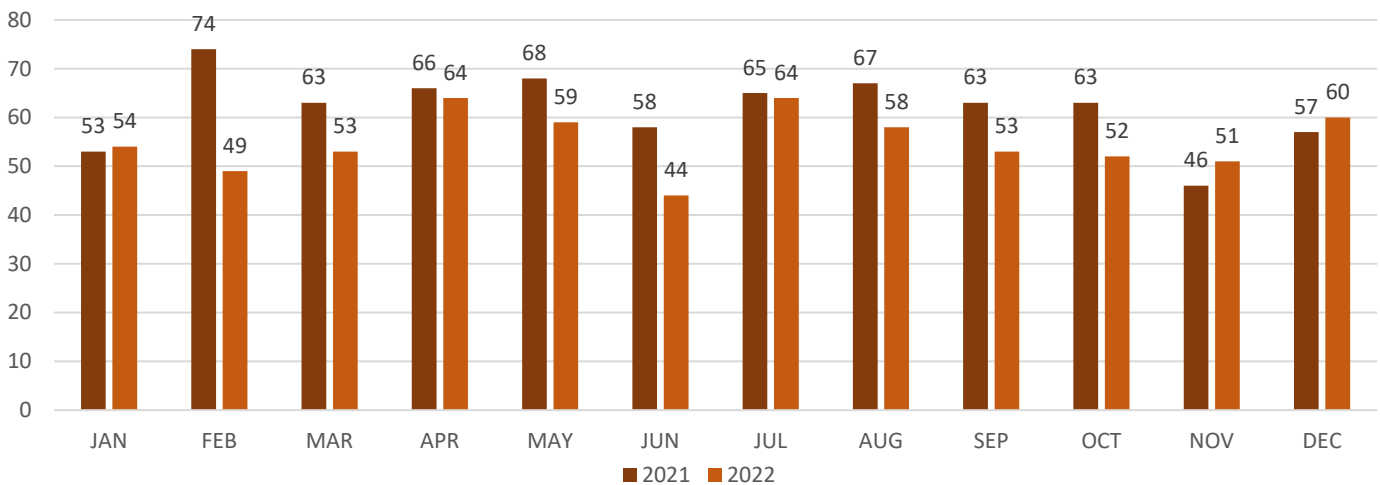
Summary of Complaints Received in December 2022

The Department of Police Accountability received **60** cases in **December 2022**, compared with **57** cases in the same period last year. The **December 2022** case total is **9%** higher than the five-year average and **5%** higher than the previous year.

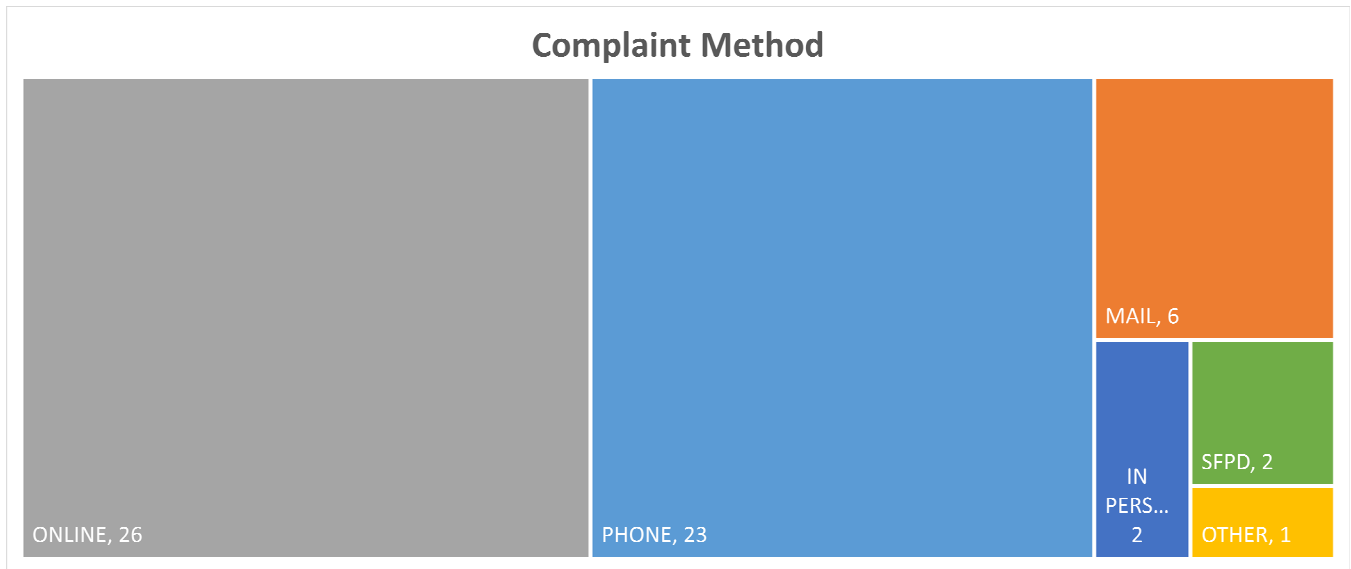
From January through December, the DPA received a total of **704** new cases, compared with the **775** cases filed during the same period in 2021. The December year to date case total represents a **9%** decrease in new complaints over last year.

Most complaints were received over the phone and online.

00052993-22	12/1/2022	The officer did not tell the complainant they were detained before being handcuffed. The officer then took the complainant to the ground.
00052994-22	12/1/2022	The complaint raised matters not rationally within the Department of Police Accountability jurisdiction.
00052995-22	12/1/2022	The complaint raised matters not rationally within the Department of Police Accountability jurisdiction.
00052996-22	12/1/2022	Officers have failed to arrest an individual who violated a restraining order.
00053002-22	12/1/2022	The named officer did not enforce the restraining order. The officer racially profiled the complainant and was unprofessional.
00053020-22	12/5/2022	The complainant stated that an officer failed to wear a distinctive uniform while issuing traffic citations.
00053021-22	12/5/2022	The complainant was accused of shoplifting by a store security guard. An officer sided with security personnel, made inappropriate comments to the complainant, and provided false information to medical personnel about the complainant.
00053024-22	12/5/2022	The officer failed to make an arrest and write an incident report for a traffic collision.
00053023-22	12/5/2022	Merged: Complaint regarding proposed policy allowing the use of deadly force via robots.
00053037-22	12/6/2022	An officer accosted the complainant, and their friend, in an unprovoked encounter that led to the officer damaging the complainant's property.
00053038-22	12/6/2022	The complainant witnessed an officer failing to effect a traffic stop for a vehicle that ran through a stop sign.
00053048-22	12/6/2022	Officers unlawfully arrested and were discourteous to the complainant and their partner while responding to a domestic violence call.
00053057-22	12/8/2022	The complainant stated he was the victim of theft and officers failed to assist him and discriminated against him because of his age and ethnicity.
00053059-22	12/8/2022	The complainant stated that an officer hacked his email and electronics to intimidate and harass him in retaliation for reporting police misconduct.
00053064-22	12/8/2022	The complainant stated that an individual made violent threats against him. He reported the incident and provided evidence of the crime. He stated that the investigating officer later told him there was no probable cause for the alleged crime and refused to transfer the case to the District Attorney's Office.
