#### V. TIDA Staff Updates

Bob Beck, Treasure Island Director, presented an update on development and operation issues.

The CAB will meet back in person at the next meeting.

Jeanette Howard from the Nature Conservancy has joined the TIDA Board.

Since the January storms SFPUC has been cleaning catch basins and Public Works has been filling potholes.

Current Swords to Plowshares residents are moving in to the new affordable housing Maceo May building.

Notice of Completion for certain roadways including Seven Seas.

Next affordable housing site, Parcel E1.2, was approved in MOH loan committee. This site will include current HR360 residents and roughly 100 units of senior housing.

On January 26<sup>th</sup> SFPUC issued a Notice of Proceed to begin work on new Wastewater Treatment Plant project.

Will have update on Autonomous Vehicle Shuttle program at April meeting.

Self-serve library kiosk at Island Cove Market with ribbon cutting on February 18.

Atta Pilram asked about transition housing available for current Gateview residents.

Tim Molinare asked how many resident occupied units are on island and asked for an update on market rate housing.

Jim Hancock asked about the temporary certificate of occupancy.

# VI. Community Planning: Aspirational Vision Statement Overview

Lazara Paz-Gonzalez, Facente Consulting, presented goals and planning of the aspirational vision statement.

The project goal is to develop a shared aspirational vision and mission statement, including associated core values for the island rooted in inclusion, equity, and belonging that supports a cultural foundation for the community and its redevelopment.

CAB members offered thriving, a sense of community, reinvigorating, and a view, as descriptive language for TI.

The draft vision statement was developed by a core planning team, reviewed by a 10-member community workgroup, and will be disseminated as a community survey.

Draft Vision: A thriving SF neighborhood in the middle of the Bay celebrated for its inviting culture, outdoor experiences, and sustainable community.

Draft Mission: To create a welcoming, vibrant, and healthy community that honors the diversity of its existing and future residents, businesses, and visitors.

Draft Core Values: Inclusion and Equity, Sustainability, Opportunity, Connection Complete the survey by February 28<sup>th</sup> at <a href="https://tinyurl.com/TIVisioning">https://tinyurl.com/TIVisioning</a>.

Liz Hirschhorn asked about including honoring the past in the mission statement. Atta Pilram commented on including the TI Museum, TI Yacht Club, and TI Sailing Center in conversations.

# V. Treasure Island and Yerba Buena Island Roadway Projects

Bob Beck provided an update on TI and YBI roadway projects.

Reviewed updates to Maceo May Apartments, Seven Seas Avenue, Trade Winds Avenue, Clipper Cove Avenue, YBI Ramps/Roadway projects, Eastbound I-80 Interchange, Westside Bridges, and Forest Road Detour.

Maceo May Apartments received Temporary Certificate of Occupancy on 1/30 and move-ins will begin this month.

Starting 2/13 Avenue of the Palms will be closed to begin work on Cityside Park and Seven Seas Avenue will open to traffic.

In March Southgate Interchange will be completing and Westside Bridges Project targeted to begin in late May/June.

Forest Road Detour target opening of May/June.
