

Dear Friends

It is my sincere pleasure to support the proposal presented by the SF Parks alliance and the "Friends of Silver Terrace" community group. My extended family has been a part of the Silver Terrace community for approx.. 60yrs. I personally have lived in Silver Terrace for 30 years. Over the years, my family has used the park for all the services it provides, from the playground, baseball and tennis, to currently walking our seniors around the existing walking paths.

The current state of the "non sports" facilities is horrible. The alleyway is in disrepair with poor lighting and broken cement. The playground has not been updated since I have been a resident, with unmaintained sand, rotten wood, broken swings and benches.

The first step in the Park transformation, is to transform the Silver Terrace Park Alleyway by providing a safe thoroughfare to the Silver Terrace athletic fields, playground, and recreation center (fyi.. which currently houses a community daycare), is long overdue. By adding lighting, planters and a painted mural, to clean up and beautify the alleyway, the goal is to create a sustainable, well stewarded community walkway.

The proposed mural is a key element in helping to beautify the Alleyway space, and truly represent the beauty of the neighborhood. Dear Craig and Colleagues,

I am a native San Franciscan who has lived in many neighborhoods of this truly magnificent city. I have lived in the Bayview, more specifically, Silver Terrace, for the past 6 years. We have a multi-generational home and one of our favorite family pastimes is neighborhood walks. My mother and two children are often found getting in their exercise by walking laps (or scootering) around the Silver Terrace athletic fields.

Though, the atmosphere in the Silver Terrace Playground and Ledyard Alley feels lack luster, if not off-putting. The playground's dark brown wooden play structure atop the light brown, tan-colored sand is a wash of blah. This brown-shaded, outdated, and dilapidated "*centerpiece*" is bound by gray walls and gray concrete. To put it plainly, calling it plain is an understatement. It is uninviting for children and their families. Without a space that is inviting to members of the community, it is increasingly difficult to form that sense of community that we all desire. This is exceptionally disappointing for San Francisco, a city that prides itself on our appreciation for art, beauty, and community.

Again, as a native San Franciscan, I know that we can make strides together to improve our environments and get the support we need from our local leaders (hence this letter). I implore you to take the necessary steps to facilitate a mural in the Ledyard Alley. Ledyard Alley presents a unique opportunity to create a strong and intuitive connection between Silver Terrace's athletic greenspace and its residential leisure space. Strategic Plan References for grant:

Strategy 1, Inspire Public Space: Keep today's parks safe, clean, and fun; promote our parks' historic and cultural heritage; and build the great parks of tomorrow. **Objective 1.2:** Strengthen the quality of existing parks and facilities.

Strategy 3, Inspire Investment: Through community engagement, advocacy, and partnerships, cultivate more financial resources to keep San Francisco's parks and programs accessible for all. **Objective 3.2**: Broaden engagement with park users and park patrons.

Background

San Francisco Parks Alliance is a citywide parks nonprofit in San Francisco. They partner with communities and public agencies to create, sustain, and advocate for parks and public spaces that welcome and belong to everyone. Community members in the Silver Terrace neighborhood advocated for improvements to the Ledyard Alleyway, a major thoroughfare from the neighborhood to the Silver Terrace Playground.

The Parks Alliance applied for and were awarded a Community Challenge Grant, a program in the City Administrator's Office, to support improvements in the Ledyard Alleyway. The Parks Alliance and artist Liv Losee-Unger, with ORLUarts, have proposed painting a mural on the

southern wall of the alleyway. The mural project aims to beautify the alleyway and create a more welcoming entrance to Silver Terrace playground and athletic fields.

The Recreation and Parks Department is supportive of the mural project, but does not maintain artwork, so the Parks Alliance will be responsible for repair and maintenance of the work, which will be installed on a temporary permit. The Parks Alliance is committed to a 10-year maintenance plan and understands that if the artwork falls into disrepair they will be responsible for removal or for reimbursing RPD for removal.

Once the Recreation and Park Commission approves the location of the art project on Recreation and Parks property, the Parks Alliance will also seek review and approval by the San Francisco Arts Commission.

Staff Recommendation:

Department staff recommend approval of the placement of a mural on Ledyard Alleyway in Silver Terrace Playground.



Waiver of Proprietary Rights

for Artwork Placed Upon CITY PROPERTY under VARA and CAPA

Artist has designed a work of visual art, described as follows:

("the Work"). In consideration of the City's approval to place the Work on City property, the Artist agrees to waive and does hereby waive voluntarily all rights to attribution and integrity with respect to the Work and any and all claims as may arise under the Visual Artists Rights Act of 1990, 17 U.S.C. §§106A and 113(d) ("VARA"), the California Art Preservation Act (Cal. Civ. Code §§987 and 989)("CAPA"), and/or any other local, state, foreign or international law, as currently drafted or as may be hereafter amended, that conveys the same or similar rights ("Moral Rights Laws"), with respect to the Work, its display, removal from display, exhibition, installation, conservation, storage, study, alteration and any other activities conducted by the City, its officers, employees, agents, contractors, licensees, successors or assigns. If the Work is incorporated into a building such that the Work cannot be removed from the building without physical defacement, mutilation, alternation, distortion, destruction, or other modification (collectively, "Modification") of the Work, Artist waives any and all such claims under any Moral Rights Laws arising out of or against any current or future owners of the site, and its agents, officers and employees, for Modification of the Work.

The City has the absolute right to change, modify, destroy, remove, relocate, move, replace, transport, repair or restore the Work, in whole or in part, in City's sole discretion.

The City has no obligation to pursue claims against third parties for modifications or damage to the Work done without the City's authorization. However, the City may pursue claims against third parties for modifications or damage or to restore the Work if the work has been modified without the City's authorization. If the City pursues such a claim, it shall notify the Artist, and Artist shall cooperate with the City's efforts to prosecute such claims.

If the City modifies the Work without the Artist's consent in a manner that is prejudicial to Artist's reputation, Artist retains the right to disclaim authorship of the Work in accordance with 17 U.S.C. § 106A (a) (2).

Artist bears the sole responsibility for providing the City with any changes to the Artist's Address for **Notice.** Notice of changes must be mailed to the Arts Commission, 401 Van Ness Avenue, Suite 325, San Francisco, CA 94102 AND to the City Agency with jurisdiction over the property.
