2. BUDGET REVIEW [ACTION] (06:23)

Executive Director Manijeh Fata and Chief Financial Officer of OEWD Merrick Pascual updated on FY 23-24 and FY 24-25 proposed budgets and facilitated discussion on budget priorities.

PUBLIC COMMENT: (50:52)

Patrick Ranahan, Location Manager commented:

- With 50 years of Location Management experience, knowing *Ant-man and the Wasp: Quantumania* opening February 14th, he felt there should have been more filming days in San Francisco
- Patrick markets to the accountants and producers about costs to work here and how Patrick can't always compete with New Orleans, Atlanta or even Los Angeles tax incentives
- If there's a way to get producers to see San Francisco now after the pandemic and downtown, it's currently a potential backlot for all kinds of movies and TV, using all the merchants and hotels down there because of the 25% vacancy
- Doesn't know if it pertains to enhancements and the mayor's budget, Patrick wants to find ways for studios to understand that San Francisco is not expensive, can make it worthwhile and not only give the most beautiful views in the world and the most talented artists, but it can make sense to film here

Heather MacLean, Location Manager commented:

- Hard to get people out of the mindset that San Francisco is too expensive for X, Y, Z reasons---there's a fluttering, unanchored fear that they're always going to spend too much
- Been hearing more often people filming at New Orleans, that the weather's terrible--productions had days shut down, not because of COVID, but because of weather costing productions tons of money
- It costs a lot to fly actors out--if San Francisco can assuage for people to build sets here, productions don't need to go somewhere else to have their interiors
- We're getting younger producers that are less experienced that don't think hard about logistics---if San Francisco can start having easy approaches to front end incentives for these producers with office spaces, hotels, stage spaces, parking, Heather thinks it would demystify the costs

Megan Carlson, local film producer, commented:

- Their film *Fairyland* premiered at Sundance this year, a production more than seven years ago that was 100% committed to make it happen in San Francisco despite the challenges
- Thinks there is a massive mystery or inaccuracy in regards to how much it costs to shoot here-- when looking at the occupancy rate of downtown real estate and what producers are challenged with travel, stage space, housing, and office space costs; those should be easy numbers for producers to crunch
- Be happy to share any numbers or any questions for commissioners with what kind of challenges producers face with, how they overcame them, the insight to budgets and incentives from New Zealand, Vancouver, Australia, Louisiana, New York

Thom Hoffman, President of the Theatrical Wardrobe Union commented:

- That not only is it spaces, but it's artist resources---San Francisco doesn't have the costume houses anymore or prop houses anymore ---so those costs are higher for individuals. How do we replenish those resources that are no longer in San Francisco?

Paula Smith Arrigoni, Executive Director of BAVC commented:

- Felt encouraged to hear about the enhancements that may be considered in the budgeting process and recognition of the importance in terms of marketing, audience engagement, bringing folks back to San Francisco hotels, restaurants, and bars
- Important to invest in events like Sundance, San Francisco Film Festival and many other festivals happening now and need the advocacy at the film Commission, at OEWD and across agencies
- BAVC is in the process applying for grants and looks for the film commission's support---recently they applied for an OEWD grant proposal that has been denied and is in the process of appeal ---- it was specifically focused on supporting the economic core
- BAVC would love do more marketing with the positive public relations for San Francisco

6. PRESIDENT'S REPORT (01:29:02)

[Discussion Item]

President Villy Wang officially and welcomed Commissioner Franco Finn.

Villy asked all the Commissioners to share what they're most excited about stepping into from the Film SF 2023 Key Priorities List:

1. Create opportunities for diverse San Franciscans to get their stories told and gain access into the film and media industry
2. Attract productions to shoot here and ensure they have access to a soundstage
3. Partner with SF film and media industry to support the city's economic recovery
4. Strengthen Relationships with Neighborhood & Merchant Associations
5. Grow our brand that amplifies our vision

COMMISSIONER COMMENT: (01:38:11)

Villy Wang will focus on priority 1 and commented:

- As BAYCAT's President, her and the nonprofit will continue create pathways for folks to work in industry (Pixar, Lucasfilm) and production companies (*The Matrix Resurrections*, *The Last Black Man in San Francisco*)
- Raised the question how do we keep these young people engaged and the storytellers? Even if they are born and raised here---many of them want to leave San Francisco. So how do we keep them here and keep them employed?

Matt Stiker will focus on priority 5 and commented:

- Been trying to spend his time and focus over this priority these past few years
- Wants to grow our brand, which is why he expressed the frustration at the limited marketing dollars
- Still thinks there are methods that we can achieve the priority without a gigantic budget by becoming creative and thinking a little bit differently

Carolyn Tyler will focus on priority 1, 3, 4 and commented:

- When appointed to the film Commission, Carolyn got a lot of feedback/comments from the African-American community who are wanting to learn who they'd need to network and make that happen
- When film productions visit town and people only see the limited parking---Carolyn wants the people to know what these productions bring other than money to the city, but the programs and missions that support along with it

Tony Delorio will focus on priority 3 and commented:

- As Principle Officer of Teamsters local 665, his main number one skill is to negotiate and would love to help wherever he can, especially with political connections
- Thinks being more involved in person and on the scene will grow the value together to the film commission and bringing productions back into the city

Jim Beaumonte will focus on priority 2 and commented:

- Felt last year we had a lot of legwork done with the film and television tax incentive SB 485 until it was pulled off the Senate floor and allocated to Governor's budget--- wants to continue working on this
- Feels we can't really get a soundstage until we have a production company committed to filming here and we can't get a production company committed to filming here until we have a better tax incentive

Franco Finn will focus on priority 3, 5 and commented:

- He's a brand guy and will amplify and extend the vision out there as an ambassador
- No matter where Franco travels, he's thinking ahead with networking, breaking down doors and in talks with folks and hyping the local sports teams, the city and now the film commission
- Understands what small businesses had to go through with red tape they thought they had--- wants to ensure productions that it's easy for productions to shoot here

Jack Song will focus on priority 2, 3 and commented:

- Thinks tactically our next big deliverable for the film commission is showcasing the Annual Report
- Believes with the support of the mayor, we could build a big event around the Annual Report and share the success why bringing some production make sense here in San Francisco

- Looks forward to having in-person get togethers where they can invite the community, invite the filmmakers, invite the diversity of the Bay Area
