While his primary emphasis as an artist started off as and remains in photography, David also dabbles in oil paint, ink, and pastels. David attended Stanford University and originally hails from Texas.

My work is today is typically shot on a Sony a6000. I have shot in APS-C, full-frame, and medium formats, but I frequently shoot in APS-C for street and cityscapes. I primarily use Lightroom, Capture One, Photoshop, and Luminar for editing.

My formal education was at Stanford University and the University of North Texas; however, the passion for my craft has brewed since my early years.
