Presentation by Human Rights Commission on Stand Together SF Initiative, RFP 78 Asian Violence Prevention and Security Progress Report, and Identification of Heritage Month Events for Commissioner's Calendars

Presentation: John McKnight, SR. Community Engagement Manager, San Francisco Human Rights Commission

Public Comment

Secretary McKnight outlined the initial premise for the Stand Together SF Initiative, and it's ongoing need to bridge communities, address underlying causes of anti-Asian violence, and promote the true narratives of solidarity between communities in San Francisco. He presented on the events supported by the Human Rights Commission including the Asian Black Cookoff, the 5K Our Heritage Fun (educational) run, and the Changing the Narratives Art Campaign. Additionally, he addressed the continuing need for the work to continue citing articles showing the rising threat from white supremacists in the US. Lastly, he presented potential changes to the initiatives format with the combination with the Campaign for Solidarity movement and the transition to in person meetings on a regular basis.

COMMISSIONER COMMENT

Chair Clopton: Asked that the Stand Together SF website and calendar be shared with the Commissioners. She asked the Commissioners to share the website through their Social media posts. She noted the citation during the presentation noting threat the number on e threat nationally to peace is the rise of white nationalism/" supremacists."

Vice Chair Shaw: Asked about collaboration with other community partners. Secretary McKnight stated the Stand Together SF is a unified effort between many community partners and he highlighted Both Sides of the Conversation, the API Heritage Foundation, the Chinese Cultural Center, Booker T. Washington Center, Asians are Strong, We Are One, and many others that join monthly and at the events sponsored and attended by the Human Rights Commission.

Commissioner Pellegrini: Asked for date of the Asian Latino Cookout. The date is August 5th 2023 and will be held in the Mission at 24th and Harrison.

Commissioner Sweet: Asked when the Commission would add in-community meetings. The Chair noted the August 10 meeting was planned to be in community. More will be scheduled, far in advance, for the 2024 calendar.

Representative from the San Francisco Department on the Status of Women addresses program designed to address Commercial Sexual Exploitation of Children

(CSEC) in San Francisco

Presentation: Nazneen Rydhan-Foster, Sr. Program Manager, SF SOL Collaborative & Anti-Trafficking, San Francisco Department on the Status of Women

Public Comment

Nazneen brought before the Commission the work being done by the Department On the Status of Women (DOSW) to address Commercial Exploitation of Children. It is National Foster Care month she noted and the Department's work is to create a continuum of placements and services for youth

experiencing commercial sexual exploitation that is called SF Bay Area Soul, which stands for Safety, Opportunity and Lifelong relationships. She noted that California passed legislation specifically under SB 855 and 2014, which makes the commercial sexual exploitation of a minor a mandatory child abuse report and clarify that a child who is sexually trafficked and whose parent or guardian has failed or is unable to protect them, can be served through child welfare as a victim of abuse and neglect. Nazneen outlined their programs designed to support the at-risk youth and the partners her Department works with including the HYPE Center.

Vice Chair Shaw: Thanked Nazneen for her Department's work and asked if the HYPE Center had a hotline. Nazneen stated there was a hotline for FCS, and the Hype Center is drop-in. The drop in approach is to make access as low barrier as possible.
