

In the four fiscal years prior to the COVID-19 pandemic, case levels had been increasing by 8% to 12% each year. The FY 2022-23 case level is more closely following the pre-pandemic trend and represents a 7% increase in cases since FY 2021-22.

Over 50% of cases involve supporting people who are considering starting a business or in the very initial stage (0-1 year)
