Ariana (No last name): Ariana reported on their experience navigating homelessness, shelters, single resident occupancy housing, and living out of their car in San Francisco. They reported being sexually harassed to the shelter monitoring committee and said that the city and county government services and policies have failed to help them find stable housing.

#### 4. 9:26 REVIEW OF TIMELINE FOR SUBMITTING THE SAN FRANCISCO AFRICAN AMERICAN REPARATIONS ADVISORY COMMITTEE REPORT (Discussion Item)

San Francisco Human Rights Commission staff and members of the African American Reparations Advisory committee will present the timeline for submitting input on final Reparations report recommendations, when the report will be submitted to the San Francisco Board of Supervisors, and when the San Francisco Board of Supervisors Committee of the Whole meeting will be scheduled. **Presentation: Brittni Chicuata, Director**, Economic Rights Division, San Francisco Human Rights Commission

Juell Stewart, Manager, Economic Rights Division, San Francisco Human Rights Commission Public Comment

Brittni Chicuata, Director of the Economic Rights Division of the San Francisco Human Rights Commission manages the team supporting the African American Reparations Advisory Committee beginning in June 2021 and ending in June 2023. The 15 member advisory committee was tasked with developing a San Francisco Reparations program addressing the legacy of institutional city sanction harm inflicted upon Black communities in San Francisco and determine the scope of and eligibility for a city-wide Reparations program in order to serve qualifying Black residents who have been wronged and/or who continue to suffer from past harms. Name ongoing discriminatory local policies, address Anti-Black prejudice and inequities within government and private institutions, the public education system, criminal incarceration system, housing, workforce development, economic opportunities, transit access, access to health care, and food security. The report detailing final recommendations is due by June 30, 2023. Important dates in June:

June 2, 2023: Last day the committee will accept community and external recommendations.

June 5, 2023, 5:30pm: Special Meeting at 25 Van Ness Avenue, Room 610 (recorded in error during the meeting as City Hall, room 400).

June 12, 2023, 5:30pm: Regular Advisory Committee meeting to vote on final recommendations for the report.

June 30, 2023: Submit final report to the Human Rights Commission, the Board of Supervisors and the Mayor's office.

#### PUBLIC COMMENT

Ace Washington, Linda Parker Pennington, Letta, Pete Terrance, CA Horton provided public comment on this item.

#### **COMMISSIONER COMMENT**

**Commissioner Pellegrini:** Asked when the report would be heard at the Board of Supervisors in a Committee of the Whole. Answer: September 19, 2023.

**Chair Clopton**: Directed staff to schedule either the July or August Commission meeting in community to review the African American Reparations Advisory Committee report recommendations, at either the George Davis Senior Center, Bay View Opera House, or new Southeast Community center.

Directed staff to draft a memorandum presenting the following recommendations to the committee, Link to Memorandum.

Request of the Public Defender's office to present a comparative data analysis evaluating pay parity and hiring/caseload equity between different Legal Departments representing the City and County of San Francisco, specifically the Public Defenders, District Attorney, and City Attorney's offices. Ask for office of the Public Defender, Mano Raju, to prepare the comparison and include the Civil Service Commission

Funding to Establish a Black LGBTQI+ Center in the Castro <u>– link to recommendation submitted</u> to the Mayor's Office in 2022-2023.

#### Edit the description of the process within the final report to reflect that San Francisco

Reparations legislation is grounded in community activism. In response to the COVID pandemic, the MegaBlack SF group was formed in March 2020. The group conducted listening sessions involving hundreds of participants who identified priorities of San Francisco's Black community. One of those includes establishing a Reparations Advisory Committee to review local government policies that harmed the Black San Francisco community in the past and continue to cause harm to the Black community.

**Vice Chair Shaw:** Asked about collaboration with other community partners. Secretary McKnight stated the Stand Together SF is a unified effort between many community partners and he highlighted Both Sides of the Conversation, the API Heritage Foundation, the Chinese Cultural Center, Booker T. Washington Center, Asians are Strong, We Are One, and many others that join monthly and at the events sponsored and attended by the Human Rights Commission.

**Commissioner Pellegrini**: Asked for date of the Asian Latino Cookout. The date is August 5<sup>th</sup> 2023 and will be held in the Mission at 24<sup>th</sup> and Harrison.

**Commissioner Sweet**: Asked when the Commission would add in-community meetings. The Chair noted the August 10 meeting was planned to be in community. More will be scheduled, far in advance, for the 2024 calendar.

Director Davis and San Francisco Public Librarian Christy Estrovitz curated and distributed 1000 summer literacy kits and lessons to community based organizations hosting youth summer programming.
